OBJECTIVES

1. To relieve hardship, need or distress, relieve sickness and advance education among internally displaced Kachin people.
2. To advance public education in the difficulties experienced by refugees as well as deprived and needy Kachin people.
3. To promote fundamental human right education base on the United Nation's Universal Declaration of Human Rights and documentation of human rights abuses.

ACTIVITIES

1. To provide short term relief aid to Kachin internally displaced people (IDPs) living along the Kachin State and China border, and those who displaced with Kachin State.
2. To work closely with Kachin relief workers in providing such aid.
3. To provide financial grants to buy basic medical equipment for IDP clinics and hospitals.
4. To provide emergency medical referral and hospitalization cost for the internal displaced people (IDPs) in the Chinese hospitals.
5. To provide grants for construction of schools and study materials.
6. To fund short term medical and education projects
7. To support legal cost for victims of civil, human rights violations and support human rights awareness program.
8. To provide the information resources for issues relating to relief assistance and human rights abuses.
9. To work closely with the organizations which we shared a common goal for our mutual benefits.
10. To evaluate annual works and reassess the best working strategy for future project.

AREA OF BENEFIT

The border of Burma and China, and the inside Kachin State in Northern Burma.

GRANT MAKING POLICY

We mainly focused on four main categories when responding accordance with the objects of charity.

1. Emergency relief responses
2. Health for the IDP
3. Education for children
4. Advocacy, activities & awareness to promote of human rights.

2014-2015 TRUSTEE ACTIVITIES REPORT

The charity continue to engage its activities in line with the objectives of the charity. The trustees held AGM and made a yearly plan for its charity work according to the budget and grant funding for the plight of the local people.

During 2014-2015, the recipients of our funds can be classified into three main categories:

1. The internally displaced people (IDPs) in the Kachin State and China border.
2. The schools in very poor and least developed area (Sumpra Bum, N-Gum La and Putao etc.) of North-Eastern Kachin State, the territories within non-government controlled areas and conflict affected areas.
3. The organizations working inside Kachin State to promote the human rights education and capacity building for local civil societies.

EMERGENCY RELIEF RESPONSES

A battle took place between KIA's 7th Battalion troops and Burmese Army's 381st, 385th, and 389th Light Infantry Regiments under Mogaung-based 3rd Military Operations Command (MOC-3) near Sumpyi Yang village on July 22 at 11 am. Burmese Army's Light Infantry Battalions (29th, 38th, 58th, 81st, 137th, 138th, 266th) and Light

Infantry Regiments (381st, 385th, 389th) from Putao, Myitkyina, Mogaung and Chin State are currently deployed along Putao-Myitkyina-Sumpra Bum road since Burmese Army launched an attack on KIA positions on June 24-25. More than 1,402 villagers including 268 school children and 24 teachers from Mali Yang, Lawt Mai Yang, Jara Yang, Nhtan Zup, Hpung Ing Yang, Sama Bum, Nhtan Zup, and Zup Ra Yang village had been displaced by heavy fighting in Mali Yang area. Kachin Baptist Convention (KBC) Relief Mission Department requested Kachin State government and Northern Regional Command to allow them to help IDPs but denied access to the areas by boats which was the only option to reach to IDPs.

The KRF got in touch with the local NGOs, churches and people from the conflict affected areas to find out an alternative method to deliver emergency aids. The KRF responded with Kyat 3,740,000 through the Kachin Baptist Convention (KBC) for emergency relief donation to assist those IDPs who were in dire need of basic needs.

GRANT FOR HEALTHCARE

The KRF has granted a partial donation to buy a portable x-ray machine to use in surgical treatment caused by landmines. Following that the KRF also have donated the oxygen concentrator machine and a microscope for laboratory use to the Medical Department in Mai Ja Yang.

KRF had arranged to deliver a blood transfusion machine, a microscope and blood dryer machine at N-Gum La, remote Northern Kachin State. Trustees were looking to improve healthcare facilities and diagnosis facility for N-Gum La, since it was very difficult for the general public to access for healthcare to Myitkyina (Capital of Kachin State) where more than (40) miles away and extremely difficult road access during the raining season.

EDUCATIONAL GRANT

KRF had sponsored nine school teachers to attend the Teacher Training College (TTC) at the Maija Yang. KRF had received a report from the concern authority of the Department of Education of Northern Division dated 13 June 2015 that nine teachers enrolled to study at Mai Ja Yang Teacher Training College have successfully completed their courses. Five teachers had gone back to their respective home villages and continue teaching duty where four teachers had continued to do further study as following.

- (1). Mr. Laxai Dau Lam - Myaw Maw Pa Middle School
- (2) . Malut Seng Ra - Htingnan Middle School
- (3) . Manang Nang San - Htingnan Middle School
- (4) . Bahkyam Htingnan Li - Pung Swi Yang Middle School

- (5) . Hkin Jawng Kaw Awng - Ja Htu Yang Middle School
- (6) . Lasi Lu Lu Awng- -further study Diploma in Education (Dip.Ed)
- (7) . Pauhkang Bawk Nu- further study Diploma in Education (Dip.Ed)
- (8) . Lahpa Hkawng Gyung - further study Diploma in Education (Dip.Ed)
- (9) . Nawbau Brang Shawng- further study at Mai Ja Yang Institute of Education

Following the AGM meeting on 6th July 2014, the KRF have been funding to build N-Gum La High School library. The resources centre will be the first kind of resources centre for the students and teachers in the region. The KRF will collect and provide the library reference books, study materials and monthly news and journal subscription. We are currently donating the Kachin Times Journal as a gift subscription for N-Gum La as well as Danai and the Kachin Sub-State in Northern Shan State. We are hoping to provide the internet connection to the library to access to online library catalogue across the globe in near the future. The KRF will also sponsor a trainee librarian to manage the library.

PHYSICAL EDUCATION PROJECT GRANT

The physical education (sport activities) project was started in 2014 and became a very successful project since it was initiated. The trustees decided to continue to support the sport activities in Mai Ja Yang and then extended to Laiza areas to sponsor Karate instructors for free training for children from the IDP camps. KRF had received a good feedback from the public and the IDP children, where the sport activities project was the only project for the local and IDP children where they could participate outside of the classroom activity. We are hoping that from this project we will be able to produce talented world class athletes, to motivate the young people and to divert the attention from drug issues in the border. The success of this project should be credited to the BRIDGE, a local NGO and the commitments of its coordinators and instructors in Mai Ja Yang and Laiza.

GRANT FOR HUMAN RIGHTS PROMOTING ACTIVITIES

KRF supported victims of arbitrary detention, human rights documentation, and assisting with legal and travel expense for the local volunteer human right lawyers from Kachin State. KRF trustees were continue working with local and international human right organisations and campaign groups to release Kachin political prisoners. Although, Mr La Ring was released on 7th October 2014, Mr. Brang Yung and Mr. Lahpai Gam were still detained and denied to release.

KRF coordinated with local church and sponsored the public meeting on 4th November 2014 to raise awareness of unlawful detention of Mr Brang Yung and Mr. Lahpai Gam cases at the Shwezet IDP camp in outskirts of Myitkyina. It was noted that the event was

also effectively putting pressure to Government of Burma before the 25th ASEAN 2014 Summit in Nay Pyi Taw.

ADVOCACY AND NETWORKING

KRF trustee member Mr. Hkanhpa Sadan, attended the Pray for Burma Event, organised by the Christian Solidarity Worldwide and gave speech on the situation of Kachin IDPs and participated in panel discussion in March 2015. Hkanhpa Sadan also coordinated and facilitated between the Royal Commonwealth Ex-service League RCEL and the Kachin Veteran Committee to distribute warfare grants to Kachin Second World War veterans.

Mr. Andrew Seng Ring Kumhpa has contributed fundraising through “Tough Mudder” competition on 2nd of May 2014. KRF fundraising activity was also held on September 2014.

Kai Htang Lashi, trustee attended numbers of Burma state holder meeting at the Foreign & Commonwealth Office (FCO) and spoke numbers of event and seminars across the U.K.

ADMINISTRATIVE EXPENSES

The KRF has no paid officials. All public relations, secretarial and financial accounting work is done by volunteers.

Hkun Htoi Layang, secretary of the charity, maintains the KRF’s website/facebook on a voluntary basis.

- And prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue operation.


Independent Examiner

We have examined the financial statements of the Kachin Relief Fund, also known as KRF, for the year ended 31st August 2015 which comprise the Statement of Financial Activities, the Balance Sheet and the related notes 1 to 10. 

1. Accounting Policies

a) Basis of Accounts

The financial statements have been prepared on the historic cost basis in accordance with relevant standards and provisions of the Statement of Recommended Practice (SORP2005) issued by the Charity Commission. The principal accounting policies adopted in the preparation of the financial statements are as follows:

b) Income

Incomes are credited to the statements of financial activities as follows:

c) Value Added Tax

The Charity is not registered for VAT and accordingly, where applicable, expenditure is disclosed inclusive of VAT.

d) Expenditure

Direct charitable expenditure comprises all expenditure relating to the objects of the charity including the costs of supporting the charity's activities.

Other expenditure comprises fund raising and publicity costs and expenditure on management and administration of the charity.

Where expenditure cannot be directly attributed to a single activity, it is allocated between activities on a basis consistent with the use of resources.

e) Unrestricted Funds

The Charity's unrestricted funds consist of general reserves which the charity may use for its purpose at its discretion.

f) Restricted Funds

Restricted Funds are those where the donor has imposed restrictions on the use of the fund which are legally binding. Income arising on restricted funds and expenditure incurred in respect of these funds are reflected through the statement of financial activities in the appropriate column with any surpluses or deficits being appropriated to/from restricted funds.
