TRUSTEES REPORT FOR THE YEAR ENDED 30 APRIL 2019

Introduction

The trustees present their report and the financial statements for the year ended 30 April 2019.

The trustees have prepared the annual report and financial statements in accordance with the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in January 2015.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governance

Gateway into the Community is a registered charity. Its Constitution was adopted on 10 April 2002 and amended by special resolution on 30 July 2014. The principal activity of the charity is to support, promote and encourage the provision of facilities for recreation, learning and other leisure time opportunities, for people living in West Northumberland who have a learning disability, with the object of improving their quality of life.

Trustees

The Management Committee comprises a minimum of four and a maximum of twelve Trustees, who are charity trustees for the purpose of charity law.

Membership of the charity is open to all people with a learning disability who are resident or receiving education or care or otherwise relevantly active in West Northumberland and at least 50% of the Trustees are members of the charity. Trustees are elected by the members at the Annual General Meeting and, if willing to stand, offer themselves for reelection each year. The officers of the charity for the ensuing year are nominated and elected (by ballot if necessary) at every AGM.

Trustee Induction and Training

A Trustee Information Pack is available to potential and new Trustees. Potential Trustees are invited to attend a Trustee meeting to find out more about the workings of the Management Committee and the governance of the charity, after which they may feel better informed to make the decision to become a Trustee.

New Trustees are introduced to the charity, their legal obligations under charity law, the content of the governing document, the Trustees and the decision-making process, the business plan and financial performance of the charity during an induction period soon after appointment. Trustees are also encouraged to attend appropriate training events that will support effective conduct in their role.

Risk Management

Where appropriate, policies and procedures or systems have been put in place to mitigate the risks the charity might face. Significant external risks to funding, and the nature of funding across the Community and Voluntary Sector, have led to the development of a long term strategic plan including the identification of priority activities in relation to income generation.

Policies and procedures exist to ensure compliance with health and safety of all staff, volunteers and beneficiaries of the charity. This includes the provision of adequate insurance cover and risk assessment of all charitable activities. These policies and procedures are reviewed annually or more frequently, on change of circumstances, to ensure that they continue to meet the needs of the charity.

OBJECTIVES AND ACTIVITIES

The principal activity of the charity is to support, promote and encourage the provision of facilities for recreation, learning and other leisure time opportunities, for people living in West Northumberland who have a learning disability, with the object of improving their quality of life.

Gateway into the Community supports people who have learning disabilities, and live in West Northumberland, to take part in a broad programme of leisure and learning opportunities.

When planning our activities for the year, we have had regard to the Charity Commission's guidance on public benefit. We work to ensure that the inclusion of people who have learning disabilities is enjoyable and beneficial to everyone. We support integrated activities whenever possible.

Achievement and performance

This has been another busy and exciting year for Gateway into the Community, beginning in May 2018 with our 20th Anniversary celebrations.

The charity has continued to grow and develop to meet the needs of people with learning disabilities in West Northumberland. Our expansion has been organic because we have developed our services around real need, which means that we have been able to establish a genuine community for people with learning disabilities.

Most of our services are now run from the Den at 3 St Mary's Wynd, Hexham NE46 1LW, where the friendly welcoming atmosphere allows everyone to reach their potential. We continue to hire community venues for activities out of Hexham and when we need a larger room. We have continued to update and improve our facilities and in March 2019, after a long fundraising campaign, we completed the installation of a training kitchen to improve members' life skills and upgraded the bathrooms to include showers.

Groups – Our 14 different groups, 2 youth, 3 adult social, 2 older persons, 3 sporting, computer club, creative arts, healthy living and the 'All Stars' performance group have continued to thrive and expand, with an average attendance of about 15 members and we have started a small gardening group. We now have more than 200 members and work with 110 people on a weekly basis, some of whom attend multiple groups. We support people with a wide range of disability. Some members receive social care funding and benefit from our Day Service or Individual Support Service. Over 60% of our members, however, receive little or no social care funding. This can lead to isolation and a decline in physical and mental health and well-being. We provide a lifeline for these individuals who have little or no support elsewhere.

From May 2018 the **Day Service** has been available five days a week and it has now expanded into an extra room in the Den, for 'quiet time' activities. Some members attend every day, others on only one day a week and everything in between, according to need. We welcomed some new Day Service users in summer 2018, as they left school, and by April 2019, 12 young people were receiving a service. We have built up a waiting list and, where appropriate, some members have been directed towards our **Individual Support Service**. That these bespoke social care funded services are so popular, shows the benefits users derive and the high esteem in which our work is held by social work and health professionals. Staff have received training in First Aid, Safeguarding and Positive Behaviour Support.

Activities — Our discos have been regular, keenly anticipated and well attended events, from the 20th Birthday party in May, through Summer, Halloween and Christmas discos to Valentine's Day. One of our members has developed into a brilliant DJ! We held an Open Afternoon in July 2018, to showcase the Den, following which the mayor of Hexham contributed some of his personal budget to buy us giant bean bags. The 'All Stars' put on a wonderful show for the birthday celebrations in May 2018 and a circus themed July performance 'The Greatest Showman', was followed by the memorable 'New Shoes for Ebenezer' featuring Scrooge at Christmas. In November 2018, five Day Service members received Tynedale Youth Forum awards for reasons ranging from kindness and consideration towards others to enthusiasm and happy demeanour. We were also invited to deliver the Christmas message at the Community Carol Service in Hexham Abbey, nerveracking for some of our shyer members, but very well received by members of the public.

Sports - In June 2018, we hosted a very successful disability cricket festival at Hexham Leazes Cricket Club. Through working with Northumberland Cricket Board we have an extremely successful Sports Academy and have developed a positive partnership with Queen Elizabeth High School. We provide the opportunity for 6th Form students to gain experience and develop their sports leader skills by planning and delivering activities at our weekly sports group. This valuable opportunity enhances the Sports Leader programme at QEHS. We continue our partnership with Newcastle United Foundation and have one of the most successful disability football projects in the Newcastle and Northumberland area. In October 2018, our footballers were offered a tour of St James' Park and free tickets to a Newcastle United home game, which they greatly enjoyed. Our own football team, the Gateway Gladiators, competed in the Newcastle Development League and we also made full use of local facilities such as Wentworth Leisure Centre, Hexham Squash Club, Tynedale Cricket Club, The Torch Centre and Sele Park. We continue to value our links with Elvaston Bowling Club who are keen to offer some more sessions.

Outings – Members of our two older persons' groups have enjoyed Christmas meals out and celebrated birthdays and special occasions together. The Prudhoe group has ventured as far as Blyth beach. These outings have reduced isolation and loneliness and are particularly important for those members who have no family living locally. The Day Service has benefited from many trips out, including bowling, theatre and cinema visits, a pub lunch, Talkin Tarn Country Park and Haltwhistle open air swimming pool.

In February 2019, we organised a Friends Weekend at Ninebanks Youth Hostel for 10 of our more vulnerable members who were not accessing external respite services for a variety of reasons. The members, some of whom had high anxiety levels, were able to relax in a nurturing environment, with staff they knew well and enjoy a range of activities from cooking to walks, despite the inclement weather. They improved their social skills and gained in

confidence, while parents and carers also benefited from time to spend with other family members, secure in the knowledge that their loved one was safe, happy and becoming more independent.

Our vision is that people with learning disabilities are and feel, full and valued members of society. We aim to put our members at the heart of their community, visible and accepted for who they are. Our belief is that everyone should know that it is their right to have dreams and aspirations. This year we have significantly raised the profile of the charity, not least by becoming known for our decorative window displays. Members were justifiably proud to win £50 for the best Halloween window display in Hexham.

Organisation development — At the beginning of January 2019, our Coordinator Fiona Macdonald handed over day-to-day responsibility for the charity to the new Chief Executive Julia Ferguson. This was the result of careful succession planning over a five year period, with Julia, previously the Life Chances manager, equipped for her new role both by internal coaching from Fiona and by external training. The Day Service manager and Individual Support development manager, together with the Chief Executive, comprise the Senior Management Team. All three have received training in financial planning, monitoring and reporting and the Chief Executive has been funded by the Garfield Weston Foundation to become a member of the Clore Social Leadership Experienced Leader programme.

Plans for Future Periods

In June to August 2019, some of our younger members took part in separate male and female workshops exploring positive relationships and sexual health and wellbeing in a non-threatening, safe environment. The course was externally facilitated by 'The Josephine and Jack Project', based in Newcastle, and funded through a special one-off grant from the Community Foundation Tyne & Wear and Northumberland, offered to its best performing grantees. We have formed a strong partnership with Hexham in Bloom who funded planters, compost and plants for our members to look after and organised several community litter picking sessions in which members participated.

We will also run, in addition to our two weekly older persons' groups, a monthly programme of sessions in a bigger venue delivering a broader range of activities such as fitness, sport, dancing, health and well-being, IT and online safety. We wish to engage with more older people and other organisations who support older people with learning disabilities. For this work, we were invited to re-apply to the Kellett Fund at the Community Foundation, who wrote "We are approaching recent Kellett recipients who were able to demonstrate the success of their projects, rather than making an open call for applications."

With great dedication, Melanie Hall our fundraiser has finally raised the full amount of funding needed to create our sensory room. This will offer members of differing abilities and sensory needs an opportunity to interact with the world around them in a relaxing, calming, safe, non-threatening environment which ultimately may have considerable impact on the quality of their lives and the lives of others around them.

Fiona Macdonald retired at the end of May 2019. As the new Chief Executive has written, "Fiona has been the absolute inspiration for Gateway. Her vision and ethos has made Gateway what it is today. It is incredible to come to work every day and see first-hand the difference we make to people's lives. Fiona has been the driving force in ensuring that all our members have a voice and are listened to. She has created a culture that promotes

acceptance and equality and has developed a community where people with learning disabilities feel they belong."

We continue to develop what we do and grow the organisation, in order to fulfil the unmet needs of people with learning disabilities in West Northumberland.

FINANCIAL REVIEW

The charity remains grateful for the help and support given by government agencies, charitable trusts and other sources of fundraising and donations.

The charity generates a significant proportion of its income from individual support and Day Service fees. Total income, including these fees, grants, fundraising and donations, in the year ended 30 April 2019 was £472,039 (2018: £360,145). The increase in income was generated largely as a result of an increase in individual support fees and the creation of the Day Service in September 2017, making the year ended 30 April 2019 the first full Day Service year. Earned income from these two sources represented 73.9% of total income (2018: 64.2%)

Total costs were £422,570 (2018: £313,017), and as a result the charity generated a surplus for the year of £49,469 (2018: £47,128 surplus). Payroll costs, which represent the significant part of the charity's costs, increased over the year to £279,863 (2018: £210,063) equalling 66.2% of total expenditure (2018: 67.1%). Costs also include £34,155 relating to the training kitchen and bathroom improvements.

Total funds at 30 April 2019 were £183,624, of which £136,797 was held in cash. Of the total funds at 30 April 2019, £155,014 related to unrestricted funds (2018: £84,686). The trustees decided to transfer on a monthly basis, from May 2018, 5% of individual support and Day Service income from the unrestricted general fund to a designated maintenance fund to support ongoing maintenance of the charity's leasehold premises. At 30 April 2019, this designated fund stood at £11,106.

The charity also recognises the valuable contribution made by individuals and supporters under our regular giving schemes.

Grant Making Policy

The Charity does not make grants.

Investment Policy

The charity holds no investments, other than reserve funds held in interest bearing bank deposit accounts, and as such has no formal investment policy.

Reserves Policy

The Trustees aim to have a reserve of sufficient unrestricted funds to cover three months' operating costs, plus exit charges. This figure has been identified following consideration of the main financial risks to the charity. At 30 April 2019 free unrestricted reserves held amounted to approximately 4.1 months' operating costs, and therefore this policy was met.

The strategy is to continue to build reserves through economies of scale wherever possible, suitable cost control, and seeking additional funding to meet essential expenses which underpin the provision of service to members. The Trustees regularly review the level of unrestricted reserves at Management Committee meetings with the aim of ensuring that a temporary shortfall in grant funding does not have an immediate impact on services for members.

Statement of Trustees' Responsibilities

Charity law requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of the affairs of the charity as at the balance sheet date and of its incoming resources and application of resources, including income and expenditure, for the financial year; in preparing those financial statements, the Trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is not appropriate to assume that the charity will continue on that basis.

The Trustees are responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011. The Trustees are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection or fraud and other irregularities.

Responsibilities of the Trustees

Trustees who served during the year and up to the date of this report are set out under Legal and Administrative Information. In accordance with charity law, as the charity's Trustees, we certify that:

- so far as we are aware, there is no relevant information of which the charity's examiner is unaware; and
- as Trustees we have taken all the steps that we ought to have taken in order to make ourselves aware of any relevant accounts information and to establish that the charity's examiner is are aware of that information.

INDEPENDENT EXAMINERS REPORT ON THE UNAUDITED FINANCIAL STATEMENTS TO THE TRUSTEES OF GATEWAY INTO THE COMMUNITY.

I report on the accounts of Gateway into the Community for the year ended 30 April 2019, which are set out on pages 8 to 17.

Respective responsibilities of trustees and examiner

The trustees of Gateway into the Community are responsible for the preparation of the accounts. NOTES TO THE FINANCIAL STATEMENTS FOR THE PERIOD ENDED 30 April 2019

1 ACCOUNTING POLICIES

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

Basis of accounting

The financial statements are prepared under the historical cost convention and in accordance with the provisions of Financial Reporting Standard 102, Section 1a Small Entities, and the Charity Statement of Recommended Practice, (Charities SORP (FRS 102) 2015), as well as the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

b. Fund accounting

Unrestricted funds are incoming resources received or generated for charitable purposes. They are available for use at the discretion of the trustees in the furtherance of the general objectives of the charity. Unrestricted funds comprise the unrestricted general fund and the designated maintenance fund to support ongoing maintenance of the charity's leasehold premises.

Restricted funds can only be applied for a particular purpose as defined within their objects.

c. Income

All income is included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Income which is received by way of grants, donations and gifts to the charity is included in full in the Statement of Financial Activities upon receipt. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Bank interest and other investment income is included when receivable.
- Income from charitable activities is derived from contracts and service agreements, and is accounted for as the charity earns the right to consideration by its performance.

Gift Aid receivable is included in income when there is a valid declaration from the donor.

Volunteers – the value of any volunteer help received is not included in the accounts, but is described and acknowledged in the Trustee's report.

NOTES TO THE FINANCIAL STATEMENTS FOR THE PERIOD ENDED 30 April 2019

d. Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes unrecoverable VAT.

- Costs of generating funds comprise the costs associated with attracting voluntary income.
- Operation and development of the charity includes all costs incurred by the charity in the delivery of its activities and services.
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include accountancy fees.

e. Fixed assets

Fixed assets are stated at cost less accumulated depreciation. All items with a useful life of more than one year, and a cost of at least £500 are capitalised. Depreciation is provided at rates calculated to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows:

Plant and Equipment

33% straight line

Vehicles

33% straight line

Leasehold Improvements

over the term of the lease

f. Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

g. Trade debtors

Trade debtors are amounts due from funders for merchandise sold or services performed in the ordinary course of business. Trade debtors are recognised initially at the transaction price. They are subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for the impairment of trade debtors is established when there is objective evidence that the company will not be able to collect all amounts due according to the original terms of the receivables.

h. Trade creditors

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Accounts payable are classified as current liabilities if the company does not have an unconditional right, at the end of the reporting period, to defer settlement of the creditor for at least twelve months after the reporting date. If there is an unconditional right to defer settlement for at least twelve months after the reporting date, they are presented as non-current liabilities. Trade creditors are recognised initially at the transaction price and subsequently measured at amortised cost using the effective interest method.

This has helped us to provide more opportunities for our members. Strong partnerships all play a vital role in working towards stronger communities and social change.

The future is exciting. The New Den has created a home where members, their friends and family can grow and flourish.



Health and happiness is at the heart of everything we do at Gateway, from our successful sports projects to arts, crafts, performing arts, social and youth groups, individual support and Day Service. Health, Happiness and Well-being is the foundation on which we build.

Our weekly grant funded projects are well attended and are extremely popular. They are often a lifeline for many of our members. Over the year we have delivered 16 weekly groups ranging from sports, healthy living, youth groups, social groups, computers and the arts.







Our groups support our members to take part in activities within their local community as well as providing opportunities to travel further afield. We have visited Durham Cricket Ground, Newcastle Participation League at Cramlington, Headway Arts and many more. Melanie has been a great supporter and friend of Gateway into the Community and has made a real impact in securing grants and funding. This has contributed to our growth and journey. Thank you Melanie. We would also like to thank all our friends, families and members for their support, donations and fundraising as without this we would not be where we are today.



Individual Support

I am pleased to report that Gateway has had another fun filled year. There have been many achievements from those who receive individual support. We were delighted when we were approached by Hexham in Bloom to work in partnership with them.



We received a donation of £250 to buy planters, compost and plants and with the help of members and staff we have created some beautiful displays. Some of our

members have taken on the responsibility of watering and maintaining the planters, which are flourishing. We aim to increase the number of planters next year with the continuing support of Hexham in Bloom.



In addition to the planters we also worked collaboratively with Hexham in Bloom doing a Litter Pick around the local area. Both Gateway staff and members volunteered and put in a huge effort.

We collected 14 bags of litter in total which I'm sure you will agree is a great achievement. As a result of the

effort and the enthusiasm, some of our members expressed interest in doing litter picking on a regular basis. We decided to invest in some high visibility jackets and litter picking tools and already our Healthy Living group have since carried out a few litter picking sessions.



Our Individual Support members continue to receive a bespoke service that is specifically tailored to their needs and we are committed to developing skills and talents. Cooking has played a huge part at Gateway this year and we are utilising the Kitchen that we had fitted as a result of valuable funding from the Community Foundation.



Members have cooked a range of healthy meals including carbonara, curry,



chilli, pies and sweet treats such as cakes, scones and rock buns. We are encouraging our members in the importance of cooking meals using fresh ingredients and making informed choices. The smells drifting around the Flat in the Den are truly amazing.

In addition, we have staff with many talents such as cycling so one of our members goes cycling every week (weather permitting). He has clocked up many miles over the last year and on one occasion cycled an incredible 40 miles. Another member has had the opportunity to visit one of our staff members' farm where she has planted seedlings and cooked and helped care for the animals.





Some of our members have also taken part in a 10k run and a Triathlon where money was raised for both Gateway and Cardiomyopathy. This was a fantastic effort by all who participated and we are incredibly proud of the effort and commitment our members have shown.



In May Kirk Barclay organised a Family Fun Day to raise funds for Gateway into the Community. The event was a huge success with activities such as face painting, mini go-karting, trampolining, raffle and mini cricket games. An amazing £900 was raised before the event even took place.



Many members, friends and families turned up and enjoyed refreshments which included burgers and sausages. A total of £2,200 was raised. Events such as these epitomise the idea that Gateway into the Community is indeed one big family. A huge thankyou to Kirk Barclay for coordinating the whole event.



Finally, we were invited to the Youth Forum Awards where some of our members were nominated because of their individual qualities and achievements. This award gives our members recognition for the difficulties or obstacles they may have had to overcome in their time at Gateway so far. Some of these members have overcome anxiety and have coped well with the transition from school. The award also recognises achievements and one of our members has successfully completed an ASDAN course in Horticulture and another member is recognised for his editorial work and development of the Gateway into the Community Newsletter.



Day Service

This has been the fastest and busiest year so far. So much has happened. The year started with an amazing residential trip funded via the Community

Foundation. A group of Day Service members and other

Friendships and happy memories were made and everyone had the best time. We were even able to take "Buddy" our little Den Doggie, who added extra fun for all.

The long awaited Kitchen and Bathrooms are finally completed and we enjoyed an opening event where

all the funders and fundraisers were invited along. We have made great use of the new facilities. Members are cooking and baking some wonderful things, increasing their social and independent skills.







Rhian, Sophie and Lucy represented Gateway in an attempt on the world record for the longest moving line of wheel chairs, during the summer. Unfortunately, due to the miserable weather on the day, lots of people didn't attend, and the record wasn't broken but they are keen to try again next year.



The Day Service has been busy keeping everyone informed of events via the Facebook page and, more recently, the first edition of The Gateway Newsletter has been published. Great thanks to everyone who has contributed, especially Rowan Simpson who has really pushed forward with this project as lead editor.

We have been working with local businesses who have supported us. This year, we were chosen by Waitrose Hexham to be one of their Community Matters recipients.





M&Co Hexham held a fashion show and our members were chosen to be models for the evening. The evening was lovely and some of our members modelled the clothes. We feel privileged and honoured to be working alongside such fabulous local businesses.



We held our annual Macmillan coffee afternoon, which was a great success. We raised £125. With our new kitchen facilities we were able to make lots of lovely cakes and everyone was able to contribute fully to the experience. We would like to say thankyou to all our visitors on the day.
