The CIO consists of:

- Seven Trustees who are nominated and seconded at the AGM and manage the day-to-day running of the Charity
- Volunteer coordinators who oversee the running of each monthly local outreach project
- Approximately 300 volunteer members, all of whom are registered vets/ veterinary nurses and who deliver monthly outreach sessions in each town/city and
- We are additionally supported (on an entirely voluntary basis) by a Veterinary Director who is also Chairperson of the medicine board of VetPartners, and a pro-bono funding and development adviser.

Identified risks are managed by the Board of Trustees who are accountable for specific aspects of the charity's activities e.g. treasurer (financial viability, oversight for all expenditure) etc. Risks are then managed and monitored through standing item agendas at annual Trustee meetings, with specific actions agreed on an ongoing or ad-hoc basis to mitigate risks and ensure appropriate controls are put in place. These are recorded in meeting minutes and reviewed on a systematic basis until the risk is ascertained to no longer be an issue to the organisation, when it is recorded as closed.

Processes for risk management during monthly outreach sessions are clearly stated within our Health and Safety Policy and associated Risk Register. Michelle Southern, Executive Director is Street Paws' Health and Safety Officer. She is responsible for the implementation of our Health and Safety Policy, and for ensuring compliance with Health & Safety legislation. Regional Street Paws Coordinators are responsible for communicating Health and Safety information to their own regions. They will be present at, and responsible for overseeing, every outreach event taking place in their designated geographical area. They are also

responsible for conducting risk assessments and ensuring compliance with Health & Safety legislation within their region/city of responsibility. Should a risk be identified, the Regional Coordinators involved will liaise initially with the Health and Safety Officer, who will advise on the remedial action which needs to be taken. Where initial risk assessments indicate that a risk is present, a supplementary assessment may be conducted by the Health and Safety Officer or another Trustee, both as a means of auditing the initial assessments and in order to ensure that the most effective remedial action is taken. All risk assessments will be regularly reviewed by the Board of Trustees at meetings.

Summary of the objects of the charity set out in its governing document

The object of the charity is to promote humane behaviour towards animals by providing free of charge veterinary care and assisting in the provision of temporary accommodation to animals owned by people who are homeless, vulnerably housed and other vulnerable groups severely affected by poverty.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

Main activities for public benefit during the period include:
Monthly outreach sessions in towns and cities across England at which our team engage with homeless/vulnerably housed people with pets, undertake initial diagnostic of each animal's health, and provide wormer/flea treatments, microchipping, pet food and basic supplies. We will also promote individual engagement with other relevant VCSE support services as appropriate e.g. Citizens Advice, Council housing teams to address their multiple and complex needs.
Facilitation of any required treatments or surgeries which need to take place within veterinary practices which are organised on behalf of, and provided to the owner/pet free of charge (paid for by ourselves). We negotiate with surgeries wherever possible to receive treatments at cost price.
Working in partnership with other local VCSE partners to carry out or work as appropriate, recognising that most people with multiple and complex needs (such as our beneficiaries) are engaged with, and would benefit from engagement with, many support agencies. Local and regional stakeholders we work alongside include homelessness charities, Local Authorities, Police, soup kitchens etc. Across our project areas, we work with approximately 500 stakeholders including vets, kennels and others.

Our beneficiaries are:

- People who are homeless (have been evicted from home, asked to leave by friends or family, repossession, must leave due to violence, can't stay due to fire or flood, or are sleeping on the streets); or
- People who are vulnerably housed (living temporary or emergency housing e.g night shelter, women's refuge; or
- Other vulnerable groups severely affected by poverty – these include those having recourse to food banks and soup kitchens, care leavers, etc.; and
- Owns pet(s) who live with them in these conditions and who require veterinary care that the individual is unable to afford.

We also work to negotiate and pre-agree arrangements for emergency kennel space. This involves animal shelters allowing Street Paws to pay reduced rates for overnight kennel space for pets of our beneficiaries. We will utilise this service in two defined circumstances: 1) when a homeless person who meets our eligibility criteria wishes to take up an offer of temporary/emergency accommodation, which does not allow pets. This enables them to access a safe sleeping space for the night; 2) when a homeless, vulnerably housing or otherwise vulnerable individual who meets our criteria needs overnight/in-patient hospital treatment. In both cases, such is the bond between the homeless and their pets that they will often choose not to access these services if it means leaving their pet, risking further detriment to their wellbeing. This service is open to all eligible beneficiaries, and who can evidence an offer of temporary accommodation or required overnight/residential treatment.

We have taken significant steps to bring down barriers to homeless people accessing accommodation and services by installation of specifically built dog kennels into hostel grounds. Less than 10% of hostels Nationally will allow pets - by installing the kennels homeless people no longer are faced with the choice of giving up their dog - or a bed for the night. To date we support two Kennels in Leeds installed by Beacon Hostel.

Summary of the main achievements of the charity during the year

Since setting up our first project in Newcastle in April 2016 with one outreach in Newcastle and three veterinary volunteers, we have grown in size and scale and now deliver monthly outreach in 24 towns and cities nationally, engaging with approximately 320 homeless people and 340 pets monthly. These are based in the following areas: North East, North West, Yorkshire, Wales and Northern Ireland.

During the reporting year, we have worked hard to develop both new and existing relationships enabling us to maximise our impact. These include working alongside 24 local veterinary practices who are based in our project areas. These include, for example, Westways Vets, Valley Vets, Beechwood Vets and Tameside Vets. From these, we negotiate cost price treatments, medicines and surgical interventions as required. We also work with stakeholders across the UK including the NHS, North East Homeless, Leeds Street Kitchen, Simon on the Streets, The Moses Project, Changing Lives and Street Kitchen. All our outreach sessions run co-terminus and simultaneously to their activities, ensuring we engage the maximum number of potential beneficiaries.

We continue to develop our partnership with other local VCSE partners, including developing an agreement with Newcastle Cat & Dog Shelter which enables us to offer overnight emergency kennel space for pets whilst their owners go into temporary/emergency accommodation or overnight/in-patient hospital treatment.

We are also working with social landlords and established hostels, in project cities to identify safe and clean longer-term accommodation that is pet-friendly. In this way, Street Paws will both address the immediate welfare needs of the animals owned by people who are homeless or vulnerably housed, and the more systemic issues causing homelessness.

Our team has also worked to develop robust governance structures to underpin the longer-term sustainability of the charity, including a range of policies and processes underpinning everything from volunteer recruitment, veterinary expenditure, and CPD for our teams. We have also invested in website development and social media to ensure we can promote our activities, attract new volunteers, take referrals for homeless pets in need of veterinary support, and engage with potential community partners. Finally, we have engaged pro-bono support including a photographer to ensure we have high-quality images of the work we do and the pets we have helped.

All of these steps will act as foundations to ensure that we continue to maximise the public benefit of our work together in future.

Our Reserves Policy ensures the organisation can operate for a minimum of one year at a basic level without any additional income should the need arise. This covers all routine veterinary fees (excluding surgical interventions), costs of running the charity etc. and totals £10000.



Review of activities and performance

The trustees of the charity present their report with the financial statements for the charity for the year ended 31 August 2019.

Street Paws is a charity concerned with supporting homeless and vulnerable people and their pets. We raise money through private donations, grants and corporate sponsorships in order to help fund the veterinary care of a large number of animals throughout the North of England, Yorkshire, Lincolnshire, Wales and Northern Ireland. We also raise awareness for the issues these people and animals are facing, and provide any other support that we may be able to provide to help the care of their animals.

During the 2018/19 period, we funded veterinary care for hundreds of animals, including offering everything from routine vaccinations to urgent surgical procedures. The charity also appeared at several events nationwide, as well as national and local TV and radio to raise awareness.


During the year we also opened our first dedicated kennel facilities to help homeless and vulnerable people place their animals at times they were unable to care for them themselves for short periods due to illness, extreme hardship, or other temporary changes in circumstance.




