## Message from the Chair

I am pleased of the achievements we have made this year. Contributing more to the community, increasing our festival and fundraising activities, all while maintaining a good surplus to help us for the coming years.

Reading Pride has become a significant annual fixture for events in the area, and a contributing factor to the improvement in quality of life for LGBT+ people in the area. Reading remains one of the largest town prides, and still remains free at the point of entry to everyone.

The organisation has remained solvent throughout its history, and remains a membership organisation.

This has been a year of firsts for Reading Pride. The first, was entering a float into the Reading Caribbean Carnival in May. In conjunction with Reading Buses and the Reading Renegades we certainly brought the rainbow to the carnival, with an open-top bus, and the weather was fantastic as well.

We also exchanged visits with our twinned town in Düsseldorf, with members of our committee attending CSD Düsseldorf in June 2018, with a reciprocal visit to our event. The first time that we have exchanged visits and certainly something we would like to continue into the future.

In June, we had our first sports day event, with teams competing against each other in old school events such as the egg and spoon race and sack race. We had four teams, with prizes for best fancy dress as well. Again this was a first for Reading Pride, and hopefully this will also become an annual fixture.

This year, we made significant efforts to increase the activities in the run-up to our event, and so for the first time, we had our first Pride Week. This included a film night at the Blagrave, a MyUmbrella social in Broad Street Cafe, a sports event with Reading Renegades and a quiz night and raffle at the Sun Inn, with proceeds going to Reading Pride. We also teamed up with Boots, to offer a trans make-over event and we worked with Reading Minster for a Christian service and Eucharist, and for the party animals, we even had a pre-pride warm-up as well.

In 2018, we continued our Love Unites theme and started our plans to improve our event. This saw the introduction of a temporary pedestrian crossing on Napier Road to



improve safety. The same company also assisted with managing the lights on Forbury Road for the parade. They also provided the signs to direct traffic to event, so this is something we did not have to do ourselves.

We also increased our security both for the parade and at our event to ensure our event is as safe as possible for everyone.

We had a dedicated family area, with activities for children throughout the day and even had story time with some of the Drag Queens including Wilma, who read the Gruffalo and Tango makes Three. We also thank Waynie, who brought karaoke back to our event.

We reconfigured the site to provide more space for marketplace and to help manage the flow of visitors. Our marketplace was significantly larger than in previous years, and we also offered community groups and organisations a free pitch to help organisations where we could. Yet we still saw a strong increase in our income for our marketplace.

Also joining our event was a dedicated area for pups, which not only provided an area for them to hang out, but also offered education as well.

We also introduced Mobiloo, a mobile accessible toilet with adult-sized changing bench and hoist.

Wilma and The Blagrave have kindly run a monthly bingo event on Sunday afternoons, which has raised additional funds.

Like many other prides we also educated on the situation around the world for LGBT+ individuals, and why Pride still matters. It is saddening that around 5% of the world's population, live in a country where LGBT+ people face the death penalty for being LGBT+. Many countries, including those in the Commonwealth, are not safe places for LGBT+ individuals, and this is something we would like to see change.

I would like to thank everyone who contributed or helped Reading Pride, to help improve the environment for LGBT+ in Reading and the surrounding areas.

## MyUmbrella

Another busy year for MyUmbrella, as they have continued to hold regular monthly social events across Reading with continued growth in attendee numbers month on month.

The Pride season kicked in February 2018 in London at Student Pride and ended in Bristol late in November, a total of 14 prides across the south of the UK were visited.

Attending other pride events to promote the breadth that exists in LGBT+ community, is an excellent opportunity to educate people about the lesser known sexualities and genders, while at the same time promoting the work of Reading Pride.

MyUmbrella also ran workshops at Exeter, Coventry and Trans Pride South West. At Warwickshire Pride, MyUmbrella ran a trans chill out zone and contributed to a pride panel for speakers corner at Gloucester Pride.

MyUmbrella held their fourth Transgender Day of Remembrance vigil, which was held at Penta Hotels, seeing the biggest turn out yet for this event.

In May, MyUmbrella joined Thames Valley police for the IDAHOBIT (International Day Against Homophobia, Biphobia and Transphobia) have your say on Broad Street.

For the first time, MyUmbrella went into local secondary schools to speak about LGBT+, and attended a number of conferences across the UK, including the National Asexuality conference in July in London and the first Thames Valley Police LGBT network conference in October.

# **Donations**

We received over £6,200 in donations on the day, an increase of over £2,000 compared to 2017.

#### Statement from the Treasurer

#### Objects and Risk

#### Objects

Reading Pride exists to champion diversity and inclusion with the Thames Valley and beyond. The running of our annual Parade & Festival accounts for the vast majority of income and expenditure. With no property assets or employees, running costs and overheads remain very low.

#### Reserves

Significant expenditure is required in advance of the Pride Festival to secure equipment and suppliers. Following a number of challenging years, it the Trustee's intention over the next several years to ensure reserves of a minimum of 25% of annual turnover of the charity.

#### Risk Review

The Trustees consider that the most significant risk continues to be from rising costs of festival equipment / suppliers coupled with the challenging financial climate making regular and predictable income sources, particularly from the third sector, difficult. The charity continues to turnover the majority of income to expenditure within a yearly cycle, however reserves have grown in recent years and there is no debt.

#### Trustee's Responsibilities for the Financial Statements

Charity and Company Law require the Trustees, who are also the Directors of Reading Pride, to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the Charitable Company at the balance sheet date and of its incoming resources and application of resources, including income and expenditure for that period. In preparing those financial statements, the Trustees are required to:

- Select suitable accounting policies and apply them consistently.
- Make judgements and estimates that are reasonable and prudent.
- State whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements.
- Prepare the financial statements on the going concern basis, unless it is inappropriate to assume that the Charity will continue in business.

The Trustees are responsible for keeping financial records, which disclose with reasonable accuracy at any time, the financial position of the Charity and that enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence must take reasonable steps for the prevention and detection of fraud and other irregularities. This report was approved by the Board on the 13 March 2019.

# Statement from the Independent Examiners Report

Respective Responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed.

The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

#### Independent examiner's statement

In connection with my examination, no material matters have come to my attention which gives me cause to believe that in, any material respect:

- the accounting records were not kept in accordance with section 130 of the Charities Act; or
- the accounts did not accord with the accounting records; or
- the accounts did not comply with the applicable requirements concerning the form and content of accounts

set out in the Charities (Accounts and Reports) Regulations 2008 other than any requirement that the accounts give a 'true and fair' view which is not a matter considered as part of an independent examination.

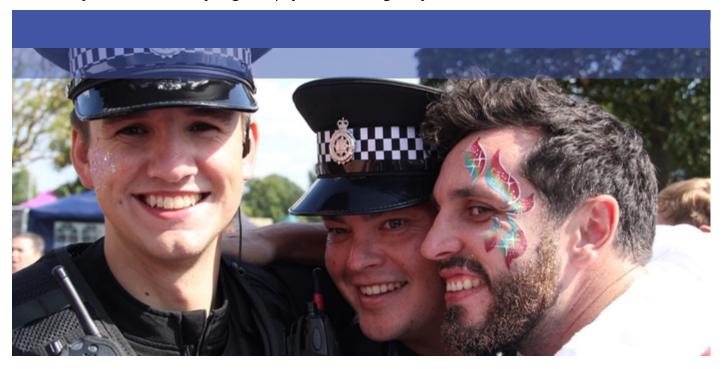
