#### REVIEW OF THE YEAR

The income of the Trust is derived from the original endowment fund under the will of the late Harry Skells and interest etc from unspent income. The income was £29,566.57 for the year. During the year the Trust approved grants totalling £6,266.40 and spent £2,399.86 on St Michael's Churchyard.

The total accumulated available income at 31st March 2019 was £42,133.84 after allowing for grants approved but not paid etc.

#### RESERVES POLICY

The Trustees have no formal policy in relation to funds not distributed. All grant applications are considered on their merits and the availability of funds. The Trustees are aware that they need to maintain unrestricted free reserves at a level to provide sufficient funds to cover operating expenditure. Whilst the Trustees can meet their current grant obligations the level of future grants is dependent upon investment income.

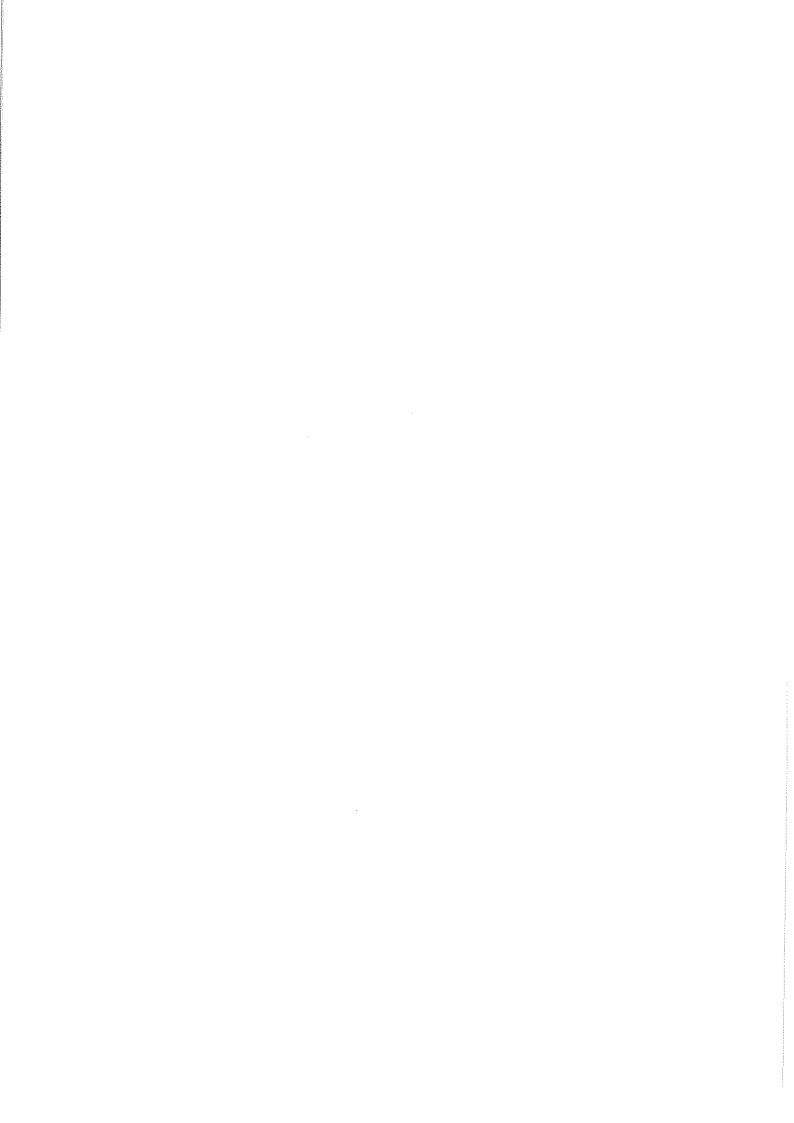
