#### Report of the Trustees for the Year Ended 31 August 2019

The Trustees present their report and independently examined accounts for the year to 31 August 2019.

#### Charitable object

The charitable object of the group, as prescribed by the Charity Commission, is to relieve the physical or mental distress of persons with Cancer and the partners, families, friends and carers of such persons through the provision of services.

- Trevor Chrismas and Raj Limbachia, who were appointed by the trustees since the previous AGM held on 5<sup>th</sup> September 2018, retired at The AGM and were both then elected for a 3 year term.

The charity trustees may appoint one of their number to chair their meetings and may at any time revoke such appointment. At the date of this report the appointed chairman is Graham Nicoll.

#### Trustees' Report

The year ended August 2019 has been the most successful on record for the Olive Tree Cancer Support Group, with total income exceeding £100,000 for the first time in the charity's history.

This is, however, no time to sit back and relax. With the opening of the new information centre in Horsham, income will need to further increase by more than 50% in the coming year if the Charity is to continue to deliver its existing and newly expanded services.

#### Horsham Information Centre

This year has seen new premises taken in Horsham Hospital and the opening of the new Information Centre. Two new staff have been employed dedicated to the Horsham site, one of which is supported by Macmillan funding.

In order to set up, equip and open the new centre, we received grants from, the Garfield Western Foundation, Gatwick Community Trust and the OneFamily Foundation.

The ongoing staff and other costs represent a significant part of the increased cost base for the coming year. The use that has already been made of the new centre, and the extremely positive feedback we have received, demonstrates how very worthwhile an investment this is, both for now and the future.

#### Fundraising

During the year Alyson Smith resigned as fund raising manager to take up an opportunity elsewhere. The trustees would like to thank her for her contribution while she was with us.

The Olive Tree is funded entirely by charitable donations and has significantly expanded its operations. The Trustees, therefore, agreed to appoint a new fundraising officer with increased working hours to refocus our efforts and drive the growth in fund raising activity. The Trustees are pleased to welcome Ava Harding as the new fundraising officer. We would like to thank the Henry Smith Charity for their continued support for this post.

The Olive Tree has been very fortunate in receiving support from a wide range of benefactors including companies, foundations and local and national organisations.

A particular success was the sponsored walk arrange by students of Oriel High School where the students had chosen the Olive Tree to receive all the sponsorship from the walk. While the walk took place in the summer of 2018, funds of £13,719 we received in the year.

While grants from organisations such as The National Lottery Community Fund and The Sussex Community Foundation provide a significant source of funds for the Olive Tree, the long term support of community organisations is key to its ongoing success.

There are simply too many to mention in this report but organisations such as the Trailblazers and the RAM Cricket Club, and events such as the Pillars to Plough walk, not only raise much needed funding, but also help engage with the community we serve and raise the profile the Charity and its important work.

#### Training

The Olive Tree believes that training is key to the effective and efficient delivery of high quality support to all those who chose to take advantage of the wide range of support services available. Training is provided to staff, volunteers and trustees as needs are identified.

#### Outlook

The coming year presents some great challenges for the staff, volunteers and trustees with the opening of the new centre and broadening of the services provided we are presented with a massive opportunity to help more people than ever before.

Achieving our objectives will rely on support from many directions; from the staff and volunteers in delivering the services, and from our many existing and new benefactors in providing the funding needed to support the delivery of our services.

#### Treasurer's Report

This year the surplus was £16,705, following a deficit of £10,910 last year.

#### Income

Income received for the year was £103,563, up from £53,047 in the prior year. The increase arose primarily from donations, including £18,571 with regards to the new Horsham Information Centre.

#### Expenditure

Expenditure paid increased by £22,901. The increase arose from salaries of £10,183 following the appointments in Horsham and fundraising during the year. A further £8,699 was incurred for equipment, primarily in Horsham and an increase in Drop-in and therapy expenses of £3,728.

#### **Restricted Funds**

Restricted funds comprises amounts received for a specific purpose. Such funds are monitored to ensure they are only applied for the specific purpose and any balance of such funds is separately.

Horsham Information Centre. Grants have been received in the amount of £18,571 for the purpose of the establishment, development and running of the Horsham Information Centre. Of those funds, £16,261 has been expended on the centre with £2,310 being held over to the following financial year.

Fundraising Officer. A grant was received from the Henry Smith Charity in the amount of £6,500 to support the role of Fundraising Officer. The grant received has been fully expended with no amounts being held over.

#### Reserves held

Reserves, including the restricted funds detailed above, have increased from £148,201 to £164,907 following the surplus of income over expenditure detailed on page 7. Details of funds invested are included on page 8.

#### Risk management

The Trustees undertake regular assessments and, where appropriate, systems or procedures have been established to mitigate the risks the charity faces. These inform the Trustees' consideration of an appropriate target range for cash reserves.

Reserves targets are calculated by reference to the forward financial outlook and the risks facing the charity, with the aim of ensuring that key services are sustainable and that early action can be taken to deal with matters as they arise.

#### Reserves Policy

The trustees set, publish, implement and monitor the Reserves Policy in line with the guidance provided by the Charities Commission in England and Wales, "Charity Reserves and Building Resilience" (CC19) to ensure compliance with their legal duties to: -

- a) act in the interests of their charity and its beneficiaries;
- b) protect and safeguard the assets of their charity;
- c) act with reasonable care and skill; and
- d) ensure their charity is accountable.

The trustees have reviewed the financial risks facing the organisation (see Risk Management section above) and quantified both the probability and magnitude of various risks. The Trustees have resolved as a policy to set both an upper and a lower limit of unrestricted reserves to be maintained for such purposes and to act to increase or decrease expenditure if the reserves fall outside those limits. At the date of the approval of this report by the trustees, the target range of reserves was £130,000 to £195,000. Actual reserves at £162,597 (excluding restricted funds of £2,310) were within the target range.
