#### Background

#### **Church Attendance**

As at December 2018 there were 158 persons on the Church Electoral Roll. Of these 38 were not resident in the Parish. Overall this was an increase of one compared to 2017 but with a reduction of one resident and an increase of two non-residents.

#### Financial Review of the Year

The annual report and accounts incorporate both the church accounts and the Parish Centre accounts in a single document.

Total income for the year from all funds was £95,169 compared to £94,884 in 2017; expenditure for the year was £113,262 compared to £114,359 in 2017. This left a deficit of £18,093 compared to a deficit of £19,475 in 2017.

The key headlines in respect of the 2018 accounts are:

#### Income

- £56,489 was received from Giving compared to £49,351 in 2017 of which £29,736 was from standing orders and this compared to £25,751 in 2017
- There was a £500 legacy received as part of the Giving total in 2018
- A further £2,535 was received in respect of other income compared to £3,978 in 2017. This
  included £1,639 in respect of income from the Parish Magazine and this compared to £1,788 in

- 2017. The total of Other Income in 2018 included £756 which was received as part of an insurance claim
- Fundraising of £3,124 was received into the Fabric Fund during 2017 compared to zero fundraising in 2016
- £10,135 was received as income in respect of the Parish Centre compared to £13,189 in 2017

#### Expenditure

- £64,452 was paid out in respect of the Parish Share compared to £65,316 in 2017
- £25,735 was paid out in respect of the day to day running costs of the church and provision of services compared to £20,822 in 2017. Of this £5,623 was spent on the church yard compared to £3,440 in 2017 and £3,589 was spent on printing and stationary compared to £1,289 in 2017
- £10,361 was paid out in respect of expenditure relating to the Parish Centre compared to £12,340 in 2017. Expenditure in 2017 included £3,110 on major repairs of which there was none in 2018

In summary the reduction in deficit compared to 2017 can be attributed to:

- An in crease in overall Giving specifically from standing orders combined with
- A reduction on overall expenditure

The Church continues to run at a deficit and whilst we have a healthy balance of £90,064 (2017: £109,224; 2016: £133,000) held with the CBF; if the Church continues to run at the level of deficit which it has been all reserves will have been used up within five years. A Funding Campaign previously planned for 2018 is being launched in 2019 to address this very serious issue.

#### Independent Examiner's Report to the PCC of The St John The Evangelist Carlton in Lindrick.

I report on the accounts of the PCC for the year ended 31st December 2018, which are set out on the attached pages.

#### Respective responsibilities of PCC and examiner

As the members of the PCC you are responsible for the preparation of the accounts; you consider that an audit is not required for this year under the Regulations, that section 144(2) of the act does not apply and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under section 145 of the 2011 act;
- b) to follow procedures laid down in the general directions given by Charity Commissioners under section 145(5)(b) of the 2011 act, and
- c) to state whether particular matters have come to my attention

#### Basis of Independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners under the 2011 act and to be found in the Church guidance, 2006 edition, issued by the finance division of the Archbishops' Council. That examination includes a review of the accounting records kept by the PCC and a comparison of the accounts with these records. It also includes considering any unusual items or disclosures in the accounts, and seeking explanations from you as members concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### Independent examiner's statement

- No matter has come to my attention, which gives me reasonable cause to (1)believe that in any material respect the requirements: -

  - To keep accounting records in accordance with section 41 of the Act and: To prepare accounts which accord with the accounting records and to comply with the accounting requirements of the Act

have not been met

The overall expenditure in the year ended 31st December 2018 was £113262.73. The income was £95169.50. This is a deficit of £18093.23 in the financial year.
