CHAIRMAN'S REPORT FOR YEAR ENDING 31ST DECEMBER 2019

The Trust has had another good year in offering our services to those that need them within the Parish of Prestbury. Although the numbers fluctuate as we are serving the elderly, this usually remains about 200. The shopping and exercise groups are well supported. The Lunch Club varies in its support including late cancellations but is much enjoyed by all who attend who are most grateful to the kind volunteers who transport them to Cleeve Hill Golf Club. The Christmas tea party was once again a great success and my thanks to Bob Conolly for organising it. As it was our 70th Anniversary it was decided not to make any charge and our main funding for this came from the Prestbury United Charities to whom we are most grateful.

The knit and natter group is small but much enjoyed by those who come to the library.

Jane Banwell continues with her fundraising with social events and applying for grants which has been very successful again this year with Quiz Nights being sold out very quickly; so this next year we intend to hold two.

The Friendship Group continues with their Birthday visits and arranging coach tours with a WI tea which are most popular. My sincere thanks to Gloria Gmys and her volunteers for running this group.

The minibus continues to be well used but there is a problem with the manual retractable steps and we will probably have to invest in electric steps. Thanks to Nigel Woodcock for looking into this and for assiduously keeping an eye on the 'bus and with Jenny Roden keeping it maintained and clean.

Our tenant of 14 years of 10A sadly passed away and following clearance by his family extensive works of redecoration, bathroom improvements and generally bringing it up to current legal letting standards were carried out as well as new floor coverings. New tenants have been found who have taken a 12 month Assured Shorthold tenancy from 11th April 2019 at a calendar monthly rent of £650.

We are proposing to modernise the Bathroom of 10 Deep Street during the next 12 months. As with all property there are periodic maintenance works needed from time to time and we endeavour to keep on top of them.

Our finances are in a good state at present. We continue to raise funds through social events, grants, legacies, gifts and this year we started a 100 Club in June and we already have 80+ members with a monthly draw at Lunch Club, thanks to Bob Conolly and Jane Banwell for organising this which should be a good ongoing fund raiser for us.

Our part time warden Jenny Roden organises or helps to organise our groups and deals with recruitment as well as making visits to our members when necessary and generally liaises with any statutory bodies when needed. My sincere thanks to her, all the committee and the numerous volunteers who help us in various ways and without whom we could not provide all the services that we do.
