# Accountants Report to the Trustees on the Unaudited Accounts of the Charity Beis Hatalmud Trust

We report on the financial statements, for the Year Ended 30 November 2019 which comprise the Statement of Financial Activities, the Balance Sheet and the related notes. These financial statements have been prepared, under the historical cost convention, and in accordance with the recommendations in Accounting and Reporting By Charities: Statement of Recommended Practice (Issued 2015), and the Financial Reporting Standard for Smaller Entities 102 (effective 2016), and the accounting policies set out therein.
