To advance such purposes that are charitable under the laws of England and Wales for the public benefit in the Puntland region of Somalia and the Haud region of Ethiopia by in particular but not exclusively;

**(a)** Providing or assisting in the provision of education, training, and necessary support to enable individuals to generate a sustainable income and become self-sufficient **(b)** The relief and assistance of people who are victims of war or natural disaster or catastrophe by the provision of emergency aid, food, clothing and shelter **(c)** The advancement of animal welfare for the public benefit by the provision of programmes to increase access to veterinary care and treatment **(d)** The advancement of environmental protection and improvement by the provision of access to sustainable waste management and the provision of programmes to increase awareness on environmental conservation and biodiversity

The CIO opened a charity bank account to facilitate income however we did not engage in any charity drives. A website has also been commissioned to establish a web presence. The charity has had no financial activities for the period 27/06/2018 to 26/06/2019.


