The object of the society is to educate the public in the dramatic and operatic arts, to further the development of public appreciation and taste in the said arts, to assist and further such charitable institutions and charitable purposes, as the Committee shall from time to time determine.

The society meets every Thursday evening at 8pm at Laleham Village Hall, The Broadway, Laleham, Middlesex for rehearsals and, in the months preceding a major production, also rehearse on Tuesdays and at the Weekends. During the year the Society performed on the following occasions at various venues in the Boroughs of Spelthorne and Runnymede.

December 2018	Christmas Concert, 'Christmas Revels' at the Riverside Arts Centre, Sunbury

The society relies heavily on the fundraising concerts and our annual quiz night to supplement our income.

The Society did not receive any financial support this year from the Local Authorities but did receive Gift Aid from the HMRC.

The Society is a member of the National Operatic and Dramatic Association (N.O.D.A.). Membership of this Association enables us to take advantage of group insurance rates, as well as being a source of help and advice on Operatic and Dramatic Issues. The Society is a member of the Spelthorne Community Arts Council, and is also a member of Magna Carta Arts Association and the Riverside Arts Centre where our concerts are held.
