This report covers the period for the calendar year 1 January to 31 December 2019.

REPORT

OBJECTIVES AND ACTIVITIES

The object of the Matthew Ministry is:

To promote and advance the Christian faith in accordance with the statement of faith set out in the schedule appended to this constitution, primarily (but not exclusively) in and around the city of Cambridge.

The Matthew Ministry was formed on 8 March 2016. The charity has been preparing plans for its operation, but no major activities were undertaken in 2019.

ACHIEVEMENTS AND PERFORMANCE

A television screen was bought in 2019 and has been lent to the church of St Andrew the Great in Cambridge.

The charity was approached by the Littlegate Trust to endorse its nominees as trustees. Two new trustees were endorsed in January and December 2019.

The charity continued to make plans for the purchase of residential property in Cambridge to house gospel workers in the city.

FINANCIAL REVIEW

The only income in the year was a refund of tax from HMRC under the Gift Aid scheme.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The charity is governed by its founding constitution dated 8 March 2016 and operates as a charitable incorporated organisation.

The three founding trustees were appointed for the following terms from 8 March 2016:

- The Reverend Giles Walter (four years)
- Professor Peter Robinson (three years) stood down in 2019
- Professor Stephen Oakley (two years) stood down in 2018

After consultation by e-mail in April 2019, the trustees agreed to appoint Matthew Baker as a trustee.

A further consultation by e-mail was conducted in June 2019 to approve the annual return for 2018.
