In turn the money is paid out by the Citizens Advice offices to meet the cost of gas or electricity, direct to the supplier, for people who have insufficient money to pay their accounts

Quiz Night October

A quiz night was held in October. To raise funds which will contribute to the Woking Lions' Christmas lunch for those living on their own, as well as local charities.

Bake off

A Great Woking Bake Off to raise money for The Royal Surrey County Hospital Trust which supports teenagers and young people with cancer was held in April.

Lions Martians Race

A charity run was held on June 30 over Horsell Common to raise funds for Local charities. Participants were invited to cover 5, 10- or 21-kilometre distances.

This is our largest fundraising event of the year with almost 6000 pounds being donated to Local charities.


