Chairman's Foreword

As foreseen in last year's Report our body of Trustees was depleted in the course of the year as Cllr. Mohammed Abbassi stepped down and Cllr. Elise Benjamin came to the end of her term. Discussion with Oxford City Council about replacement nominees was still under way at the end of the year.

The arrangements detailed last year concerning the splitting of the post of Estates Manager have continued in place. Phil Crème, Estate Manager, has further reduced his hours to six per week. Edmund Faria, his deputy, has increased his to nine hours per week. The Trustees remain pleased with the new arrangements which will persist in the meantime. The resulting increase in salary cost has been accommodated by reducing charitable giving in the year – possible by more than proved to be necessary in the event - but it is hoped that this can be increased again over the next few years.

Our association with the charities Restore and The Porch continue to be a source of satisfaction and enjoyment and we appreciate the project work which they carry out on our site. Other charities are taking plots and pursuing their own charitable objects with us, a development which we welcome.

I wish to record my appreciation for the work of our Trustees and the efforts of our part-time staff – Phil, Edmund and Ian Honeyman, Charity Manager, who fulfils the roles of Secretary and Treasurer. Ian had a period of serious illness in the latter part of the year which delayed the work of preparing accounts and this Report, but I am pleased to say that he has now returned to full health. I also record the contribution made by the solicitor to the Trustees, Ms. Kathryn Woodward.

Report of the Trustees for 2018

As the Chairman has reported the financial outcome in the year has been satisfactory, but only because, to our regret, it has been achieved by reducing charitable giving by a substantial amount. We plan to return to recent levels whenever possible.

Staffing arrangements have been reviewed and deemed to be satisfactory. We will therefore continue on the current basis for the foreseeable future. Our large site required more oversight than it was previously receiving and the effect of the increase we have implemented has been beneficial. Take up of plots has been gratifying. New tenants, as the Chairman has recorded, include charities who are active in the area. We are happy to be supportive of them and will consider further help over time. Our governing document imposes significant restrictions, but we are happy to work within them.
