## Report of the Trustees for the year ended 30th June 2019

The Trustees present their annual report and financial statements for the year ended 30th June 2019. The financial statements have been prepared in accordance with the Constitution of Severn Dean Lions Club (ClO) dated 19th April 2018 and the requirements of the Charities Act 2011.

## Structure, governance and management

Severn Dean Lions Club (CIO) achieved Registered Charity Status on 19 April 2018 as a Charitable Incorporated Organisation part of Lions Clubs International. The Club is managed in accordance with its Constitution and Grant Making Policy, approved by and registered with the Charities Commission. The Club elects a minimum of 3 Trustees annually.

Members and Trustees routinely meet monthly to receive reports from Trustees and Officers, to consider business matters and to decide on:

A programme of Events

Volunteering activities

Grants and applications for assistance from organisations and individuals in need

### The Year's activities in Summary

Incomes

The Club enjoyed income arising from 2 main events, which were organised in conjunction with the Forest of Dean Lions Club, an adjacent Charity:

The Wild Boar Chase, this year held in May, is a Mountain Bike Ride of various lengths through the Forest of Dean for both adults and children. This event is managed with the assistance of the Royal Dean Forest Cycling Club and reported on financially by the Forest of Dean Lions, proceeds are divided between the 2 Lions Clubs, this year to the sum of £6,850 each.

A Bonfire and Fireworks Display held annually each November at Speech House in the Forest. In September 2017, Severn Dean Lions Club took on responsibility for managing the accounts for the Bonfire and Fireworks Display and to report its financial affairs to the Charities Commission. Currently 3 of the Club's trustees serve on the Bonfire and Fireworks Management Committee. Again proceeds are divided between the 2 Lions Clubs, this year to the sum of £5000 each.

The Club, on occasion, assists with marshalling for other events held within the Forest of Dean, for which donations are normally received. The Forest Vintage Machinery and Vehicle Club this year donated £350.

## Expenditure, Grants and Assistance

The accounts show the detail of various grants and payments made totalling £15,548, in accordance with the Club's Grant Making Policy. Additionally, running costs for the Speech House Bonfire totalled £20,266. After accounting for the £5000 transfer to the Charity Account this gives a Total Consolidated expenditure for the Year of £30,815. Notably people and organisations supported included:

A number of individual Welfare cases, where the Club's early intervention has supported families in need with specific items of furniture, furnishings and white goods.

Schools and Young People in the Forest have benefited with specific support for projects. This year in particular the Club supported School Holiday meals for families in receipt of Free School Lunches, Dean Magna School for a number of Projects, and sponsored the Prizes for the Mitcheldean Festival Forest Young Poets and Story Tellers.

Donations were made to a number of Charities and organisations serving people in the Forest of Dean and to our local hospital, The Dilke, in Cinderford.

Grants were also made to a number of International Activities and Appeals supported by Lions Clubs International. Additionally the Club directly supports Paluoc, a Kenyan Woodworking Workshop under the auspices of Hands Around the World; and, the education of a student in India under the Joe Homan Charity.

The Club maintained a working balance of £16,876 at the end of this year; £8004 is specifically reserved in order to stage the next year's Bonfire and Fireworks Display.
