Structure, governance and management

The Trustees for the year 2018/19 were elected from the Club's members at the Annual General Meeting. They shall hold office for one year or until the succeeding season's AGM, and be eligible for re-election. The Annual General Meeting was held on 23rd October 2018. The Trustees constitute the Committee of the Club, which is responsible to the Charity Commission for the proper conduct of the Club's affairs. The Club is governed according to the rules established by its Documents of Constitution, approved by the Charity Commission and dated 20th September 1990.

Objectives, membership and activities

The objectives of the Club are defined in its Constitution, approved by the Charity Commission and in line with the provisions of the 2006 Charities Act. These may be set out as follows:-

- 1. To promote, improve, develop and maintain public education in and appreciation of the art and science of music in all its aspects by the presentation of public concerts and recitals, by commissioning new choral works and by such other ways as the Club through its Committee shall determine from time to time.
- 2. To further such other charitable purposes as the Club shall from time to time decide, including cooperation with neighbouring choirs and providing opportunities for schools to participate in its concerts.
- 3. To charge an annual subscription to cover the costs of weekly rehearsals and to contribute towards the periodic losses incurred in performing public concerts. This subscription may be waived or reduced in exceptional circumstances and at the Committee's discretion.
- 4. To welcome into membership any active musician in Aldeburgh and the surrounding district, without audition, and on the clear understanding that all members will support the Club in everyway within their means.
- 5. To provide, using patronage, or by charging attendees, training sessions for members, within or additional to concert rehearsals.

The Club arranges and performs concerts each year in Aldeburgh and the surrounding district. The programmes include many of the great classical choral works and a wide variety of less well-known works together with concertos and other orchestral works. Wherever appropriate, the Club will employ local orchestras, young professional soloists and instrumentalists from East Anglia.

Review of the year

The Club gave three concerts during the year. In November 2018 the choir with the Prometheus Orchestra gave a special concert at Snape Maltings Concert Hall to commemorate the 100th anniversary of the ending of World War One. The main item in the programme was Karl Jenkins' The Armed Man performed to a virtually full house. This was followed by another successful concert 'The Amazing Mr Handel' with the Suffolk Baroque Players on 16th March 2019 at Snape Maltings Concert Hall to a better than budget audience capacity of 74%. In May 2019 the club gave a concert titled A Night with the Choir accompanied by Mr James Recknell at the piano at Orford Church. The programme consisted of music by Elgar, Tavener, Jacob Handl Gallus, Faure and Bernstein and showcased the choir's versatility in music of different styles. Audience capacity at this concert was 94%.

All three concerts were conducted by the club's popular and excellent Music Director Edmond Fivet to enthusiastic audience acclaim.

Finances

The accounts of the club are prepared on a receipts and payments basis in accordance with charity law and on this basis they show an excess of receipts over expenditure of £5,827 in the financial year 2018/19. The better than expected result was in part due to higher audience numbers and the generous additional financial support from choir members, patrons and other supporters towards the additional costs of The Armed Man.

Charitable expenditure totalled £54,460.

In the year 2018/19 there were 84 members paying a subscription of £130 each. Excluding the recovery of gift aid tax, membership subscriptions totalled £10,870. Patrons contributed £8,213 excluding gift aid tax. These subscriptions and gifts help to underwrite the choir's rehearsals and concerts.

The three concerts made a total deficit of £7,471, compared to a budget deficit of £16,430.

We held cash at bank at the year end of £54,983.

Statement of policy on the level and banking of retained funds.

It is the club's policy to retain prudently substantial reserves to support future activities, especially where no sponsorship, grants or gifts are made available.

The club operates the following bank accounts:-

- Charities Aid Foundation Bank at 25 Kings Hill Avenue, Kings Hill, West Malling, Kent ME19 4JQ at which two
 accounts are held for day to day transactions and for receiving member subscriptions.
- HSBC at 20 High Street, Saxmundham, IP17 1DB, for receiving Patrons' donations and making payments to musicians.
- Charities Aid Foundation 60 Day Notice Account Issue 1 for the reserve funds. The account is held at Shawbrook Bank.
