Highlights 1 January – 31 December 2019

- This is the 35th year that the Disability Advice Service (East Suffolk) has been offering advice and support to disabled people and carers in East Suffolk Coastal.
- We have supported our clients who were awarded approximately £2,481,838 in benefits.
- We have advised 1,248 Clients
- We have dealt with 5,379 Enquiries.
- We won 71 of the 77 appeals cases where a decision was reached (92%)and dealt with 151 appeals throughout the year! Approximately 58 Cases have been carried over to 2020
- We were awarded £301,210 over three years by the National Lottery through the Big Lottery Fund. This is the Annual Report for the 2nd Year of the Big Lottery Grant
- We gave £4,086 as small grants to individuals.
- We continued our partnership with the **Multiple Sclerosis**Society to deliver advice to their members across our area.
- We continued our outreach services to Leiston/Framlingham/Felixstowe/Saxmundham/Woodbridge and their surrounding areas.
- We worked with a large group of housing officers from different organisations to deliver housing related help and advice including discretionary housing payments, housing arrears, evictions and homelessness.

Vice Chairs Report: Roy Gilmour

Disability Advice Service (East Suffolk) or (DAS) is an independent advice service for disabled people and family carers living in the Suffolk Coastal area. We are part of a wider network of disability advice services throughout Suffolk working to county-wide standards that are equivalent to nationally agreed community legal services (CLS) standards.

Our charitable objective is the relief of people with disabilities and families and their carers in East Suffolk, and our aim is for disabled people and their carers to have increased financial, social and psychological well-being through holistic advice. All financial, strategic and operational decisions by the Trustees are made with due regard to our charitable objective, aim, and the Charity Commissions Public Benefit Guidance.

To this end we provide advice on welfare rights, housing rights, accessible leisure activities, equipment, health and social care services, employment rights and permitted work, as well as referral to accredited providers of debt and legal advice. We are constantly developing our working relationships and partnerships with related organisations so that no-one in need of help and advice gets passed from pillar-to-post.

The last year has seen lots of changes in both staff and volunteers. We said goodbye to the following people:

I would like to thank them all for everything they have done for the organisation.

Special thanks go to Stella Morris for leading DAS as Chair of Trustees for 6 years. Her leadership and dedication were invaluable to the organisation,

Customer numbers have continued to be high. DAS has helped 1,248 customers during the last year and has won 92% of the appeals undertaken.

We have come to the end of the second year of our Big Lottery funding and have continued to achieve excellent results. through our manager, staff and volunteers at the DAS head and outreach offices.

We have continued to hold workshops as part of building capabilities and I would like to thank the staff, volunteers and trustees who took part in these.

I would also like to thank the MS Society, the Financial Inclusion and Advice Team (FIAS), Housing Options, CABs and many many more statutory and voluntary sector agencies without whom we would not be able to meet the needs of our local communities. And of course we are so grateful to our funders, including our customers who often donate to DAS.

I would also like to a include a special mention to Margaret Shaw, her support of DAS this year was greatly appreciated by everyone for all her time and hard work.

Robin Stroud and Grahame Tinnion have also given unstintingly of their time and effort to ensure the work of DAS continues, so special thanks to them as well.

Lastly I would like to thank all our trustees, staff, volunteers, funders and supporters in the local community who together make DAS such a trusted and expert service.

I have completed this report as Vice Chairman of the Trustees as we are actively seeking a new Chairperson to lead the organisation.

Manager's Report

Joe Crabbe, Lottery Grants Officer said:

"It is a testament to you, your staff and volunteers that you have overcome the hurdles you have faced to deliver" on the rural outreach project.

During 2019 we were able to achieve the outcomes we had said we would deliver during the second year of our successful bid for Lottery funding and to maintain our core service.

We have improved the skills of our volunteer advisers and are able to offer appointments in two weeks. Our paid staff have organised training and given encouragement and on going training - and we learn so much from our clients. We are working on reducing the time we take to answer client's messages and meeting the time limits for registering appeals for clients.

Thanks to our clients for responding to our surveys - we now know that we have helped lessen anxiety, and improve financial well being and reduce the feeling of being alone with problems.

We have been able to provide a service at the location of the client's choice. We are able to offer appointments in Saxmundham at The Old Police Station. We have a recruitment programme to recruit volunteers to increase this service, our home visiting service and essential administrative support at our office in Martlesham. We have a training programme in place which gives our volunteers confidence and transferable skills. Our volunteers report that working for DAS gives them satisfaction as they feel part of being included with a valuable service.

We have been able to give intensive support to people who were at crisis point because of lack of benefits to which they are entitled- their homes and health being at risk. We negotiate for immediate help and then help people acquire some of the skills and knowledge they need to avoid the situation in the future.

The support from IT and administrative staff and volunteers has been essential to help us keep improving the quality of service to our clients. The instant and positive response to our requests for help has meant an increase in the numbers of hours these volunteers give to DAS.

This year we have tried to diversify our income stream and the manager was involved in tendering for contracts to provide services. We have been successful with grant applications made by our volunteer fundraiser but it is our local support that has been essential to keep DAS funded.

Our thanks to Suffolk County Council, Suffolk Coastal District Council and Parish Councils and The Rope Trust who have recognized our valuable contribution to helping them provide services effectively and economically. Donations from clients and local supporters have meant that we were able to fund DAS this year with financial support from our reserves.

Robin Stroud and Grahame Tinnion have worked tirelessly this year to manage DAS, seeking expert help where needed. We have recruited two new Trustees who are committed to helping us in the challenging year ahead.

Treasurers Report

I present the statement of financial activities and balance sheet I have prepared for the year ending 31 December 2019.

The period has seen continued high activity and I have to report that we finished the year with a £10,595 surplus. We had an income of just under £154K and this has been achieved by the hard work in attracting donations, grants including the Big Lottery and fundraising. This leaves us with a final bank balance of £76,381. In line with our financial policies all of this is our reserves fund and includes £2,000 restricted funds.

During my time as treasurer I continue to be very impressed in the total efforts of the staff, committee and volunteers in the delivery of a quality service and the combined contribution to the financial aspect both visible and hidden.

As I have mentioned previously, the voluntary efforts in advisor work, administration, IT support, committee duties and fundraising have a tremendous hidden value. A conservative estimate of the total number of hours involved with this is some 60 hours a week. Therefore, over a year at say £26 an hour if they had to be paid for, these efforts have contributed a hidden income or saving on expenditure of over £80,000

All involved have to be congratulated and I would like to thank all those involved and extend special thanks to those that have assisted me directly with the accounts work over the year.



The total benefit awarded to clients as a result of our work this year was approximately £2,481,838 highlighting the essential need for our service in the East Suffolk Coastal area.


Enquiries by Town and Area

Disability Advice Service (East Suffolk) Helping people of all ages


DAS is an independent advice service and specialises in issues relating to disabled people and their carers. We are based in Martlesham Heath, but we offer free help and advice to people over much of the Suffolk Coastal district.

The 6,058 enquiries DAS has received this year have been varied and encompass the following categories.

- Welfare benefits and tax credits
- Advocacy and appeals
- Housing adaptations and special equipment
- Accessible transport, holidays and leisure activities
- Help with education and employment retention
- Home and respite care
- Access issues and disability discrimination
- Fundraising

Disability can affect anyone of any age and we do our best to advise and support people of all ages who require our help.
