



is an Associate Professor at the Department of Biomedical Sciences at the University of Padova, Italy. He started diving as a 23-year old medical student and immediately became interested in environmental physiology. In 1997, he obtained his medical school degree with a thesis on the functional evaluation of combat divers with the Italian Navy Special Forces. During a residency in underwater and hyperbaric medicine, he participated in a experimental high-altitude diving project, evaluating the different degrees of post-immersion platelet activation in an iced lake on Monte Bianco (Mont Blanc). He then spent several years in Syracuse, USA and worked on ischemiareperfusion (his PhD thesis) and human metabolism in extreme environments.

Back in Italy, in 2011 he founded the 'Hyperbaric School of Padua" at the University of Padova, offering a Level II course for diving and hyperbaric medicine and a High Course in technical and health management for hyperbaric technicians and nurses. Gerardo ("Dino") was elected Vice-President for UHMS from 2016-2018.

- The European Code of Good Practice for HBO Therapy (May 2004) represents a harmonised European view on safety in therapeutic hyperbaric facilities.
- It should be used as a reference document in European countries in need of Guidelines, Regulations, and Standards in hyperbaric medicine.

- The update is planned to be released in 2019/2020


Willingness to merge two entities in order to:

DECLARATION OF COOPERATION

We, the Presidents of the European Committee for Hyperbaric Medicine (ECHM) and the European Underwater and Baromedical Society (EUBS),

- whereas the ECHM is funded to study and define common indications for hyperbaric therapy, research and therapy
 protocols, common standards for therapeutics and technical procedures, equipment and personnel, cost-benefit
 and cost-effectiveness criteria, to act as representative body with European health authorities, and to promote
 cooperation among scientific organizations involved in Diving and Hyperbaric Medicine;
- whereas the EUBS is founded to advance the science of undersea medicine and related scientific disciplines, including hyperbaric medicine, work in compressed gas, and hyperoxia, and to assist in the promotion of research in these fields and in the publication of the results of such research, to provide a forum for professional scientific communication among individuals and groups involved in basic and applied studies concerned with medical life sciences and human factors aspects of the hyperbaric and hyperoxic environment, to aid in maintaining cooperation between life sciences and other disciplines concerned with extending hyperbaric activity, to work for improved safety of all operations by advice and educational semianrs on the medical and physiological hazards involved and to do all such other things as shall further the objectives of the society;
- Express our willingness to initiate the efforts in merging aims, activities, jobs and functions of both organizations in order to further stipulate the active involvement of all the Members of both organizations in Diving and Hyperbaric Medicine;
- Stress that it is of fundamental importance to guarantee that all aims of both organizations are upheld in full and further cooperation should be treated as the add-on value to enforce the position of Diving and Hyperbaric Medicine in Europe;
- Decide to prepare in the closest foreseeable future the agreed proposal on fundamental requirements to be fulfilled by both organizations to be presented to the Executive Committees for consideration;
- Agree that specific details of such cooperation and modifications of the Constitutions and By-laws of both
 organizations will be proceeded by the Joint Committee consisting of representatives delegated by the Executive
 Committees of both organizations;
- Accept that each President reserves the right to cancel the agreement before being presented to the General Assemblies of both organizations if the final proposal is not in concordance with the fundamental requirements as declared in points 2 and 3.

- <u>Continuity</u> of the name, history and tradition
- "<u>independency</u>" of the Committee treated as the <u>academic freedom in preparation of</u> <u>the documents</u>, standards, guidelines and recommendations
- Proper Committee <u>structure</u>: group of active medical practitioners in the field of <u>hyperbaric medicine</u> (minimum Level 2H). Chairman and General Secretary are elected by Societies GA same rules as the President.
- Efficient <u>internal</u> cooperation: <u>chairman of the Committee is included in the ExCom with</u> <u>the voting rights</u> and every Society member can participate in the Committee meeting (without voting rights)
- Efficient <u>external</u> cooperation (function of "federation" of the National Societies in the <u>Hyperbaric Medicine</u>)
- Efficient work: meeting of the Committee should be at least one per year, documents must be updated regularly, <u>workshops and Consensus Conferences on Practice in</u> <u>Hyperbaric Medicine</u> should be organized regularly by the Society, results should be reported to the GA and submitted for <u>publications</u>.
