# THE CLASSICAL ROAD SHOW DIRECTORS' REPORT FOR THE YEAR 2019

#### **Review of activities**

2019 was another successful year for The Classical Road Show (CRS), with good concert support from current and new sponsors. In March 2019, we promoted a performance of *Dreamtime Tales* by Richard Brown and Nigel Williams in Cadogan Hall. The Royal Philharmonic Orchestra (augmented by a didgeridoo) and two full houses of London Primary Schools were conducted by Ben Glassberg, who had just been appointed Principal Conductor of The Glyndebourne Tour – aged 25yrs! The narrators were Gavin Spokes and Annabelle Brown and the stage choir was St John's Walham Green Primary. The children sang aboriginal tales with enthusiasm and accuracy, delighting our sponsors M&G.

In October 2019, the CRS promoted a performance of *FIRE!*, the story of the Great Fire of London by Richard Brown, Sarah Harding & Fern Dickson. Over 1,300 children participated in song over the two shows in Milton Court, Barbican, accompanied by the London Mozart Players side-by-side with musicians from Guildhall School of Music, conducted by Hilary Davan Wetton, standing in for Benjamin Pope who was unwell. Samuel Pepys was played by Michael Dore and Jane, his maidservant, by Annabelle Brown: also on-stage was a strong choir from Edmund Waller Primary, who led the audience songs. The CRS is most grateful to The Mercers' Company for their sponsorship of this concert.

For the first time in some years, The CRS Croydon production scheduled for June 2019 had to be cancelled, due to the delayed re-opening of the Fairfield Halls, which were undergoing major refurbishment. Schools who had booked were sent, by request, the music and script for the *Dreamtime Tales* piece and were pleased to have this as their internal summer term project. Our next Croydon concert is booked there for June 2021.

**Conductors;** Hilary Davan Wetton, founder-conductor of CRS, continues as our inspirational Musical Director. We have welcomed three young conductors: Ben Glassberg (see 1<sup>st</sup> paragraph above), Benjamin Pope, who works extensively with the RPO and major orchestras world-wide, and Karin Hendrickson who conducts opera and orchestral concerts in the UK and abroad. Our conductors hold enjoyable workshops for teachers at the beginning of each concert term, to highlight tricky passages and to ensure their children learn to sing out with confidence at our concerts. In turn, we value teachers' suggestions on eg methodology and topics for our repertoire of pieces.

**Sponsors;** The CRS Directors pay tribute to M & G Investments for their sponsorship of our Cadogan Hall concerts from 2006 to 2019, all of which they attended. They are most grateful to The Mercers' Company for supporting many of our Barbican concerts. They thank other long-term benefactors: the HR Taylor Trust & Mott MacDonald for their support of Croydon concerts, The Joyce Grenfell Memorial Trust for their donations and Studio 108 for their gift of exceptional publicity design of concert materials. Our most welcome additional sponsors are The Alpha Plus Group (Cadogan concert 2020) and the Dean and Chapter of Westminster Abbey, who awarded an unrestricted grant.

**Vice Presidents:** We thank our VPs for their support and congratulate Prof Michael Mainelli, our most recently appointed Vice President, on his appointment this year as Aldermanic Sheriff of the City of London. We were delighted to welcome him to our City concert in October, resplendent in his robes and chain, the latter examined closely by many of the children as they left!

**Music Hubs**: The CRS thanks the many music hubs with which they work for their support and guidance over the year. We exchange information with 16 hubs and receive support from most, in particular from Southwark, Hackney, Croydon and the Triborough hubs, as well as our latest 'partner', Haringey Music Service.

**Front Row Club:** Hilary Davan Wetton visited music pupils at Marylebone School, to prepare them for intense listening (from their free, front row seats) at a concert including Mozart: *Coronation Mass* & Mendelssohn: *Violin Concerto in E minor*, soloist: Chloë Hanslip, in Cadogan Hall with the RPO and the City of London Choir, conducted by Hilary in November 2019. His workshops (one with the concert soprano), ensured familiarity with the piece and its inspiration.

**Results for the period:** Ticket income and concert costs were as budgeted. Future concerts may be delayed because of the Covid19 epidemic, but without affecting our reserves, since we have benefitted from pro bono concert management and administration since the Company's inception. We intend to appoint a General Manager when funds permit. We plan to provide schools with music projects in lieu of concerts and to add to our distinctive concert repertoire, composed for performance by professional orchestras (the RPO and the LMP) accompanying children 7-11yrs, who perform in song from their audience seats. Their important rapport continues to develop and the stage/audience divide is not perceptible.
