The management committee have complied with the duty in section 7 of the Charities Act 2011 to have due regard to public benefit guidance published by the Commission.

Aims and Organisation

The aims and objectives of the Epworth Choir are:

- The study and practice of choral music in order to foster the public knowledge and appreciation of such music by means of public performance, and
- To assist and further such charitable institutions and charitable purposes as the Committee shall from time to time determine.

The charity is based in Woking, operates principally in Surrey and has no direct links with any other charity. The charity is organised by unpaid voluntary staff. In execution of its aims and objects, the Epworth Choir pay professional soloists, orchestras, Musical Director and rehearsal accompanist.

Throughout the year, Choir members meet to study and practise a wide variety of choral music, which is then publicly staged to foster the public knowledge and appreciation of music whilst raising money for charitable causes.

The organisation of Choir activities is achieved through a management committee, assisted by Marketing and Music sub-committees. At the AGM on 9th October 2019 Sandra Bedford, Honorary Secretary, and Lynn Curtis, Treasurer, did not stand for re-election. All other officers and committee members were re-elected. Pam Curnock was elected unanimously as Honorary Secretary. Ali Conway was proposed to join the committee as Treasurer and was elected unanimously.

Review of activities and achievements

Chair's Report

Concerts

On November 11th 2018 some choir members joined the singing at the Remembrance Day Observance in Jubilee Square. This is always a moving experience and was especially poignant as it was the 100th anniversary of the end of the First World War.

On 24th November 2018 we finished the 60th anniversary celebrations and the started our 2018/2019 season with a performance of Mozart's Requiem at Guildford Cathedral where we were joined by Islington Choral Society and the Philharmonia Orchestra. The concert was extra special because we were also joined by Chloe Hanslip who played Barber's Adagio for Strings. The concert was very well attended and was held in aid of SSAFA, who support the armed Forces, in recognition of the 100th anniversary. I'm sure that everyone agrees it was a very memorable and enjoyable experience for everyone.

With limited rehearsal time, we held our annual Christmas concert on 10th December 2018 and were joined at Christ Church Woking by Greenfield School. The concert was well attended and supported SSAFA again.

On Saturday, 9th February 2019, we held a 'Come and Sing' which was Karl Jenkins The Armed Man, a Mass for Peace. This is now becoming a regular date in our spring calendar and was another successful and enjoyable day.

Our spring concert was held at Holy Trinity Church Guildford on the 6th April. The programme was a celebration of English traditional folk music and the second half was a performance of John Rutter's beautiful suite, The Sprig of Thyme. We were joined by a small orchestral group and a clarinet quartet also performed.

Another regular fixture in our annual calendar is our end of term concert which is more informal and an opportunity for friends and family to join us for tea and cake. This year it was held on Wednesday, 26th June, and the songs were all on the theme of travel. The closing collection was in aid of the choir.

On 31st July some of the choir joined Michael for a singing evening, this was well attended and very enjoyable.

Another busy year with a very varied programme.

Review of financial activities and affairs

The charity's activities are financed, in the main, by the sale of tickets to the general public. Choir members pay an annual subscription and provide their own music.

Dorothy Curtis Endowment and moneys received from the Deakin Charitable Trust fund

The value of the Dorothy Curtis endowment fund remains at £34,000, with all interest arising being utilised in meeting running costs during the year.

On the expiry date of the previous year's investment, £65,000 was reinvested in a new 1 Year Fixed Rate Saver account with Shawbrook Bank to achieve better interest rates (at 1.3%) than HSBC accounts offered. In July 2019 a further £20,000 was transferred into a different 1 Year account from Shawbrook Bank, paying interest at 1.4%. This Shawbrook account was recommended by the Charities Aid Foundation and the investment is covered by the Financial Services Compensation Scheme and the Financial Ombudsman Service.
