Objectives and Principal Activities

The charity's principal activity continued to be that of grant making to elderly and disabled gentlemen, in need or on low incomes, living in Lincolnshire. The scheme of the charity has recently been amended to include grant making to ladies also.

The trustees consider that the objectives stated above, as summarised from the governing document, satisfy the Charity Commission's guidance on being for the public benefit.

Achievements of Performance

During 2019 the trustees continued to support the recipients by making 29 grants of £162.50.

These were made bi-annually on the following dates - 6th April 2019 and 11th October 2019.

Financial Review

The charity continues to make improvements to the farm and to ensure any remedial work is completed, to enable the farm to continue to provide an income.

The charities policy on reserves is to maintain adequate funds to continue to make grants to the recipients, even in the event that rental income temporarily ceased.

**Independent Examiner's Report to the Trustees of
Edward Hunstone Charity**

I report on the accounts of the charity for the year ended 31 December 2019 set out on page 3.

Respective Responsibilities of Trustees and Independent Examiner
