Cromwell District Scout Council -Trustees Annual Report for the year ended 31 st December 2019

Once again 2019 saw the District membership numbers increase and we now have a total of 1,118 members of which 831 are young people supported by 287 Adults comprising of leaders and executive members. Of the 831 Young people we now have 59 explorers spread over the 3 units and 26 Young Leaders supporting 9 of the District Group's. Our 14 Group's have 265 Beavers, 285 Cubs & 196 Scouts

Our 3 Explorer units continue to have joint meetings and enjoy a range of activities and trips away

Also the Young Leaders continue to thrive and support 9 of the groups within District helping out with section meetings together with completion of their modules and gaining their belts and buckles

Beavers have been very active with 4 colonies joining the Cubs in their trip to Gilwell. 33 Beavers from 6 group's attended the District Beaver Sleep over at Copley, 94 Beavers from 9 groups took part in the fun day at Copley in July and most Beavers attended the sausage sizzle at Copley held over two evenings in September

Cubs have run two night hikes one in March and the other in October. 3 groups went to Gilwell in June. 84 Cubs from 6 group's attended the activity day at Copley and 96 Cubs from 10 group's attended the swimming event at the one leisure in St Ives in November

This year we have had two new ADC's appointed one for Beavers and one for Cubs and our thanks go for those who stepped forward to take on these two challenging roles

The District enjoyed another very good turnout for the St George's Day Event marching through St Ives for the renewal of promise ceremony held on Slepe Field

CMC has been active again this year in running the Big Rock trip which is always a very popular event together with hill walking weekends away to Cornel, Glenbrook & the Brecon Beacons

The District ran at Copley a skills day in May for the adults that was successful and it was hoped to repeat this event next year

Copley has had another very successful year with just short of 1,500 camp nights and 169 sleep over's bringing in over £10,000 in receipts. You will see from the accounts that the planned maintenance spend was just over £8,000 most of the costs incurred being for the new larger activity store and the testing and subsequent upgrading of the electrical system to the main building

To conclude I would just like to thank the DC, DDC, ADC's, District Leaders, ASU, Copley Maintenance Crew and Site Managers and all those that sit on the District Executive, Appointments committees and core organising teams for their contribution during the last 12 months. Without your support and continued commitment we would not be able to produce the District events for our young people

The District is a Trust established under its rules that are common to all Districts, and the Trustees are appointed in accordance with the Policy, Organisation & Rules of the Scout Association and The accounts have been drawn up on the receipts and payments basis that is consistent with the previous year and approved by the Trustees on the 17th February 2020 and signed on their behalf by the District Chair
