STRUCTURE GOVERNANCE AND MANAGEMENT

Governing Document

The charity is a charitable incorporated organisation ("CIO") governed by its constitution dated 24 August 2015, and granted charitable status by the Charity Commission on that date.

Appointment of Trustees

At each Annual General Meeting, one third of the trustees shall retire from office but will be eligible for reelection. The vacancies so arising may be filled by the decision of the members at the AGM. At the AGM held on 2nd September 2019, Roger Higson and Anthony Ogus retired. Roger Higson was re-elected to serve for a further three years. Anthony Ogus was re-elected to serve for a further three years but did not wish to continue in the role of treasurer. Judith Hooper and John Appleyard were elected to serve for a further three years, having previously been co-opted. John Appleyard was appointed treasurer to succeed Anthony Ogus.

OBJECTS & ACTIVITIES

The objects of the charity are:

- to promote, develop, and maintain appreciation of, the art of music in all its aspects by the presentation of
 public professional concerts and recitals, and by such other ways as the society through its committee
 shall determine from time to time.
- to advance musical education by the provision of free or subsidised concerts to minors and their families.

In furtherance of these objects, but not otherwise, the society provides six chamber concerts a year to its members and ticket purchasers. It not only engages experienced and acclaimed musicians but also encourages local and younger performers. Young people attend concerts at heavily discounted prices and children of school age attend free of charge.

Public Benefit

The six concerts in our season give the opportunity for the audience to experience high quality live chamber music locally in the inspiring setting of Ripon Cathedral.

For some people, this is a first time experience and even for seasoned concert goers there will be the opportunity to hear unfamiliar repertoire and new compositions.

In preparing this report, the trustees have had regard to the Charity Commission's guidance on public benefit.

ACHIEVEMENTS & PERFORMANCE

The season marked 25 years since the Society was founded. A very successful Jubilee dinner and musical entertainment (Haydn in London) by Anthony Ogus was held on July 1st at Ripon Spa Hotel to mark this achievement.

Six very well received concerts were given in the year under review. Because of restoration work, we were unable to hold any concerts in the quire of Ripon Cathedral. One was held in the nave, one in the crossing and the remainder in Holy Trinity Church. The latter proved popular with the audience and because of ongoing difficulty using Ripon Cathedral Quire, it has been decided that Holy Trinity Church becomes the Society's default venue for concerts in the future.

The Society completed its re-branding exercise. It now trades under the name Ripon Concerts, has a new logo and a new style and format for publicity material.

Average attendance at concerts was a pleasing 160. The society's membership is 151.

TRUSTEES' REPORT

The following concerts were held:

14th October 2019 - The Albion Quartet

The Jubilee season opened with a fine concert by this young string quartet with a growing international reputation for giving exciting concerts. They played Beethoven's epic String Quartet Op 130 with the Grosse Fugue preceded by two works by Czech composers Suk – Meditation on the old Czech hymn St Wenceslas, and Dvorak – String Quartet no 10 (Slavonic). The latter is full of melody and colour that speaks of nature, love and simple pleasures with lots of echoes of his Slavonic roots.

4th November 2019 - Paul Lewis (Piano)

The highlight of the season was a compelling piano recital by Paul Lewis CBE, a former artistic director of The Leeds International Piano Competition and one of the leading pianists of his generation. He played two huge works — Schubert's piano sonata no 18 and Beethoven's 33 Variations in C on a Waltz by Diabelli Op 120. This was a wonderful concert. Rarely had the audience heard such sensitive playing.

9th December 2019 - O Duo (Percussion)

For our December concert, which we try to make a bit more light-hearted and therefore of wider appeal, especially to young people, we were treated to a virtuoso display of percussion playing by O Duo. This was a concert of popular classics and accessible contemporary music played with huge dexterity on marimbas, vibraphone and a wide range of other percussion instruments.

13th January 2020 - The 10/6 chamber ensemble

This was to some degree an experimental concert to give a platform to a newly formed group of local musicians to play a programme put together by our concert organiser, Brian Kealy. The experiment worked well. A very good audience heard them play, under the direction of Jeremy Carnell, Bach's third and sixth Brandenburg concertos, followed by Hindemith's Trauermusik and Brahms Sextet in B. The concert was a success and warmly received.

10th February 2020 - The virtuoso violin

Every season we try and make room for a promising young performer at the start of their career. The violinist Emmanuel Bach, who won the string section of The Royal Overseas League music competition is one such.

Accompanied by South African born pianist Jenny Stern, he performed pieces by Mozart, Brahms, Britten, Tchaikovsky and Wieniawski. After an introspective first half, he played with more freedom and spontaneity in the second.

For this concert we had returned to Ripon Cathedral but in a new location in the crossing. This proved to be acoustically difficult especially with a storm raging outside and was not a success.

9th March 2020 - Life, Love and Longing: Songs by Schumann

The 2019/20 season concluded just before the coronavirus pandemic lock down with a concert devoted to lieder by Schumann, performed by baritone Ashley Riches accompanied by pianist Sholto Kynoch. An appreciative audience heard the two great emotionally charged song cycles Liederkries, and Dichterliebe together with Heine songs.

FINANCIAL REVIEW

Overview

Income has come from membership subscriptions, ticket sales for individual concerts, programme and refreshment sales and donations from individuals. Principal items of expenditure have been artists' fees, venue costs, piano hire and publicity material.

Our aim has always been to try to cover our operating costs with regular income from membership subscriptions, additional ticket sales at individual concerts and regular donations from members. This year we are again grateful for sponsorship by Maunby Investment Management and we have benefited from additional

sponsorship by Property Maintenance Yorkshire Ltd, a legacy of £5,000 from the estate of the late Brian Carroll and advertising in concert programmes. This has meant a year-end surplus of £1,553.

Historic donations by the Liz and Terry Brammall Foundation and the Mayor of Harrogate's Ball fund, have enabled us to continue to secure the future with an adequate operating reserve.

Donated Facilities and Services

The trustees are again very grateful to Maunby Investment Management Ltd in Ripon for waiving their fees for managing the charity's investments until they were realised and the cash deposited with The Hampshire Trust Bank.

Reserves Policy

Given that membership fees, ticket sales and donations from members do not cover the costs of concerts, the trustees consider that it is appropriate to hold sufficient reserves to underpin a complete season of concerts. Reserves at the year-end, excluding investments, were £23,040 (2019: £36,420) which is close to the target range.

FUTURE PLANS

The immediate future is very uncertain because of the Covid-19 pandemic, which has curtailed all public performances for the foreseeable future. We may radically have to re-think our modus operandi to be able to stage live music in the future to fulfil our principal objectives as outlined above and:

- host well known experienced performers to enhance our reputation;
- provide a platform for musicians at the start of their careers;
- promote a balance of both well known and less familiar works; and
- encourage attendance at our concerts by young people.

1. Basis of Preparation

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities Act 2011.

2. Fund Accounting

- (a) Unrestricted funds are those that can be expended at the discretion of the trustees in the furtherance of the objects of the charity.
- (b) Restricted funds are those that may only be used for specific purposes. Restrictions arise when specified by the donor, or when funds are raised for specific purposes.

Currently all of the charity's funds are unrestricted.

3. Taxation

- (a) The charity is not liable to corporation tax or capital gains tax on its charitable activities.
- (b) The charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.

4. Trustee remuneration

- (a) No remuneration was paid to trustees during the year or in the previous year.
- (b) The charity's insurance policy includes trustee indemnity insurance cover for all of its trustees.
