# **SOME PARISH DETAILS**

**Population**: 10,000 approx. (This figure gives some idea of the 'pastoral area' for our church, rather than exact count of the population).


**Location**: North East area of Luton, at the boundary with Herts. The parish includes the wards of Stopsley and Putteridge. The busy A505 from Luton to Hitchin runs through the parish and separates the church geographically from much of the rest of the parish.

**Type[s] of housing**: Mainly owner occupied, with some rented accommodation, and pockets of housing association or council property.

**Community facilities**: Two high schools, two primary schools, one special needs school, and a large sports complex with Olympic swimming and diving facilities.

**History of the community:** In 1862, when the church was built, Stopsley was a village. Over the years since then Luton has gradually swallowed it up and it is now a suburb of the town. Some of the major employers of people in the community over the past 100 years have closed or declined in size, but employment remains fairly high. The airport and the car industry are major employers.

**Parish boundaries:** No longer quite the same natural cohesive community that it once was but boundaries mainly make sense except confusing boundary on Ramridge Estate with St. Francis.



# PARTNERSHIP IN WORSHIP, MISSION & MINISTRY

We are active participants in the Luton Deanery in working together in mission to our town of Luton.

20 years ago we planted Christchurch, Bushmead, a thriving church largely within what was the much larger former parish of Stopsley.

Other Christian Churches: we have a good friendly relationship with Stopsley Baptist Church and Ramridge Baptist Church with whom we have co-operated on various events and projects. SBC has a much bigger congregation, and with its better facilities and style of worship it attracts younger people and people from a wider area. We have different styles of worship but complement one another in our evangelistic task. We have friendly relations with Sacred Heart (RC). Ministers are involved in local and town wide fraternals, and we also participate in a local evangelical hub for prayer and mission, and a similar but larger grouping for the whole town.

# **Committees**

Standing Committee

The Standing Committee is the only committee required by law, and is our only official committee. It has power to transact the business of the P.C.C between its meetings, subject to any directions given by the council. We also have a number of 'Action Church Teams' (ACTs) that organise activities, or discuss matters, as directed by the P.C.C. and Vicar.

# **Electoral Roll**

This year all Church of England parishes are required to totally renew their Electoral Roll - existing members required to reapply, as well as new members welcome to apply. We attempted to contact all existing members, especially those living in the parish, and those who regularly attend worship. We also invited current worshippers not on the old roll to apply for the new. There are now 149 parishioners on the Church Electoral Roll. This is -1 from the previous year's AGM Electoral Roll.

# Review of the Year.

During the last year we continued enthusiastically with God's help our task of **seeking to share God's love with all.** 

We continued our 'Rolling Worship' service pattern which aims to provide a wide range of service styles, and enables different congregations meeting together as one Church. It is encouraging to see each element of the pattern developing new life. We also value the midweek service, which continues to be well supported. During the year the PCC decided that the evening service was no longer sustainable as the congregation had grown so small. We have, however, continued with a monthly 'Prayer Service' and termly Choral Evensongs. We sought to hold accessible services appropriate to different groups, blending the best of traditional and more informal styles. Much time and effort went into trying to prepare inspirational biblically based preaching.

We presently have two regular 'homegroups', one for women, and these are developing well in nurturing fellowship and spiritual growth. We consider this to be a significant part of our church life and very important for future growth, and we wish to grow other groups in coming years. The Tent Project continues to meet with high numbers of attendees appreciating their weekly gathering.

It has been an exciting and encouraging year amongst children and young people. The Sunday Club has excitingly grown in numbers and the children eagerly show off their work at the 10am service. A team led by Sara Sammons, Karen Ritchie and Ruth Marshall leads the Sunday Club programme which is enjoyable and helpful for members. We continue to appreciate our strong links with Uniformed Youth organisations. However, the Scouts and Cubs have now decided not to regularly attend the Parade Services. However, the Guides continue to do so, although numbers are not what they used to be. We started in 2018 to hold 'After Parade Parties' for the young people (not just from the uniformed organisations) which includes games, activities, food and some appropriate Christian input. These have been well attended, and included a bonfire event at Haverings. This gathering has now adopted a name, suggested by David Ritchie, one of our young people, after a poll amongst the participants. The new name is STUFF - St Thomas' Unbelievably Fabulous Fun! We hope STUFF will grow from strength to strength, meeting regularly not just after Parades - in fact that it will indeed be hot STUFF!

We continue to seek to give a warm welcome to visitors to the Church. Much effort and preparation is given to provide services that develop further an atmosphere of welcome. We particularly organised special events to welcome people over Christmas, Easter, Remembrance and throughout the year. This year we also held a memorable and well-attended Wedding Celebration for those married, whether this happened at St Ts or elsewhere. Participants varied from those freshly married (or soon to be!), to those married for many decades (65 was the longest!), and also those celebrating and also remembering

their marriage where their spouse had died.

Our Lunch Club thrived with fish and chip and other lunches. We have enjoyed social activities that enhance our welcome to people. The Pilgrimage to St Albans was another enjoyable activity, enjoyed by a small group of 'pilgrims'. We also held successful monthly Coffee Mornings. A course on Christian basics, "Alpha - Christianity Explored" is periodically held for people within and without the Church family. In 2018 this led to 5 church members being confirmed by the Bishop of Bedford, and another 5 affirming their baptismal faith, all in a lovely service at St Thomas's, along with some other candidates from other parishes.

Baptism policy for children offers a choice between a 'Thanksgiving Service' to families who want to have a celebration service in Church but who do not intend coming to Church regularly, and Baptism for those families willing to undertake preparation to make the commitment involved in that service. Thanksgivings are generally held after the Informal Service and Baptisms are held during the main Sunday Service. We also provide an informal detailed preparation for weddings. The weddings themselves appeared to be thoroughly enjoyed by the couples and their guests. We believe that these continue to be an important opportunity to provide a good witness for the Church, although along with a national trend the number of weddings in church has greatly decreased in recent years.

The choir continues to help lead the worship at the weekly 10am Family Communion and other services. Thanks are due to John Alexander, our Director of Music, who leads the Choir and plays our church organs. Our Music Group continues to creatively lead our Informal Service, and this is much appreciated by those who attend that service. Thanks are due to David Newbound who leads the meditation group, which is much appreciated by those who attend, and which enhances our spiritual life. We are grateful to all who have helped with the maintenance of Church and Churchyard, especially Ian Clitheroe, and those who clean our Church, and to the flower arrangers. Their hard work enhances our worship.

The Pastoral Care Team continued to meet regularly to oversee some of the pastoral needs in the Church, and have done marvellous work, which has included visiting, delivering cards and arranging lifts. Parishioners are asked to inform the Parish Office if visits or help is needed. We are very fortunate that David Newbound is 'released' (not least by the sacrificial support of his wife Debbie) into his ministry as Pastoral Worker. This has enabled the Church to greatly enhance the pastoral ministry and support that the Church offers. During 2018 Debbie has trained as a Parish Nurse and preparation has been made for this new ministry to begin in May 2019.

The witness of individuals in their community, work and leisure environments remain vital for our evangelistic mission. The Vicar is involved in ministry to the workplace with chaplaincy work at Vauxhall Motors. David Newbound has been chaplain at NOAH centre of

the homeless and at the coffee shop in the village. Steve Dolby is also involved in chaplaincy at Asda. Many of our members help serve at the NOAH 'Soup Kitchen' for the homeless. We have also been keen to support the World-wide Church, particularly focussed through our links with 'Hands of Mercy' in the Philippines. Our Church has been open for prayer and visitors during weekday mornings. We served the community in caring for bereaved people at the time of funerals and welcome them to an annual Commemoration service, as well as other services.

The Parish Office continues to handle much of the administrative work of the Church. We are grateful for the service of Linda Clitheroe, our Administrator and the work she does in the Office. This work is now shared with Deborah Bachini, who has settled well into the Office work. Linda has now decided to step down from her role, after 18 years! We are very grateful for the hard work she has given us. Deborah will be increasing her hours to fill the gap. Communications within the Church are good through a new website, advertising our events, and a weekly newssheet, the details of which are also projected onto the Church screen. Communications with the wider parish through our magazine is greatly appreciated by large numbers inside and outside of the Church family. Our thanks to the editorial team and to Tony Clitheroe for all their hard work in producing our magazine. We also contact interested people through emails and WhatsApp messages advertising services and events, and have a social network presence on Twitter and Facebook.

We have continued to run our Stewardship Scheme. We are grateful to everyone who responded to stewardship initiatives, and all the Finance Team, our Treasurer, Neil Rolls (and up to April 2018 John Kingham), and our Stewardship Secretary, Les Sims, and the skilled help of Sarah Vyvyan. Full details of the finances are provided in the relevant reports and the presentation at the AGM.

We wish to thank many, both Church members and others, who have contributed to the ongoing work of the Church in the last year. Gratitude is due to all involved in leading and preaching at services, especially Ruth Barr, our Curate, for this and all her much appreciated ministry in the church and wider parish. Many thanks are also due to Rosemary Stipta and John Pinnock for all their work with the audio and visual enhancement at our services. We are very thankful for the significant and important contribution of our Administrators, Linda Clitheroe and Deborah Bachini. We are also very appreciative of the sacrificial work of our Churchwardens, Steve and Ian. The PCC wishes to thank all those who contributed to the services: as sanctuary assistants, sidesmen/women, readers and intercessors, not forgetting all who provided welcome refreshments after the morning service and on other important occasions, and also to those who have helped provide such excellent food at Lunch Club and at other events. We are also grateful for the group of volunteers who have helped at Coffee Mornings and in many other ways as well.

We look forward to the future with confident hope in God as we share His love together.

#### Confessions of a curate 2018-2019 Rev Ruth Barr

This has been another busy year and my time with St Thomas's seems to fly by. Each different Church season brings new challenges and joys.

From Pentecost, David suggested that I become the Acting Vicar, so that I could gain experience of leading the church not only on Sundays but with the everyday parish affairs. This included more administrative roles, which is why we have had a different weekly newsletter format, which on the whole has been warmly received. Those on the church rota list had to be very patient though, as I struggled with the finalising of the monthly rota and sent out many erroneous copies before eventually getting it right.

May 2018 was the Royal Wedding and the Cup Final. As part of the Fresh Mission, alongside a number of other churches across Luton, over 600 pieces of wedding cake were handed out to people in the village to bless them, before coming back to the church to share a cream tea and to watch the Wedding together.

We had a number of weddings ourselves this year which are always such a joy. On the Saturday closest to Valentine's Day, we held a wedding blessing service which was attended by approximately 30 couples, five children and about 5 or 6 people who were on their own that day for various reasons and who wanted to honour the marriages they had had. It was a lot of work but was great fun and the sanctuary looked beautiful, lit up by our new LED lights, loads of candles and highlighting the number of wedding photos displayed on the communion table.

Love it or loathe it, I encouraged the PCC to agree to the Electronic Card Reader that we now have passed around each week on the stylish pink clipboard. For those who rarely carry cash, this is a way to enable more people to be part of the giving community at St Thomas's. If everyone who has a contactless card tapped it for just £1each week, that would be an extra £100 or so coming into the church. Give it a go!

At Christmas, I was officially signed off by the Diocesan Bishop. This means that the St Albans Diocese feel that I have fulfilled enough in my training here to be allowed to become the vicar/rector/priest in my own church, or as part of a team ministry. From January I have been allowed to start the application process to find such a church, but regardless of the outcome of the selection and interview process, I will be staying at St Thomas's until at least the beginning of July 2019, which is three years after joining you.

Thank-you for the words of encouragement that you share with me; the texts, emails, WhatsApp messages, and Facebook posts as we continue this journey together and as the song says: "Oh, Dear Lord Three things I pray, To see thee more clearly, Love thee more dearly, Follow thee more nearly, Day by day"

Sunday club over the last year has gone from strength to strength. We are now regularly having 12 – 15 children attend with the potential for more than 20 if all our regular children all came on the same day. It is so rewarding to see the children grow and engage in the activities. We have introduced the concept of our church youth growing as a family and came together outside of church on 2 outings last year. We visited the farm and a Christmas pantomime, both of which were enjoyed by all.

We have an exciting year ahead. We would like to welcome Stewart to the team who has recently joined us as an assistant. Stewart and Ian are concentrating on providing activities for the older children and we are getting some really positive feedback.

Our Sunday Club has grown and this was a very important step forward for us but more importantly for the children as their journey continues within the church family.

We are in a position now that the range of ages within the group is significant with the older children up at 14 and our younger children as young as a year. The necessity to ensure that we are not failing the children at either end of the scale is our biggest challenge and with Stewart and Ian's help we are moving forward but we really do need another helper each week. If anybody would consider joining us for one Sunday a month this would be a big help.

Lastly we would like to thank the whole team, without each and every one of you we wouldn't have a Sunday club and I think you will all agree that Sundays just wouldn't be the same now without our St Thomas youth family.

# Safeguarding

This past year we have been active in relation to training for Safeguarding.

Something recently introduced is that <u>all PCC members</u> must be cleared <u>before</u> they can take up their role on PCC.

Those already cleared working within the Church will simply continue with their work.

We strive to conform to all that is required of us and believe that we are achieving this goal.

We thank you for your support and would ask that if anyone notices anything which causes concern then please mention it to either of us as it <u>might</u> just be very important. We are

very happy to be contacted and consulted about anything and can assure you all these conversations will be in the strictest confidence.

# **Home Groups**

Our Home Group meets weekly on a Thursday during term time. We meet in our home and have a regular membership of six people. Meetings last about 90 minutes starting at 8pm with refreshments.

We look at various topics and issues surrounding the Christian faith all of which are bible based. We usually follow the sermon series and at Lent a specific bible based lent course to help us all grow our understanding and knowledge of the bible and issues facing Christians. We are a very friendly and welcoming group and get on well at our meetings, at church and on other occasions. Often we start and end a term with a social event especially at Christmas.

# Noah Soup Kitchen

We have a group of volunteers from St. Thomas' and surrounding churches who help at Noah Homeless Shelter on a Monday evening. They attend one Monday a month, on a rota basis, and support the Soup Kitchen. This involves warming pre-made soup and preparing sandwiches to serve alongside crisps, biscuits, tea and coffee. The volunteers arrive at 6.30pm and are usually cleared up by 8pm.

The Soup Kitchen opened in September 2010 and was only supposed to run for six months. It is however still going strong every night of the week. Without the volunteers providing this service, many homeless people in the town would have no food from lunchtime that day until breakfast the following morning.

I would like to thank all those from St. Thomas' who volunteer on a regular basis, many of whom bake or take in additional food for the homeless. Those who help at the Soup Kitchen really find it rewarding to help the service users, who always show their appreciation.

We are simply not generating enough income on a regular basis to cover our monthly costs which we have pared down almost to the bone. This has brought into question whether or not we can continue to share our God given wealth with those who are much less fortunate than we are. At the moment we are committed to give 10% of our income to a small number of very worthy charities but inevitably we may have to reconsider this if things don't get better. It is our firm belief that, within the body of St Thomas', God has provided us sufficient resources financially and in human skills and talents to not only make ends meet but to create an abundance of material and spiritual wealth.

Part of Discipleship is accepting that, as all things come from God and that we are only returning to Him, that which He has given us in the first place, we must seek His will for every part of our lives and trust and obey Him, even if it 'hurts'. If we embrace this, then He will shower us with innumerable blessings, riches and good gifts. If we don't, then we shall be facing yet another year of agonising decisions in connection with our finances and having to cope with the consequences of our actions.

First impressions mean a great deal and, for most people, the first person they see on a Sunday is a sides-person. So, well done to all.

Very sadly, Steve Dolby is, after several years of dedicated service as a church warden, stepping down from the role. We all owe him (and of course his lovely wife Ann) a huge

debt of gratitude for the incredible impact he has made on the life and people of St Thomas'. Steve does not plan to go anywhere but, in fact, continue pursuing a number of spiritual and theological activities and we wish him and Ann well in their continuing journey of faith and service to God. Thank you Steve.

# Stewardship Report – YEAR 2018

Thank you to everyone who has faithfully committed to supporting the church this financial year (2018). The "Gift Day" appeal at the end of November raised £5962.00 and resulted in a final figure of £7171.38 after taking gift aid into consideration. As you can appreciate, with increased running costs year on year [together with unforeseen building maintenance] regular stewardship giving and "Gift Day" donations are more important than ever. However, stewardship is not only about money, it is also about giving time and practical help to St. Thomas's Church.

At 31<sup>st</sup> December, 2018 there were 89 members (couples counted as one) in the Scheme. This is a net reduction of 7 members from the previous year. However, there has been only a small reduction in planned giving. As we press on into 2019 there is a continuous challenge to meet the Church's running costs and the Parish Share.

With our Vicar's and the PCC's blessing, Ruth, our Curate, introduced a card payment scheme in December. It is aimed at those who do not carry cash and enable them to contribute to St. Thomas's work within the church and the parish. It is still in its infancy, but it is becoming a regular item at our services. Ruth has informed me that over £260.00 was donated by this method in December [2018]. A splendid achievement considering this is money that would not necessarily have been collected through the plate offerings.

In terms of giving your time and practical help to St. Thomas's Church there is a need for Sunday Club helpers, cleaners, litter pickers and people to carry out odd jobs, etc. The list is endless. If you are in a position to help please talk to the Churchwardens or the staff in the Parish Office.

Finally, I would ask that you take this opportunity to pray and reflect on your giving. If you would like to join the Stewardship Scheme and make regular donations please ask me, the Treasurer or the Churchwardens for details.

# **Deanery Synod Report**

The Luton Deanery Synod usually meets four times a year and meetings are held in a weekday evening, usually in February, June, September and November. The Synod meets in a different Church or hall for each meeting. Meetings start with refreshments and allow a welcome chance to meet up or make new friendships with other Synod members. Luton Deanery Synod is made up of two groups. The groups are called The House of Clergy (the licensed clergy of the Deanery) and the House of Laity (Church members who are elected by each Church and normally serve, initially, for three years).

The House of Clergy is Chaired by the Area Dean who is appointed by the Bishop, after consultation with the Clergy of the Deanery, for a term of five years.

The person who chairs the House of Laity is elected by the lay members at the beginning of each three year term.

The Synod elects its own Secretary and Treasurer and such Committees as required. Luton Deanery has a Standing Committee and a Mission and Pastoral Committee.

During a term of office members of the Deanery Synod may be called upon to vote in the five-yearly General Synod elections. Members vote thoughtfully and prayerfully, knowing that the consequences of decisions made at the General Synod are felt by diocese, deanery and parish.

In June 2013 the Deanery Synod agreed that its aims and values would be

- To emphasise mission rather than maintenance in its outlook and planning
- To train, equip and empower laity to be active in mission in whatever their context.
- To affirm existing expressions of Church and also support and resource new expressions of Church.
- To be realistic, practical and creative in identifying and using our resources of money, buildings, paid workers and volunteers.
- To be willing to take risks and learn from our mistakes as we do our best to follow lesus

God's love and care for his people, for Society, and for creation needs to be expressed by our words and our deeds.

Parishes are finding great value in sharing best practices, working together, training and studying together, sharing resources and caring together.

The word "Synod" comes from two Greek words meaning "the way" and "together". It describes a partnership of Church members, bishops, clergy and lay people.

Deanery Synod members were thanked for all of their inputs recently to produce the Deanery Review and MAP which were presented to Diocesan Mission & Pastoral Committee last December. The presentation had been extremely well received and we were commended on the way it told the story of progress over recent years, and all the information created a "brilliant baseline" to measure our development in the future. The presentation slides and context document will be made available for reps to take back to their PCCs.

# St Thomas' Church Treasurer's Annual Report Year ended 31st December 2018

Once again this has been a challenging financial year for our Church. Our total income increased by less than 1% from 2017 mainly due to lower donations for the repair of the building offsetting increased income elsewhere. Excluding the impact of these donations, other income rose by nearly 5%.

Total expenditure was slightly increased from last year, despite a £13,978 reduction in maintenance costs. During the year the heating system was repaired at a cost of £7,838, and we recommenced our customary tithe to charities.

Unfortunately as a result of this, in order to balance our income and expenditure, we underpaid our Parish Share by £19,383 making a combined total underpayment to the Diocese for 2017 and 2018 of £39,383.

By utilising the £7,400 of funds previously set aside for the heating system, our General Account has returned to surplus. We are also fortunate to still have significant Reserves in the form of the Legacy Funds that have accumulated over recent years. These Legacy Funds are 'Unrestricted' so they are available in case of for any other major repair work that may be required.

I am sure that 2019 will again be a challenging year. The Parish Share has further increased by £2,541 to £69,182 and with the age of the building it is unlikely that we will not incur some level of expenditure to maintain it in a good condition.

Finally, I would like to take this opportunity to express thanks to the many people who help with the handling of the Church Cash and Accounting:

the Sidepersons who count and record the Collections at each Service;

the Monday Banking Team led by David White;
Sarah Vyvyan who operates the Church PAYE scheme; and
John Kingham, who despite stepping down from the role of Treasurer has been very supportive in this handover year.

We are also appreciative of the fact that Godfrey Laws, who carry out the Independent Examination of our Accounts, do so at a concessionary fee.

# 2018.7 Vicar's Report

The Vicar commented that the Council were doing a good job on churchyard grass and had repaired a section of the wall. He also thanked John Pinnock and team for putting in the new screen so that the Pulpit was now back in use.

#### 2018.16 Administration Matters

The Vicar thanked Linda Clitheroe and Deborah Bachini. He also mentioned the data protection letter and form, urging people to complete and return them as soon as possible.

# 2018.17 Finance Matters including (a) Election of Independent Examiner; (b) Financial Report and (c) Stewardship

- a) Election of Independent Examiner it was proposed by the PCC that Godfrey Laws should be elected as Independent Examiners. This was now proposed by Steve Dolby, seconded by Rosemary Stipta and supported unanimously.
- b) Financial Report John Kingham presented a slide show in support of this. He said the Legacy Funds amounted to just over £20,000 including £5,000 from Bryan Sexton's estate. John thanked everyone for their help and support as he now stepped down from the role of Treasurer after over 50 years. He said that Neil Rolls had agreed to take over as Treasurer and this was supported by the

PCC. Les Sims asked about the restricted funds for heating – John Kingham said that £1,150 was restricted but £6,250 was not restricted so could be used elsewhere. Ian Marshall commented that heating costs could potentially be less, so presumably the donor would be consulted if not all the money was used and John Kingham agreed this should happen. David Alexander commented that the intention was to use the money on heating. David Alexander asked for a proposer to adopt the accounts – Les Sims proposed, Neil Rolls seconded and it was agreed unanimously. David Alexander, on behalf of everyone, said a big thank you to John Kingham, not just for this year, but for the last 50 years and more. A gift was presented to John and flowers to Judi Kingham.

c) Stewardship – Les Sims commented that although donors had increased, we had lost some very generous donors and were £3,500 down. He urged all to consider their giving and try to increase. He also wants to try to persuade those still on the Stewardship Scheme to go on the Parish Giving Scheme as this would help the Treasurer. Les commented that John Kingham had said he (Les) could not go until John Kingham retired, so Les was now giving notice!!!!

# 2018.18 Partnership etc

(St Thomas's, St Francis, St Anne's and St Christopher's). Steve Dolby commented on Deanery Synod and said that Rev Jan McKenzie had now moved on and that Rev Joe Pienaar is now the new Area Dean.

# 2018.19 Election of PCC and Deanery Synod

The Vicar said that the Deanery Synod representatives were one person down as we could have 3 people but only have 2 – if anyone would like to stand, speak to David A or Steve.

# Election of PCC:

John Kingham needs a year off PCC before he is eligible for election again.

John Alexander – as Director of Music is able to continue.

John Barr – has only served one year so is able to be re-elected.

Sara Hillyard and David Stipta stood down.

We have: 4 PCC places for 3 years – until 2021

1 PCC place for 2 years – until 2020

1 PCC place for 1 year – until 2019

# 2018.21 Any Other Business

- a) Steve thanked all for coming; he thanks John Barr for supporting Ruth and presented him with chocolates. He also thanked Jane Alexander and presented flowers for her to David; he also thanked Ruth Barr and presented her with flowers.
- b) Fabric Les Sims asked about the guttering above the Vicar's Vestry and the Vicar said that PCC were aware of this and that a builder would be fixing it soon. Les also mentioned that now that the Pulpit is back in action it isn't possible to hide!!! He also wondered if it would be appropriate to remind people to return bibles at the end of the services. Finally, he wondered about the possibility of handing out the news sheets on exit as lots are currently left in the pews. Karen Ritchie commented that it is nice to look at the notices whilst they are being mentioned in the services.
- c) Ruth Marshall asked whether the news sheet would be going on the new website and John Pinnock said it would, along with a facility to email it.

# 1. Accounting Policies

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 together with applicable accounting standards and the Charities SORP.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value.

#### **Funds**

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted.

The accounts include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body nor those that are informal gatherings of Church members.

# **Incoming Resources**

# Voluntary income and capital sources

Collections are recognised when received by or on behalf of the PCC.

Planned giving receivable under covenant is recognised only when received.

Income tax recoverable on covenants or gift aid donations is recognised when the income is recognised.

Grants and legacies to the PCC are accounted for as soon as the PCC is notified of its legal entitlement and the amount due,

### Income from investments

Interest is accounted for when received.

# **Fixed Assets**

# Consecrated land and buildings and movable church furnishings

Consecrated and beneficed property is excluded from the accounts by s.96 (2)(a) of the Charities Act 1993.

No value is placed on movable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal since the PCC considers this to be inalienable property.

Office Equipment and sound equipment is depreciated on the straight line basis at a rate of 33.3% per annum.
