## Trustees' Report - Mission and Activities

The Trustees present their report and accounts for the year ended 31 December 2019. Breadline is a Christian charity constituted as a company limited by guarantee, incorporated on 16 January 1997, and is therefore governed by its Memorandum and Articles of Association. The Trustees meet regularly to manage its affairs. The day-to-day administration and liaison with project partners is carried out by the Executive Director and Assistant Director.

### Our Objective and Mission

Our objective is to help to relieve poverty in Eastern Europe. Our particular mission is in the Republic of Moldova where we give support to local churches and charities that are committed to serving the poor and disadvantaged in their communities. We work alongside Christians as they seek to embody the life of Jesus Christ in their local communities through word and action.

### Our Aims

- **Sustainability** - To help people to escape the poverty trap, discover their full potential and live sustainable lives.



Above: the cheese making project in Dancu continues to expand. In 2019 Breadline purchased a much needed refrigerated van to enable them to deliver the cheese throughout the year without it losing any quality due to the intense summer heat.

- **Partnerships** - To establish partnerships with Christians and local churches to enable them to develop ongoing community projects and ministries.
- **Links** - To connect churches and charities in the West with churches and charities in Moldova.
- **Unconditional support** - As a Christian charity, to work unconditionally with the poor as we seek to demonstrate, through word and action, God's love for all people. We respect the right of individuals to pursue their own beliefs and never press our faith on those we are working with.

## Key Goals

- **Facilitate** - Sustainable community development initiatives.
- **Promote 'children at risk' education and prevention of trafficking** - Through partner projects such as children's day centres, shelter homes and education on a range of topics including health, inclusion, nutrition, relationships, sex education, people trafficking and lifestyle.
- **Job creation** - Income generation.
- **Train** - Equip members of the local communities with essential skills.
- **Advocacy and support** - For those who cannot speak for themselves.
- **Build networks** - Between people, churches and organisations in Moldova and the West.
- **Capacity building** - to help our partner churches and charities in Moldova to grow into sustainable organisations which can thrive independently without relying on Western donors. Breadline does this by supporting training in project cycle management, governance, fundraising and publicity, and organisational development.

## Key Values

- **Unconditional** - Support offered regardless of religion, gender, skin colour and ethnic origin.
- **Participative** - Involvement of all stakeholders.
- **Relevant** - Appropriate interventions that demonstrate respect for rights and choices.
- **Avoiding dependency** - Emphasis on achieving ownership, empowerment and sustainability.
- **Friendship** - Relationships modelled on friendship not paternalism.
- **People centred** - Transformation through people-centred approach to change: 'process not package'

## Overview of Developments, Activities and Achievements

In 2019 our church and charity partners in Moldova continued to embrace ministries across the full spectrum of age groups including children at risk, the elderly and people with disabilities and additional needs. Supported activities included - the provision of a day centre for children with disabilities, summer camps for children at risk, residential camps for children with disabilities and their families and adults with disabilities, projects aimed at reducing the risk for vulnerable girls from trafficking, supporting disadvantaged young people through higher education, providing specialist therapy for people with disabilities, and training on inclusion for people with additional needs for churches, social workers and charities. We also support farmer self-sufficiency projects, the coordination of transport and facilitating delivery of over 25,000kg of material aid from supporters and UK partners to beneficiaries, welfare support for families and the elderly at risk including emergency wood for heating, winter emergency food supplies and support for medical costs and clothing, evangelical programmes, a mobile training team to train a core of 33 churches, financial support of church leaders and their families and a mobile medical clinics to remote rural communities,



**UK Partners and Networking** - Existing partnerships with a number of UK charities, including Medical Missionary News and Moldova Mission, continued to develop. We were delighted to have several opportunities to work together on the ground in support of our partners in Moldova. We are also very grateful for the continuing advice and support we have received from Christian farmers and other members of the community

in Northern Ireland, who play a key role in the development of the Tabita agricultural project we support in Dancu, western Moldova.

**USA Partners** - In 2019 Breadline continued to work closely with our USA charity partners Globalway and AGConnect Ministries to raise funds and provide advice towards the development of the dairy, cheese and horticultural businesses belonging to our partner Tabita in Dancu, Moldova.

**Field** - Between them Executive Director Brian Pile and Assistant Director Di Acaster made 5 visits to Moldova in 2019, spending time with several partners teaching, researching case studies, analysing community needs, reporting, monitoring and evaluating projects and facilitating ministry capacity building. Breadline accountant, Rachel Samways, accompanied Brian on one of his trips, and chairman, Ian Hames, led a team from Christ the King Church in Kettering to volunteer at a summer camp for children with disabilities and their families run by our partner, Moldova Charity Mission,

**UK** - Brian Pile and Di Acaster gave presentations on the work of Breadline to churches and small groups across the UK. They also advised churches and missionaries in developing partnerships with Moldovan charities and churches.

## Summary of Partner Supported Activities in Moldova

- **Building Sustainable Livelihoods** - In 2019 our partners continued to help others in their communities to build sustainable livelihoods through a range of small, low-cost projects that in recent years have transformed the lives of hundreds of people and their families. Projects we supported included:

- **Dancu Church Tabita Agricultural Association** - 150 farmers received mechanisation support to farm their land more efficiently, which also resulted in higher

The farmers' crops were stored in Tabita's community barn. Support for the horticultural project enabled some produce to be grown for sale at the market, and some to support the feeding program for the elderly, making these projects more cost-effective to run.



Above: there is 80% unemployment in rural areas like Dancu. In 2019, Tabita was able to provide vital work for 29 staff and 50 seasonal workers via the Horticultural Project.

– **Dancu Tabita Cheese Project** - this project has expanded considerably during the year, producing a total of 8,792kg cheese and attracting 200 tourists from other parts of Moldova to the factory to watch the cheese being made and enjoy a lunch of freshly made bread, cheese and soup. Breadline's support included the refrigerated van already mentioned. In addition to their own shop in Dancu, they now supply 25 shops, deliver on-line orders and attend food exhibitions in Moldova and Romania.

– **Dancu Tabita Dairy Project** - we continue to facilitate the development of the dairy and have purchased 8 replacement dairy cows to improve the quality of the herd, funded the purchase of high quality feed and new equipment for the dairy, and obtained specialist advice.

– **Dancu Tabita bakery** - we support the development of the bakery which produces bread for several welfare projects that the church supports. These include a feeding program for 60 elderly people three times a week, meals for a number of weekly children's groups delivered at the community centre, church community events and prison outreach. The bakery also plays an important role in the development of the agricultural-tourism mentioned above (see photo below).



– **Education** - 22 young people, many of whom were at risk of being trafficked, were helped through vocational and higher education courses - for example, teaching, dressmaking & design, languages, business and driving. A number secured work through this project.

– **Work Skills Training** - we supported a woodwork project in Dancu which trains young people in basic skills and is now selling crafts in Moldova and the UK. Our support has included funds towards materials and running costs.

– **Small Business Start Up & Development** - we supported 5 income generating projects, three of which involved church leaders (bee keeping, chicken farming and dairy). Church leaders do not receive a wage, so it is of vital importance that they have an independent income. We also supported 2 women to make money through dressmaking and craft.

## Children at Risk

– **Prevention of Trafficking** - our main input in this area is through the education project mentioned above, and by providing vocational training through the sustainable businesses being created in Dancu. Our partners in Dancu, Straseni and others run various children's groups where they can assess and monitor children at risk and help to keep them safe.

– **Children's Ministries** - we continued to support weekly church run clubs and activities for over 100 teenagers and children at risk in 5 villages - Dancu, Poganesti, Jagver, Bozieni and Corbani. In Dancu we provided funds towards special events for children with disabilities and a Christmas event for children from several communities.

## Safeguarding

During 2019, Breadline developed their Safeguarding Policy and Procedures in line with legal requirements from the Charity Commission. Assistant director, Di Acaster visited Dancu with a colleague in January 2019 to deliver Safeguarding training to staff and volunteers from Tabita, Dancu School and the Moldova Charity Mission. They assisted Tabita to write their own policy which is now in place. They also did some training at Dancu school to 4 classes of children about internet safety.

## Support for People with Disabilities and Additional Needs

**- Inclusion** - Breadline supported the development of a project, including the training of volunteers, from the villages of Dancu, Poganesti, Cioara, and Calmatui, which helps adults and children with disabilities and additional needs to be more integrated in community life.

**- Projects** - support was given to our partners, the Moldova Charity Mission in Straseni, to run a day centre for 20 children with disabilities, including extra funding for special events such as Mother's Day (especially for those whose children have additional needs), summer camps for children and for adults, and Christmas celebrations. Breadline also supports the Hope Club in Dancu for children with additional needs and their parents, and have begun the process of fundraising for a purpose-built extension to the community centre for the project (see photo below)



## Family Welfare and Medical Support

**- Food Aid** - with Breadline's support 150 poor families received vital food supplies through Tabita in Dancu - i.e. 400kg of wheat and 100kg sunflower seed per family. 50 families at risk received emergency food parcels on a



**- Mobile Clinics, Care in the Community & Family Medical Assistance** - with the kind support of our UK partner Medical Missionary News, our partner Emanuel Clinic (EC) held 16 mobile clinics over a period of 28 days, serving 16 rural communities. Approximately 4,400 patients were given free consultations.

**- Equipment and medical provision.** Breadline and MMN provided essential medical supplies and equipment for EC's Home Care Project throughout 2019.

**- Medical Conferences & Training** - EC held a national medical conference in October attended by 180 doctors, nurses and medical students, in addition to 2 separate conferences specifically for students attended by 250 students. Support was given to one doctor to attend a radiography course in Canada, one doctor completed a management course at the main training hospital in Chisinau and 6 doctors attended a medical conference in Romania. The Step by Step Project provided education about living healthy lifestyles to various schools and holiday camps, attended by 800 young people altogether. Other activities included visits to retirement homes, an orphanage in Orhei where almost 200 boys and young men live and the women who nurse and support them, summer camps for people with disabilities and widows and training and support for mothers and children.

- **MMN's support** also enabled 20 people known to Breadline's partners to receive assistance towards emergency medical treatment.

- **Emergency Wood and Heating** - up to 30 impoverished families, including some vulnerable elderly people, received gifts of wood for winter heating and fuel for cooking (see photo below)



➔ **Aid** - individual supporters, churches and our charity partner, Mission Moldova, sent over 22,000kg of humanitarian aid. This included Christmas shoeboxes, clothing, school uniforms, tools, toys and educational resources, domestic and medical equipment. They went to 16 villages, a school, 2 kindergartens and a day centre for children with disabilities.

## Church Ministries and Training

➔ **Church Training** - we continue to support the Mobile Training Team (MTT) to deliver a theological training course to 33 churches in the region of Hincesti. This involves delivering a program of 6 modules to 40 church leaders and missionaries each year. We facilitated a visit from teachers employed by the Latvian Bible College (Riga) to Dancu, to observe the MMT with a view to developing their relationship and to explore the possibility of organising exchange visits.

➔ **Evangelical Events** - with the help of the Stuart Hine Trust and others, we supported 14 evangelical events in the Hincesti region.

➔ **Youth and Children's Work** - we supported 3 summer camps in Dancu, Poganesti and Jagver, attended by over 140 children, and a community youth project (Youth in Action) in Dancu. The young people attended this project help to clean, repair and decorate the homes of elderly people.

➔ **Women's ministry** - In Dancu, we supported the women to start a craft group, particularly knitting and sewing, by helping to provide resources. In August, they created 60 handmade bags and put in them warm knitted socks and toiletries for widows attending a summer camp run by our partners EC.

Assistant director, Di Acaster, and Liz Baird from Life Church Warrington, delivered a seminar on stress management to 20 women from Dancu Church and school in April. Breadline also helped to fund a marriage course in Dancu.

➔ **Ministry Support** - Breadline contributed towards the ministries and welfare of 26 church and charity leaders, and missionaries such as Mihai Burlacu, seen with his family in the photo (right). We also helped to fund building renovation and emergency repair for four manses, and provided training aids and furniture for a church plant in Bozieni.



➔ **Visits** - We are deeply grateful for all the teams and individuals from churches and other organisations in the UK who visited our partners in 2019 and gave them so much encouragement and support in the activities they participated in. These included specialists who advised on the businesses in Dancu such as the dairy and the bakery, those who helped with ministry and teams who supported the children's summer camps.

## Future Developments

We will continue to seek support for our partner projects and ministries and, wherever possible, facilitate direct links with individuals and churches in the UK. In 2020/21 we look forward to continuing our support for a number of new and ongoing projects, including:

- Facilitating the development of the Dancu Tabita Agricultural Association (TAA) and the cheese and dairy project.
- Supporting TAA in its vision to empower other communities, churches and their leaders in the Hincesti region to develop sustainable livelihoods.
- The continuing support of the vital work of the Dancu Mobile Training Team (MTT) in its delivery of a training programme for equipping leaders and members from 33 churches in its region and others beyond.
- Facilitating the MTT's vision to share about its model of training at the point of need with churches and Bible Colleges in Moldova and overseas i.e. Latvian Bible Centre in Riga.
- Development of church ministries to people with disabilities and inclusion awareness education. In October 2019, Sharon Rose, a speech and language therapist from Ruislip (pictured right), came to Dancu for a year. Sharon had visited Dancu previously, and had returned to work alongside professionals and volunteers from Dancu Church to develop their ministry with children with disabilities and additional needs and their families. Sharon is supported by the Church Missionary Society (CMS), but is working in collaboration with Breadline.
- The Moldova Charity Mission are also seeking new premises to develop the work they are doing with children and young adults with disabilities and additional needs. Breadline will be working alongside them to help network with specialists both in the UK and Moldova as they research how best to expand this project.
- With the assistance of MMN, to enable our partner Emanuel Clinic to develop its mobile clinic activities. In addition we will continue to help support people within their home care project by proving donated equipment and medical items from the UK which would otherwise be thrown away.
- A continuing emphasis on equipping and enabling our partner churches and charities in Moldova to be more effective in what they do, through training in leadership, teamwork, management and fundraising.
- Empowering the poor and marginalised to realise their potential and achieve sustainable livelihoods through encouragement, practical support and training, especially projects which enable young people to develop their gifts and skills to serve others in need in their own communities.
- Supporting projects that provide young people at risk from trafficking with educational and vocational training opportunities.
- Supporting projects that bring churches and communities together, educational resources for schools and family welfare.
