In setting objectives and planning activities, events, competitions and training for the members of the Cumbria Federation of Young Farmers' Clubs Northern District, the Trustees gave careful consideration to the Charity Commission's Public Benefit guidance.

Our key objects for the year included:

- Working with the National Federation of Young Farmers' Clubs (NFYFC) to organise a programme of over 50 competitions for our members to participate in. These included public speaking, After Dinner Speaking debating, pantomime, reading, county sports, stock judging, fencing, hedging, sheep shearing, cooking and floral competitions.
- · Providing Officer Training to all club chairs, secretaries, treasurers and advisory members to ensure each Northern District club ran smoothly and effectively.
- Supporting members in organising their club events, activities and Field Day.
- Encouraging members to carry out voluntary work and fundraising within their local communities.

Achievements and performance

Summary of the main achievements of the charity during the year

Membership:

For the purposes of this report, the figures given for the annual total will be those up to the end of July 2019, when the membership year came to a close. The Northern District of Cumbria YFC, continues from strength to strength, with a total of 929 members (excluding Advisory Members and Club Leaders) across 15 clubs. Our smallest club, Lamplugh currently has 25 members and our largest club, Skelton has 103 members. Walton has increased its membership by 14% this year and now has 40 members with ages ranging from 10 through to 26. As a democratic organisation, the Northern District encourages all of its clubs to develop a strong ethos of involvement and community awareness within its clubs. Younger members are mentored by older members, with knowledge and skills being passed on continuously, ensuring the successful survival of clubs.

Competitions:

The district has had another great year, with good results from not only district and county rounds, but also at Northern Area, Regional and National Finals. Raughton Head and Caldbeck YFCs Entertainment "G'Day Sport" took a very well-deserved 1st place at the Northern Area Weekend

In all, young farmers in the Northern District took part in over 50 different competitions throughout the year ranging from stock judging through to public speaking. Skelton YFC's very own Eamon Monaghan won 1st place in Member of the Year at both the Northern Area Weekend round and also at the NFYFC Finals, leaving his club and the district feeling very proud of his achievements. Junior Sydney Simpson from Lamplugh YFC also did his club proud by taking joint 1st place in the 17 and under category at the NFYFC finals of the Clay Pigeon Shooting Competition.

The Field Day this year, held at Home Farm, Greystoke, by kind permission of the Peile family was an excellent event, with host club Skelton YFC winning the Field Day cup for the second year in a row.

Fund Raising/Community Work:

The district continues to put much effort into both its fundraising and community volunteering endeavours. The 15 clubs raised a total of £12, 745 in the previous year for both local and national charities. All of the clubs now take on a local community challenge and carry out work tending community gardens, re-building stone walls and tidying up school playgrounds.

The Future:

The district is looking forward to another positive year with competitions, fund raising, training and community work being at the centre of their plans.

Financial review

Brief statement of the charity's policy on reserves

1. Dissolution of the County Federation

If in the event of the dissolution of the County Federation there remains after the satisfaction of all its debts and liabilities any property or funds whatsoever to which it is beneficially entitled, the same shall be transferred to the National Federation of Young Farmers' Clubs to be held on trust by the National Federation at its discretion and used for the benefit of the Young Farmers' Clubs organisation in the area concerned and shall not be distributed among the Member Clubs of the County Federation unless the said National Federation is no longer in being at the time of dissolution.

2. Restricted Reserves

The restricted reserves are:

- Monies received from closed clubs is restricted for 7 years during which it will be transferred back to the said club if any point during this period it reforms. After this period, it will be transferred to the unrestricted reserves.
- Monies received from Friends of Cumbria is restricted to the specific use it was originally provided for. If, after a period of 3 years, from when the monies were originally transferred, there are remaining funds, these may be transferred to the unrestricted reserves with the agreement of the finance and general-purpose committee. If, during the 3-year period, it becomes apparent the original use of the funds is no longer appropriate, the finance and general-purpose committee may redesignate the funds to a different purpose.
- Monies received from organisations is restricted to the specific use or event if was originally provided for. If, after the specific use or event has been delivered, there are remaining funds, these may be transferred to the unrestricted reserves or any other restricted reserve with the agreement of the finance and generalpurpose committee.

3. Unrestricted Reserves

The unrestricted reserves are available for the general operating expenditure of the charity. The charities reserve policy is to maintain freely available reserves equivalent to 12 months of budgeted operating expenditure, based on previous 6-year average. The trustees consider that unrestricted reserves of at least £110,277 should be maintained for Cumbria YFC as an organisation in its entirety.

This will be reviewed at each finance and general-purpose committee meeting. Action will be taken to maintain the level of reserves by the finance and general-purpose committee.
