- To liaise with national and local organisations such as Welsh Government and the City and County of Swansea (CCOS) to ensure a secure future for a librarian led service in Pennard, and to ensure that the building is fit for purpose
- To raise funds and assist with fundraising in support of Pennard Library where appropriate

- 4. We spent £1800 on building a patio for the outdoor reading area to encourage library use.
- 5. We held an AGM in June 2020 to keep members apprised of our activities.

FoPL's reserves policy is based up Charity Commission guidance. Namely: Charity reserves: building resilience (CC19, First published: 29 January 2016, Part of: Charity money, tax and accounts, Applies to: England and Wales).

FoPL's reserves policy is in place in the event that FoPL needs to take on the running of the library building, should Pennard Library be once again be threatened by closure.

Our targeted amount of reserves is £9000: with £4,500 being set aside for 6 months running of the facility, to allow time to generate new sources of income and for grant money to materialize, and £4,500 being held in reserve for emergency repairs.
