Structure, Governance and Management.

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

The Group is a trust established under its rules, which are common to all Scouts.

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

The Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group, which is an educational charity, manages the group. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of 3 independent representatives, Chair, Treasurer and Secretary together with the Group Scout Leader (if one appointed), individual section leaders and parent's representation and meets approximately every 3 months.

Members of the Executive Committee complete "Essential Information for Executive Committee" training within the first 5 months of joining the committee.

This Group Executive Committee exists to support the Group Scout Leader, in meeting the responsibilities of the appointments and is responsible for:

- The maintenance of Group property.
- The raising of funds and the administration of Group finance.
- The insurance of persons, property and equipment.
- Group public occasions.
- Assisting in the recruitment of leaders and other adult support.
- Appointing any sub committees that may be required.
- Appointing Group Administrators and Advisors other than those who are elected.

Risk Management and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as a church, community centre and other Scout Groups. We would offer similar reciprocal arrangements with these organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.

Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Occasional helpers are covered under a separate insurance policy. Risk Assessments are undertaken before all activities.

Reduced income from fund raising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.

Reduction or loss of Leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there were a reduction in the number of leaders to an unacceptable level in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section and in the worst-case scenario the complete closure of the Group.

Reduction or loss of members. The Group provides activities for all young people aged 6 to 18. If there were a reduction in membership in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section and in the worst-case scenario the complete closure of the Group.

The group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss; these include 2 signatories for all payments and a comprehensive insurance policy to ensure that insurable risks are covered.

Objectivities and Activities

The Purpose of Scouting

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

The Values of Scouting

As Scouts we are guided by these values:

Integrity - We act with integrity; we are honest, trustworthy and loyal.

Respect - We have self-respect and respect for others.

Care - We support others and take care of the world in which we live.

Belief - We explore our faiths, beliefs and attitudes.

Co-operation - We make a positive difference; we co-operate with others and make friends.

The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- Enjoy what they are doing and have fun
- Take part in activities indoors and outdoors
- Learn by doing
- Share in spiritual reflection
- Take responsibility and make choices
- Undertake new and challenging activities
- Make and live by their Promise.

Public Benefit Statement

The Group meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

Achievements and Performance.

See attached reports from the GSL and various Scout Section Leaders together with the Chairman's and Treasurers report for an overview of the work carried out over the last 12-month period.

Financial Review

Reserve Policy

The Group's policy on reserves is to hold sufficient funds to continue the charitable activities of the Scout Group should income and fundraising activities fall short. The Group Executive Committee considers that the group should hold a sum of 12 months running cost, circa £10,000.

The Group held reserves of £27,812 against this at year-end. This is above the level required for operating expenses. However, this can be explained by: -

- Deposits paid in for events that will occur during the next financial year included postponed and cancelled activity camps and events due to Corvid 19 outbreak.
- Possible refunds to parents and guardians for cancelled events and possible subscription reductions due to temporary cancelling of all face to face meetings due to social distancing during the Corvid 19 pandemic
- Reserves for future improvements and running costs to the Scout HQ premises during the period whilst the scout premises cannot be used either for Scout meetings or private hire.

Investment Policy

The Group's income and expenditure is very small and consequently does not have sufficient funds to invest in longer-term investments such as stocks and bonds. The Group has therefore adopted a low risk strategy to the investment of its funds. All funds are held in cash using only mainstream bank.

The Group Executive regularly monitors the levels of bank balances and the interest rates received to ensure the group obtains maximum value and income from its banking arrangements. Occasionally this may involve using an account that requires a period of notice before funds may be withdrawn, before doing so the Group Executive considers the cash flow requirements.

Plans for the coming year.

The planning for the next financial year is currently on hold due to the Scout Group being unable to conduct face to face meetings due to restrictions caused by the Corvid-19 pandemic. Once restrictions are lifted planning will be undertaken to provide a full programme within the limitations that we might be faced with. In the meantime, section meetings and our Scout programme will be conducted through our dedicated Facebook page and by conference (online) sessions

I REPORT ON THE ACCOUNTS OF THE 82^{ND} BRISTOL (St. Bernadette) Scout Group for the year ended 5^{TH} April 2018, which comprise of the Statement of Financial Activities, the Balance Sheet and any related notes attached.
