## **Projects**

Our multi-faith diversity project in West London expanded to engage new groups within the local community; young people and women from the Mosque, and men and women from the local Methodist Church. Additional outcomes have been achieved through the project; increasing connections amongst the local community and reducing loneliness in the older generation. Complementing our original aims to increase physical activity, improve health of the older generation; working on balance, co-ordination and movement.

The Golf Trust expanded our residential care facilities pilot in West London across London and Hertfordshire. The project works with care homes and sheltered housing accommodation to deliver adapted golf sessions for the residents. The project aims to improve physical fitness levels and reduce loneliness, as well support memory improvement and increase a sense of belonging within the group.

Awareness of The Golf Trust and our work is growing. We have been approached by physiotherapists and rehabilitation specialists to support their clients who have experienced life-altering accident, illness or injury. To support these participants sufficiently, we have acquired use of a Paragolfer – a motorised wheelchair that alters the position of the rider from sit to stand to perform the golf swing. The Paragolfer enables us to support and coach individuals who have spinal injuries, paralysis or issues with standing.

Our schools project delivers curriculum and after school golf sessions by qualified golf coaches. We have trebled the number of schools we are working in – introducing more young people to golf at a grassroots level. We have created links between schools and local golf facilities to provide sustainable pathways to continue their journey in golf.

## **Events**

The Golf Trust UK Disabled Open took place for the 7<sup>th</sup> year at The Shire London. Over 50 golfers competed in this Pan-Disability event which was played in the very best of spirits. This is the largest pan-disability golf event in the UK for all abilities from grassroots to elite.

In May, The Golf Trust held our first fundraising golf day. Thank you to Callaway Golf, Modest Golf, Steed Tailors, Els For Autism, Darren Gough and Arccos Golf for donating prizes to support the event.

### **Partnerships**

We are pleased to announce a new partnership with Variety Club Golf Society that will enable more disabled children to learn golf. The Variety Club Golf Society will provide grants so we can deliver more sessions across the country, reaching more children with various disabilities and impairments.

Our partnership with Els for Autism continues to flourish this year. The partnership is two-fold; 1) delivery of sessions to children and adults with autism and 2) providing "Game On" clinics and training to teachers, golf and multi-sports coaches in the UK. We have delivered seven "Game On" clinics across England and our first clinic in Ireland. The Els for Autism framework has been integrated to all of our disability sessions. The framework is based on evidence-based practices to teach golf. The framework is designed to build self-esteem and confidence in a fun, welcoming and supportive environment; encouraging participants to learn golf skills while practicing specific autism learning concepts including communication, emotional regulation, motor, and social skills. We have seen significant improvements in social and communications skills alongside improvements in health and wellbeing.

We continue to raise awareness in the area of disability and offer more inclusive opportunities. We have collaborated with partners (Wheelpower, Mencap, Disability Sports Coach and Jason Roberts Foundation) to introduce golf to individuals with multiple disabilities.

### **Funding**

We would like to thank our funders Hillingdon Community, Barnet Council, Sport England Small Grants, Big Lottery, and Variety Club. Their support has enabled us to introduce more people to golf and offer more inclusive sporting opportunities. We would also like to thank our fundraisers who ran the Royal Parks Half Marathon and participated in our charity golf day to raise money for The Golf Trust.

### **Future plans**

Our Senior team and coaches will continue to raise awareness about The Golf Trust, disability, the impact of golf on disability and encouraging golf participation. - Raising awareness of disability particularly autism
- Reducing loneliness through golf and reminiscence
- Promoting inclusion by faith and ability
- Extend care homes project into South London and Hertfordshire
