### Achievements and performance

# Summary of the main achievements of the charity during the year

- 1) In June 2019 we completed our annual 'Big Walk' a long distance Community-focused walk around Newton. This boosts community spirit and is also our main fundraising event of each year.
- 2) In July and August 2019 we offered four days-worth of 'Summer Games' at our local cricket club. Each day had a separate theme sport, an off-site visit to a 'Play Farm' and a final 'Beach Party'. Again, all our events were free of charge as part of our drive to attract and support as many financially disadvantaged children as possible.
- 3) During October and November 2019 we ran a weekly Craft Club where the children designed and created a range of simple products. These were distributed to elderly residents of the town's Care Homes when we visited them all as part of our 'Big Carol' in December.
- 4) In November, members of our 'BFY Samba Band' played live at the opening of the Earlestown Christmas Lights event.
- 5) In December we hosted over 100 children at our annual Christmas Party.
- 6) On a case by case basis we have supported children / families in acute financial hardship to attend clubs and groups which they would not otherwise have been able to afford,
