Structure, governance, and management

Charitable Status

Changing Tunes is a company limited by guarantee (number 07791242) which was incorporated on 29 September 2011. It attained registered charity status with the Charity Commission of England and Wales (number 1144789) on 24 November 2011.

This charity was set up to take over the activities of an existing unincorporated charity of the same name, which was founded in 1997 as part of the work of the Bristol Chaplaincy, established as an Association with a Constitution on 2 February 2000, and granted charitable status on 2 March 2000 (charity number 1079673). As such, the assets and funds of the unincorporated charity were donated to this charity on 31 December 2011.

The Charitable Objects

The object for which the Charity is established is as follows:

The advancement of education of prisoners and ex-prisoners in all forms of music and the performing arts with a view to aiding their rehabilitation and to further their rehabilitation by whatever means the trustees may from time to time decide.

Trustees

The charity trustees meet at least four times a year to discuss and review the progress and development of the charity, and are kept up-to-date, between meetings, by email. Where a requirement for a new trustee is identified, suitable individuals are identified and appointed by the remaining trustees. The Chairman of Trustees is responsible for the induction of any new trustee. New trustees have to gain an awareness of trustees' responsibilities, the governing document, administrative procedures, and the history and philosophy of the charity.

Risk Management

The trustees have reviewed the major risks and there are systems in place to manage those risks.

Trustees' Report

The Trustees present their report and the financial statements which have been independently examined for the year ended 31 December 2019.

Chairman's report

I write this report in the middle of the biggest global disruption since the 1940s, with a very indeterminate future and outcome but looking forward to when, as surely we will, we return to degree of normality. That normality will, almost certainly, be quite different from that we have known for very many decades.

Working in the criminal justice sector, we are very mindful indeed of not only the impact on physical health, on those living in higher-risk, densely-populated environments like prisons but also, critically, on the longer-term mental health impact on those in and out of prison, including our wider society, particularly those also serving our healthcare systems.

Overall, the impact of the COVID virus has been fundamental to delivery of our core services, with prisons entering 'lockdown' in March. We protected the financial reserves of the charity by placing all musicians on furlough, benefitting from Government support, but also developed remote support activities to prisoners. We also placed on furlough most office staff, with the exception of our fundraiser, and are continuing to take full advantage of new flexibility in part-time furlough arrangements, as prisons work towards reopening. Reserves are at a sufficient level to give reasonable certainty about longer-term sustainability and ongoing fundraising activity has produced encouraging results to date.

2019, for Changing Tunes, as I indicated at this time last year it would be, was the greatest year of transition I can recall, due to changes in the Chief Executive postholder. However, the board feels incredibly blessed in that it became a largely seamless transition, with Lizzie Bond continuing to support some fundraising work and conduct a piece of work on our post-release strategy, Richard Reddrop keeping the charity functioning extremely well in the first half of the year, before Dave Jones started in June. We are truly indebted to all these individuals for their professionalism and commitment in this transitionary period, showing great leadership of the wider team.

The board is excited by new challenges that Dave Jones has brought to the fore, ranging from development of our post-release work, specialisms across the prison estate (e.g. young offenders and women's prisons), and pushing the case for prison-funded work, thereby increasing our sustainability.

We also, in the latter half of 2019, worked towards a fully-agreed merger of the Changing Tunes Midlands franchise (a standalone charity) into Changing Tunes, and this process completed on 31st March 2020, the year-end of the former entity, with all assets and staff being transferred across. We are particularly delighted that this has been an entirely harmonious discussion and process, and also that two of the Midlands trustees will join the board, providing that much-valued regional representation, with the prisons and local funders.

We must also put on record our great thanks to those funders who see, and support, the transformational impact of the work we do, a purpose and outcome which is in the interest of every member of society.

As is always the case, I must thank all of our staff, from our new Chief Executive and office support staff, to all of our musicians delivering the work within the prison environment and elsewhere, for their determined commitment to delivering this value-restoring, life-changing work. We have been extremely fortunate indeed, over the years, and with great stability, to have working with us the most talented of musicians, but each of whom has been willing to put their talent second to developing the gifts of those who often have little opportunity to better themselves, and to use music for great and beneficial therapeutic effect.

We look forward to serving those in, and released from, prison during the remainder of 2020, as far as we are allowed to continue doing so.

The charity has reviewed key areas of its work and broke even, financially, all of which bodes well for 2020!

Staffing

Changing Tunes continues to benefit from the commitment and skills of its staff and volunteers. Lizzie Bond and Richard Reddrop led the organisation through the transition period, handing over to me in June 2020. Amelie Taylor joined the team in April as Office Manager bringing a wealth of knowledge of the Arts scene. Pete Truin relocated away from Bristol leaving a gap in both HMP Bristol and Vinney Green. We have successfully recruited a replacement for Bristol who started in early 2020. We recruited a couple of new volunteers to support in prisons and post-release.

Fundraising and Communications

Fundraising is a constant focus for the organisation. Working with Rea and our volunteer Fundraising Assistant, Rosie, we have developed extremely effective processes for building strong relationships with, and making attractive approaches to, funders. Here are some of the highlights from the year:

- The PCC Hampshire and Isle-of-Wight awarded us £9,000 towards our work in HMP Winchester, HMP Albany, and HMP Parkhurst and our Hampshire post-release work: This is almost double the amount given in the previous year
- The AB Charitable Trust awarded us an unrestricted grant of £15,000 reflecting the strength of our reporting and the engagement with this funder
- Changing Tunes' bid for Lottery funding, for the first time, and was successful, being awarded an Awards for All (Big Lottery) grant of £9,990 for our new St Mungo's project. This enabled us to launch a partnership project that has strong potential to drive forward our mission, in that it is being facilitated by one of our former beneficiaries, who is now a Changing Tunes Musician-in-Residence and it is enabling us to bring the benefits of our work to ex-prisoners, with whom we haven't already engaged in prison, extending our reach in a responsible and sustainable way. It paves the way for us to apply for bigger pots of money e.g. Big Lottery Reaching Communities Fund
- The Nisbet Family Charitable Trust gave us £12,000 for work at Vinney Green Secure Children's Home. This was a re-engagement with this funder, which donated £1,000 in 2015, enabling us to generate learning and outcomes to help us build the case to funders and partners for the growth of our work in youth secure units where we operate.
- The Valentine Trust gave us £10,000 towards our work at HMP Guys Marsh
- Seedbed Foundation (now wound up) awarded us £10,000 of unrestricted income.

We have developed our profile and formed new relationships with major donors, including through a presentation and performance at an event in London hosted by Clinks and the City of London Mayor. An influential philanthropist has pledged support to us and we are in the process of exploring what the level of that donation will be. This has put energy behind our work to cultivate a growing family of 'major donors', as a sustainable way of building unrestricted income.

We have had a renewed focus on our communications, looking at the best way to get the message out about our work to maximise support. This culminated in us producing a short video all about our work in HMP Eastwood Park, including comments from participants and strategic partners.

Financial Review

Income in 2019 was £279,130, compared to £356,852 in 2018, of which 74% was unrestricted funds and expenditure was £272,047. This enabled the organisation to slightly increase reserves to £143,113 putting the organisation in a strong financial position.

Unrestricted funds at the year-end stood at £98,771 with £3,649 tied up in fixed assets. The reserves policy of the charity prescribes maintaining a balance of three to six months' expenditure. This equates to reserves of between £68,000 and £136,000 and, at the year-end, free reserves were £95,122, which was well within this range. No funds, whether restricted or unrestricted, were in deficit at the year-end. The Trustees are pleased to report that reserves have been maintained during this year of transition.

Impact of Covid-19

The COVID-19 crisis has had a significant impact on Changing Tunes, like many other charities. It has primarily affected our voluntary income from Prisons as well as some grant-making Trust income. We have been able to make use of the government's Job Retention Scheme and also the Discretionary Grant to offset some of our fixed costs. Our healthy unrestricted reserves will more than cover these partial losses in income and see us through to the time when we can restart receiving voluntary income. The adaptation of some of our services has also generated new income streams, further supporting our sustainability at this time.

Plans for the next 12 months

Replicate

The next 12 months will be an important period for the organisation. A decision was been taken by the Boards of Trustees of both Changing Tunes South West and Changing Tunes Midlands to merge with effect from 1st April 2020. This organisational change will allow us to move forward as one organisation, developing thematically and strategically, and removing any duplicated costs of operating two charities. In 2020 we want to **Specialise**, **Replicate**, **Grow** and **Deepen** the work we do:

Specialise Develop tailored music programs for specific participant groups, e.g. our new project for vulnerable women who self-harm and are at risk of suicide

Grow our work across the female prison estate

Replicate the success of our work with young offenders, by developing programs in more

secure children's homes where we operate

Develop a bespoke Theory of Change for our work with young offenders in secure children's

homes

GrowBuild our capacity for increased service delivery in existing partner prisons with high demand e.g. delivering more weekly sessions to accommodate more potential participants

Expand our presence to prisons in South Wales e.g. HMP Parc and HMP Usk

Develop our post-release work by creating 2 New Hubs; in South Wales and Devon, in partnership with rehabilitation services and arts organisations

Double the number of ex-prisoners we engage in our long-term post-release work

Deepen

Roll out our 'Post-release Pathways', supporting participants to progress on to volunteering, training and professional opportunities, available with Changing Tunes and our partners

Develop our public performance programme, creating more opportunities for ex-prisoners to present their work and share their stories with audiences

Develop our artistic partners and audiences

Develop our communications with all partners

Some of these plans will no doubt be affected by the outbreak of COVID-19.

Statement of Trustees' responsibilities

The trustees (who are also directors of Changing Tunes for the purposes of company law) are responsible for preparing the Trustees' Report (incorporating the strategic report and directors' report) and the financial statements in accordance with applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102: *The Financial Reporting Standard applicable in the UK and Republic of Ireland* (United Kingdom Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting Policies

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006, applicable Accounting Standards in the United Kingdom, the Financial Reporting Standard 102 (effective January 2016), the Charities Act 2011 and the requirements of the Recommended Practice, Accounting and Reporting by Charities (SORP FRS 102).

The charity is a public benefit entity as defined under FRS 102.

There are no material uncertainties about the charity's ability to continue as a going concern, despite the significant uncertainty being caused by the worldwide COVID-19 crisis. Whilst the Trustees expect there to be a significant impact on the charity's operations and reserves in the coming months and years, the charity has sufficient reserves to be able to meet these challenges

Income

Income from donations is included in income when these are receivable, except as follows:

- I. When donors specify that donations given to the charity must be used in future accounting periods, the income is deferred until those periods;
- II. When donors impose conditions which have to be fulfilled before the charity becomes entitled to use such income, the income is deferred until the pre-conditions have been met.

Investment income is included on a receivable basis.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accrual basis, inclusive of any VAT which can be recovered.

Fixed assets

Fixed assets are stated at cost with purchases of £500 or greater being capitalised. Depreciation is calculated so as to write off the cost of fixed assets over the useful life as follows:

Music Equipment 25% reducing balance Office Equipment 25% straight line

Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

Bank

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Creditors

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

Fund Accounting

Unrestricted funds can be used in accordance with the charitable objects at the discretion of the trustees.

Designated funds form part of unrestricted funds and have been identified as being for particular purposes by the Trustees. They are not restricted and can be undesignated at any time at the discretion of the Trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
