REPORT TO THE AGM OF TENDRING DISTRICT TALKING NEWSPAPERS ASSOCIATION **AGM 2020**

I present to you the annual accounts to the year ending 31st March 2020. These accounts are presented having been examined and agreed by our examiner to whom I must offer my thanks.

INCOME

Listener donations in the year were down on the previous year at £200 as against £323. This drop in listener donations is a continuing trend but I understand this is in common with many other such organisations. We received a large legacy in the year with an initial receipt of £30,000. A further small balancing figure is expected during the next financial year. When encashing our previous investment with Nationwide and adding further funds received our investment in the Nationwide deposit account now stands at £70,000. This investment will be reviewed annually by the Trustees. The opening interest rate was 1.16% variable. However in light of the "Covid 19" outbreak this interest rate will be reduced in line with all other rates. Again our examiner donated his fee back to the Charity.

EXPENDITURE

Expenditure this year was slightly up compared to last year; with most of the increase being on memory sticks, and equipment repairs. PAT testing and other testing also slightly increased. The cleaning costs encompass increased hourly rate as agreed and includes tea, and cleaning materials. Depreciation has been considered as previously agreed by committee at 25%. I will have to consider further write offs next year of some "Boom boxes" as some tend to be lost when a listener dies. There is also natural wastage due to wear and tear.

INVESTMENT

As per agreement we were investing with Nationwide. The interest was added at £271 and with Trustees permission the total was withdrawn on maturity and added to monies received via a legacy. After examining independent financial advisor advice the Trustees decided that due to IFA costs and low interest rates the monies could better be invested elsewhere. This has been done as per Income section above

GENERAL

Due to the large legacy received in the year there was an overall excess income of £25,818. Factually without the legacy receipt there would have been a loss on operations of £4,182. I did warn last year that we were running at a loss in excess of £60 per week this has increased to £80 per week in the year. However we are still in a very healthy financial position as can be seen from our balance sheet and we continue to maintain our Charities overall criteria and purpose.

I will of course continue to monitor the position and advise the Trustees accordingly.

I commend this report and the attached examined accounts to the meeting and ask its approval
