Objectives and activities

Summary of the objects of the charity set out in its governing document

- 1. FOR THE BENEFIT OF THE PUBLIC TO RELIEVE THE SUFFERING AND DISTRESS OF HEDGEHOGS IN NEED OF CARE AND ATTENTION BY PROVIDING AND MAINTAINING RESCUE FACILITIES FOR THE RECEPTION. CARE AND TREATMENT OF SUCH ANIMALS IN THE WARWICKSHIRE AREA.
- 2. TO ADVANCE PUBLIC EDUCATION IN THE STUDY OF HEDGEHOGS TO INCREASE THEIR KNOWLEDGE INCLUDING THE CONSERVATION AND HABITAT OF HEDGEHOGS.

In operating our charity, the trustees have had regard to the guidance issued by the Charity Commission on providing a public benefit.

For the public benefit, our main activities include accepting into our care hedgehogs that have been found by the public and that we deem require our intervention to survive.

Generally, we are contacted by a member of the public who has found one or more hedgehogs. After a telephone screening process, a hedgehog is brought to us, whereupon we examine it and, if we are able to diagnose a condition, the medication appropriate to the condition(s) is During the initial rehabilitation period, a Rehabilitator administered. provides the patient with safe housing artificial heat where necessary. food, water, bedding and close monitoring. While the hedgehog is under hedgehog-friendly vets nearby.

the care of the Rehabilitator, any other conditions arising will be diagnosed and treated with the appropriate medication. Should the services of a vet be required the hedgehog is transported to one of our Rehabilitators are distributed throughout Warwickshire therefore each uses a veterinary practice local to them. It would be impossible for us to

continue our work with hedgehogs without the support of the vets. Whilst most of the hedgehog care can be done without the need for a vet, we rely on vets to:

- 1. Advise on difficult/unusual conditions
- 2. Recommend treatment of stubborn or complex problems
- 3. Supply medication for use by rehabilitators
- 4. Examine and, if possible, treat hedgehogs with serious injuries e.g. broken leg or jaw, strimmer wounds
- Euthanise hedgehogs that are very ill or badly injured e.g. head

injuries, broken spine or pelvis, deep tissue infections, multiple broken legs.

Occasionally, the hedgehog requires, and we provide twenty-four hour care. During the treatment phase our Rehabilitator cares for the patient until it has improved to the point where it can be re-released into the wild or handed to one of our Foster Carers who provides continued care, sanctuary and support for the hedgehog, for example in gaining weight, in preparation for its release. In the Autumn, hedgehogs that are healthy, but underweight for hibernation, are 'overwintered' with our Foster Carers. During that period the hedgehog is offered sanctuary, is monitored, kept warm, fed, watered and cleaned. Once the hedgehog has reached a suitable weight it is encouraged to hibernate. Upon awakening in springtime, after hibernation, the hedgehog remains in care until its weight is deemed appropriate to allow it to be re-released into the wild.

We find permanent homes for some hedgehogs that would not survive in the wild. In these homes they are provided with secluded, enclosed, outdoor facilities and are fed, watered and monitored.

As dedicated volunteers we have been helping hedgehogs as a group since the formation of the organisation in 2014. Several members have worked with hedgehogs independently for many years.

The group comprises about ten Rehabilitators and many Foster Carers, all operating from their homes and gardens within the county of Warwickshire, where they offer rescue facilities. Rehabilitators are those volunteers who are specially trained in the care of hedgehogs and, more specifically, in the administration of medication to sick or injured hedgehogs. On the whole, Foster Carers care for the hedgehogs during the recovery period. Their job involves feeding the hedgehogs and cleaning their pens whilst continuing to observe and record the hedgehog's health.

Rehabilitators are all trained at Vale Wildlife Hospital & Rehabilitation Centre where they attend the *First Aid, Care & Rehabilitation of Hedgehogs Course.*

The task of nursing a hedgehog back to health is a lengthy process with one hedgehog requiring, on average, three months of care that involves feeding, cleaning, medicating, vigilance, recording, vet visits and, the other side of the coin, receiving the public into our homes and communicating with the public. Multiple tasks requiring time and expertise of a few dedicated individuals. We are a small team dedicated to making a positive impact on the survival of Warwickshire's hedgehog population.

Our volunteers have made us happen over the past year. We acknowledge that they form the backbone of our charity and, without them, we simply could not be. The trustees thank you all for your generosity of spirit.

During the summer months we take stands to events such as Village Fetes, National Trust events, and opens days at local attractions, *e.g.* Charlecote Mill.

We raise small sums for the charity at these events, and generate much interest from the public, both children and adults alike. These gatherings are educational opportunities allowing us to share information and stories

about hedgehogs. We answer questions and provide information for example, on feeding and providing 'houses' for wild hedgehogs, the annual life-cycle of hedgehogs including breeding and hibernation times, the management of gardens to reduce hazards and increase opportunities for hedgehogs, the reasons for the rapid decline of hedgehogs and what to do if someone finds a sick hedgehog.

Visitors may take our contact details, leaflets and flyers from our stand, and the pictures on display are reliable conversation starters.

It is important to acknowledge that we are staffed entirely by volunteers and that our objects and activities would fail to be achieved without them. Volunteers donate their time, their personal funds and their expertise for the benefit of the public in general and, on their behalf, Warwickshire's hedgehogs.

The support of volunteers cannot be underplayed because it enables us to continue our charitable work. Thanks to them, we continue to generate goodwill amongst hedgehog lovers, and it is that goodwill that keeps our doors open to the public.

Section D

Achievements and performance

Summary of the main achievements of the charity during the year

Our Rehabilitators received into care almost six hundred sick hedgehogs in 2019, a huge increase from 2018. Most hogs recovered fully and were released back to the wild, some were settled into safe gardens belonging to a member of the public who offers food and shelter. Sadly, some hedgehogs with serious injuries or advanced conditions could not be saved despite, where necessary, veterinary intervention. We have recorded a significant increase in hedgehogs with severe injuries (broken legs, strimmer wounds, etc.) and infections and continue to see the presence of intestinal fluke that is proving recalcitrant to treatment and thus causing the time in care to be extended.

Over the past decade, we have received increasing numbers of hedgehogs. The cause is unlikely to be that there is an increasing number of hedgehogs but may be driven by the media attention on hedgehogs that has raised awareness of the decline of hedgehogs and their habitat, and promoted hedgehog rescue centres. These days the public is much better educated about what to do if they find a sick or injured hedgehog or find a hedgehog out in the day.

Our talks, presentations and fundraising events continue to be well-received, as was our first calendar. We feel they have been instrumental in raising awareness of the plight of Warwickshire's hedgehogs as judged by the increasing number of calls we receive from the public and the increasing number of hedgehogs we receive into care. In addition, the publicity has brought us new volunteers who wish to train as Rehabilitators and Foster Carers. They will help us to accept even more sick and injured hedgehogs.

In May 2019 we gained charity status, a major achievement that enabled us to apply to charitable trusts for grants that contributed £7K to our income. For these grants we give our thanks to: The A.H. Achievements and performance

We are grateful for the ongoing support from 'Kenilworth Books' who actively raise funds for us and raise awareness of hedgehogs and of our work.

Two of our Rehabilitators undertook to produce our first calendar. It was an educational tool in which each page represented a month and included information about hedgehogs, their requirements and their habitat relevant to the month. The calendar was funded by the public and by the sale of sponsorships to businesses in the Stratford-upon-Avon area. The calendar was an overwhelming success, contributing almost £4K to our reserve as well as enabling us to purchase special cameras to assist with hedgehog care.

Importantly, an achievement that cannot be overlooked, at the end of our financial year we had succeeded in increasing our reserve by 80%, up from £10K in 2018, to nearly £18K.

During the year, Amy Swinbourne stepped down from managing the accounts for the charity. She had taken on the role when the Trustees of the Charity changed and played a crucial role in raising the standard of the financial records and 'stabilising' the record keeping. We are all very grateful to her for taking on this challenging role and supporting the organisation during a time of significant change.

Amy handed over the accounts to Virginia Kearsey who not only has taken on the finance role but using her experience working with other charities has also achieved a significant milestone for the organisation in attaining charity status.

A pattern of quarterly meetings has been established. During the meetings, the finances of the charity are discussed, and sources of funding are considered. News on hedgehog care is shared and updates on projects are given.

Our principal sources of funding in 2019 were charitable trust grants, the crowdfunding platform GoFundMe, the sale of our first calendar and donations from the general public.

91% of our expenditure has directly supported our key objectives, comprising 31% veterinary care; 21% medicines; 14% food and care; 13% medical supplies; 12% rehabilitation equipment, while 9% has indirectly supported our key objectives (goods for sale, admin).
