The excess of income over Expenditure is largely made up of an insurance claim for fire damage the hall suffered in June 2019 of £45191.78, grants totalling £6818.17 and a £10000 National Lottery Grant.

This takes the total cash funds at the year end to £33961.94. This does include £16489.01 in the savings account (which includes the National Lottery grant) and £11175.18 of remaining Insurance Money spend.

It is my view that these accounts are supported by detailed accounting records for both Income and Expenditure categories and represents the activities of the Scout Group and its financial position at the year-end date.
