UHST raises funds to support education in humanist schools in Uganda. Our funds go to schools that belong to the Uganda Humanist Schools Association: Isaac Newton High Schools at Kateera, Masaka, Mustard Seed High School, Busota, Kamule, Kasese Humanist Primary School and Katumba Parents' Humanist Primary School, Bundibugyo. We also provide scholarships to allow bright but needy children to attend the above schools.

As in previous years, Uganda Humanist Schools Trust places considerable emphasis on keeping supporters informed about the progress of the schools. We visit the schools each year and write detailed reports for donors. By having a trustee on the Management Board of each school we are able to play a full role as partners in key decisions concerning the development and management of the schools. 	<ol> <li>We continued to promote independent learning by providing money for books, science and other learning materials. We promoted a Reading for Pleasure programme.</li> </ol>
	<ol> <li>Our provision of re-useable sanitary pads continued to maintain high level of participation by girls.</li> </ol>
	<ol> <li>At Isaac Newton School we completed the construction of a new teaching block with 3 classrooms and a science lab and connected the school and surrounding villages to mains water and electricity.</li> </ol>
	<ol><li>At Mustard Seed School we completed the construction of a new multi-purpose Hall and funded a second girls' dormitory.</li></ol>
	<ol> <li>We provided funds for books at the two primary schools, and funds to pay for the school fees of over 100 orphaned children at Katumba Humanist Primary School.</li> </ol>
