### **Description of the charity's trusts**

The charity is constituted as a Trust with a Trust Deed Dated 06/06/1994 as a governing document.

The charity's Objectives and activities are the prevention and alleviation of animal suffering (for further details see clause (B) of the governing document.

#### **Achievements and performance**

Our ever important spaying and neutering work and education on animal welfare has continued along with the usual rehoming of unwanted cats and kittens.

The replacement animal utility room and the isolation room, also built by Peticular Pens, are near completion but have had to be put on hold due to the coronavirus lockdown.

### Financial review

There are no restricted funds. All the reserves and investment income are to be used for the benefit of the charity's objectives and activities. Donations, legacies and fundraising have continued to provide a substantial income for the charity.

The charity is now VAT registered and the VAT charged on purchased goods and services such as cat food and vet bills is now recoverable.

Rental income from properties previously acquired by the charity has continued to make a far greater contribution to our funds than bank interest.
