# Special Note Re-election of Officers & Council

In normal circumstances the Hon.Secretary, Hon.Membership Secretary & Hon.Treasurer are elected annually at the AGM. Council Members who have served four years retire in rotation & replacement nominees are elected for four year terms. In mid 2020 the Council Members due to retire were Mrs Lynn Carstens and Mrs Hilarie McNae. It is proposed that following forced cancellation of the AGM the current incumbents are asked to remain in office for one further year, leaving one vacancy open for co-option.

## **Honorary Treasurer's Statement**

#### Trustees

The Trustees have no beneficial interest in the charity.

#### Structure, Governance and Management

The Friends is a member association who appoint Trustees to oversee the running of the Charity. Trustees serve for four years and may not return for 12 months. The offices of Honorary Treasurer, Honorary Secretary, Honorary Membership Secretary are renewable at each Annual General Meeting and may be continuous. The position of Chair is held by the Dean or Acting Dean and Vice Chair is held by the current Chapter Representative of Chester Cathedral.

#### Risk Management and Reserves Policy

It is the responsibility of the Trustees to assess the main risks the Charity is exposed to, particularly those relating to the operations and finances of the trust. The trustees undertake this assessment and ensure that systems are in place to mitigate and manage the Charity's exposure to any major risks.

The Honorary Treasurer presents a formal report at each council meeting (held about four times a year)

The level of unrestricted funds at end 2019 was £120,179 The trustees are satisfied that this is sufficient to meet any obligations arising through the operation of the Charity at the current time. In addition, restricted funds of £41,775 are held. The trustees have considered the requirement to maintain free reserves and are satisfied that the Charity has a need to establish free reserves to absorb the major fluctuations in funding received without curtailing services to its beneficiaries. This is was assessed as £25,000 and stood at £24,276 at the end of 2019. It is planned to reduce free reserves to approximately £20,000 in 2020. The remaining funds are held in investments and interest bearing savings to provide regular income for future services.

#### Statement of Public Benefit

The Trustees are aware of the Public Benefit provisions of the Charities Act 2006 and of the guidance on them published by the Charity Commission. They are satisfied that the objects of the Charity and the activities of the Charity are within the definitions of Charitable Purposes as set down in the Act. The Trustees are not aware of any public detriment caused by the Charity's objects or activities, and nor are they aware of anyone receiving any private benefit from the Charity's activities.

### **Objectives**

Assisting the Dean and Chapter in furthering the religious and charitable work of Chester Cathedral by supporting the spiritual life, work and worship, and maintaining, improving, adding to and repairing the fabric, fittings, furniture, ornaments, services and music.

#### Principle Activities

The Friends raise money by an annual subscription. They also receive donations, bequests and legacies. The Friends organise events to advertise the work of the Cathedral and Friends, attracting further support.

## Independent Examiner

#### Notes to the Accounts for the Year Ended 31st December 2019

#### 1. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with the current applicable accounting standards and the Charities Statement of Recommended Practice. They have been prepared under the historical cost convention.

#### Funds

Unrestricted Funds are not subject to any restrictions regarding their use for the general purposes of the FCC. Funds designated for a particular purpose by the FCC are also unrestricted. Restricted funds are: -

- (1) a bequest of £25,000 which is restricted to enhancing music and the choir
- (2) The Sir John and Lady Temple fund which is restriced to music and the choir until 31 Dec 2020, when the fund reverts to unrestricted
- (3) The Cheshire Regiment Association fund which is restricted to the Regimental Memorial Garden and the Regimental Chapel and subject to approval by the trustees of the CRA.

#### Incoming Resources

#### Voluntary income and capital sources.

Subscriptions are recognized when received by the FCC. Income tax recoverable is recognized when the income is received. Grants and legacies to the FCC are accounted for as soon as the FCC is notified of its legal entitlement, the amount due is quantifiable and its ultimate receipt by the FCC is reasonably certain.

#### Other Income

The income from Events is shown in detail in the Detailed Income & Expenditure and in summary in the Statement of Financial Activities. The related expenditure is reflected in a similar manner. The profits and losses on each Event can be calculated from Detailed Income and Expenditure. Events created a net income of £561 in 2019.

#### Income From Investments

Interest entitlements are accounted for as they accrue.

#### Resources Used

The accounts have been prepared on the accruals basis which takes into account liabilities due at the year end for expenses incurred and matches expenditure to the period incurred or income gained. Grants and donations are accounted for when paid, or when awarded, if that award creates a binding obligation on the FCC.

#### Fixed Assets

Assets are written off in the year of purchase. The charity has no fixed assetts.

#### 2. REMUNERATION

The Friends acknowledge the extensive work carried out by its volunteers. No remuneration is paid.

#### 3. SUNDRY CREDITORS, SUNDRY DEBTORS, PREPAID EXPENSES AND INCOME

There are no sundry creditors, sundry debtors or prepaid expenses and income.

## 4. CBF CHURCH OF ENGLAND FUNDS INCLUDING TEMPLE ENDOWMENT

Total investment remains unchanged at £108,000. No account has been taken of fluctuations in the market value of the investment funds. The total bid value of invested funds was £153,700 at the end of 2019 compared with a book value of £108,000. The trustees take the view that these are longer term investments and the capital gain is not reflected in the accounts until the investment is liquidated. However it is planned to liquidate a major portion of the investments in 2020 to contribute towards the expected Nave Liturgical Furniture.

In addition £29,678 including accumulated interest is held in deposit funds which will be transferred to the current account as & when needed, before liquidating investments.

#### 5. CURRENT ASSETS - BARCLAYS PREMIUM ACCOUNT

The account balance at £24,276 against the target of £25,000. The target is reviewed from time to time and will be allowed to drop to £20,000 in 2020.

## Report of the Independent Examiner to the Friends of Chester Cathedral

I report on the accounts for the year ended 31st December 2019, which are set out in this report

#### Respective responsibilities of the trustees and Independent Examiner

As trustees of the charity, the members of the FCC are responsible for the preparation of the accounts. They consider than an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.
