Achievements and performance

Summary of the main achievements of the charity during the year

January 2019 saw all the Home Educated students returned after the Christmas break. Pre planned were a set of new lessons building on all the work done at the back end of 2018.

Throughout the early to mid part of 2019 we covered a number of new 'Great Master' Artists and a variety of new and established techniques, expanding minds and improving abilities. In August 2019 we held our first Art H'eds exhibition, we had all the kids and mums ad to curate and mount their own work, this proved an important learning experience as each person had limited space and a large body of work to select from. We had the kids host the exhibition, introducing themselves and their artwork, we had in excess of 45 people attend the launch alone. Feed back from those who were seeing for the first time what the kids had produced were extremely complimentary and encouraging, so much so the kids want to stage another exhibition next year in 2020.

Late August 'Top Church' here in Dudley, had commenced some major renovation work which involved the removal of their 300 year old pews. We approached the church with a proposal to paint in acrylics scenes of the church on any off cuts of wood they had. This proposal was received with enthusiasm and so with the kids we went on mass to the church to take some study photographs and collect the wood.

In December on the re-opening of the church they had dedicated an area for the sole purpose of exhibiting all the wood paintings the kids and mums had done, the kids were extremely proud.

In Aug/Oct we were notified of two successful bids for grants for our Home Educated groups, one from The 'Phillip Bates' Foundation and one from the 'Active Citizens' award. These awards meant we could replenish our diminishing stocks as well as invest in materials the kids have never experienced or used before.

Overall the learning curve the kids have undertaken since Sept 2018 when they first started with us has been amazing, there confidence levels and their interaction skills have also greatly improved too.

Our Craft & Chat sessions has grown over the months with groups sizes reaching 10+ people. During these sessions we now have a number of service users running some groups within Artspace They have all bonded well with many forming friendships outside of Artspace, for some this has become the highlight of their week.
