THESE ARE A MIXTURE OF OVERSEAS AND CHILDRENS' WELFARE, CHRISTIAN ORGANISATIONS, THE DISABLED & SICK, AND INDIVIDUALS IN NEED.

THE MAIN THRUST OF THE FOUNDATIONS' EFFORTS DURING THE YEAR TO MARCH 2019 CONTINUED TO BE IN AFRICA, ZAMBIA IN PARTICULAR, WHERE IT IS SUPPORTING HOSPITALS, YOUTH SKILLS TRAINING, SATELLITE COMMUNICATIONS, WELL DIGGING AND OTHER CLEAN WATER AND HEALTH INITIATIVES.
