For example, our Tuesday evening prayer services provide a quiet, intimate and reflective time for families to pray and fellowship with others especially those who for some reasons could not catch up on the Sunday service.</p> <p>This year, we have been successful in continuing our Thanksgiving Service on the 1st Sunday of each month. An opportunity for families to reflect on the goodness of the Lord in the cause of month and share their testimonies to encourage others to be steadfast and unmoveable in their faith and relationship with God and others.</p> <p>This year has been successful with many of our community initiative programs. The church general conference has been successful with bringing many families together to pray for our communities, cities and nations.</p> <p>Our community BBQ service in the summer was a huge success as we saw many people in the community come to church to fellowship and enjoy free meal and drinks. 
