### **Annual Report**

#### for the year ended 31 December 2019

The trustees present their report with the financial statements for the year ended 31 December 2019. The financial statements comply with the Charities Act 2011 having been prepared on a receipts and payments basis.

The Balasuriya Foundation CIO was registered in England and Wales as a Charitable Incorporated Organisation on the 23 October 2017 with charity registered number 1175296.

The objects of the charity shall be the advancement of charitable purposes (according to the law of England & Wales) for the benefit of the public, as the trustees see fit from time to time, in particular, but not limited to making grants to charities, or other organisations or individuals working to advance charitable purposes.

#### Trustees

The trustees who are also the members and served the charity during the period are detailed on Page 1.

New trustees are appointed by the current trustees from people over 16 who have shown a keen interest in the work of the charity and have abilities required on the governing body.

The board shall consist of at least three trustees and at least one of the trustees must be 18 years of age or over. When they are inducted the trustees are presented with a current copy of the constitution and latest annual report and financial statements.

#### **Trustees responsibilities**

The Trustees are required to prepare financial statements for each financial period which give a true and fair view of the state of affairs of the Charity and of its income and expenditure for that period. In preparing those financial statements, the Trustees are required to:

- · select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping accounting records which disclose with reasonable accuracy the financial position of the charity and which enable them to ensure that the financial statements comply with the Charities Act 2011.

#### **Financial review**

The results for the charity for the financial year are detailed on pages 5 to 7.

#### Achievements, performance and developments

The foundation has generated income and awarded grants as shown within the financial statements. The charity has been able to offer support the following main charities as well as other smaller grants shown in note 2 to the accounts.

- Children in Need has a vision that every child in the UK has a childhood which is safe, happy, secure and allows them the chance to reach their potential. The charity provides grants to projects in the UK which focus on children and young people who are disadvantaged. It supports small and large organisations which empower children and extend their life choices.
- Make-a-Wish Foundation a medical charity which enhances the lives of sick children by promoting and further the care and relief of children under the age of eighteen who have a terminal illness or who are suffering from a medical condition sufficiently life threatening to create a probability that the child will not survive beyond their eighteenth birthday, and in particular by granting feasible wishes of such children.

#### Achievements, performance and developments (continued)

- Mission Smile a medical charitable trust dedicated to providing free life changing cleft care and surgery for children and adults born with cleft lip, cleft palate and other facial deformations.
- Nepal Youth Foundation UK a health, welfare and educational charity which acts as a resource for young people living in Nepal by providing advice and assistance. It organises programmes of physical, educational and other activities to advance in life and help young people by developing their skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individual The charity advances education; provides nutrition centres to restore the health of severely malnourished children and to educate the child's carer on health, hygiene and nutrition to stop the cycle of malnutrition. Providing residential care for destitute children where there is no family alternative available; relieving unemployment.
- Redbridge Budhist Cultural Centre is a religious organisation which was established to provide a suitable site in or around Ilford to establish a Temple. They purchased a building for £180,000 which was inaugurated in November 1998. The Temple has gained popularity to provide all the necessary services to the Buddhist Community at large at especially in the Redbridge area. The project provides an important cultural centre for the area and wider region.
- The Benjamin Foundation a youth support foundation which aims to provide high quality services and opportunities that significantly improve the lives of vulnerable children and young people. They provide advice, support, counselling, information, supported accommodation, an independent school, residential care for looked after children, positive activities, parenting support, out of school and youth projects, handyman service and re-use schemes.
- The Pickering Cancer Drop In Centre is a self funding registered charity established by a group of cancer patients and based in Tunbridge Wells. The centre acts as a hub for anyone affected by cancer, providing information, support and a relaxing atmosphere where people can talk freely. Patients, carers, family and friends are offered a wide range of free facilities which includes complimentary therapies as well as advice and counselling.

#### **Public benefit**

The trustees consider that the objectives and activities of the charity are in accordance with the Charity Commissions' general guidance on public benefit. The details of public benefit are covered within other areas of this report especially under the heading of 'Achievements, performance and developments'.

The foundation makes grants to charities, or other organisations working to advance charitable purposes, which gives benefit to children, the elderly, those with disabilities, those of different ethnic or racial origin.

#### **Risk assessment**

The trustees have considered the major risks to which the charity is exposed and consider that those risks have been currently been negligible. When the charity makes investments then it will need to re-address those risks and ensure that suitable mixes are used and assets are covered by adequate insurance.

The trustees do have a grant making policy which incorporates ensuring that the institutions to which grants are made are suitable and charitable in their own activities.
