### Loughton Men's Institute Trustees Report for year to 31<sup>st</sup> March 2020

Throughout the year the Trustees have met regularly to ensure the building at Station Road is maintained to a proper standard

The Club has plans to carry out major improvements in order to make the premises more attractive to outside bodies and therefore increase the income. The Trustees monitor the financial position on a regular basis. Arising from this the Trustees decided that it would be sensible to provide financial assistance. They therefore provided a grant of a certain amount and in addition a loan repayable over a period of two years. Immediately after that Lockdown occurred and the Club was closed so the repayment period had to be extended.

The Trustees have continued to support local Charities who they consider need financial support while retaining funds for any unexpected expenditure.

During the year the Trustees continued making a grant to the local Citizens Advice Bureau to assist them in providing debt counselling work at the Loughton Branch.

Also during this year the Lease granted to the Club expired and has now been renewed. The term of the lease was increased to assist the Club in seeking finance where providers wish to see a longer period of security of tenure.
