Chairman's Report 2019

I find it hard to believe that, yet another year has gone by, and we are already looking forward to the 2020 season which with the current world pandemic could be a little different to what we normally know. SLS Cornwall have already postponed some of our Stillwater's event, but the welfare of our members will always be taken first.

All our events were well attended, and the Region came together to help run these events. There is always a lot of hard work going on throughout the year, and I would like to thank everyone for their effort and support, which makes Cornwall the Region it is today. Our events are now the main source of income for the region and we find ourselves having to increase entry fees to cover the ongoing cost to support these events.

Grant applications are now becoming more difficult to secure and needs to be addressed with us looking at more grants funding which will help us setup support packages for the clubs. We were successful with the grant for new intermediate boards which we were able to offer every club in Cornwall. We are renewing two of our IRB engines which will replace our current ageing ones (the oldest is now coming up to twenty years in service), these were not fundable and were funded by the Region out of the current funds.

This year we will see Diane Green standing down from the role of Hon Secretary which she had held for over 20 years. Diane has been the main anchor of the Region who without her endless help and support we would not be where we are today. I cannot thank her enough for all the help, support and direction she has shown to me over the years. Good news is that we will not be losing her as she has agreed to stay on as Treasure. There has been a drop off in clubs attending the monthly meeting, which is a little concerning as we need to hear the voice of all our member clubs and not just a few. We have now changed the number of meeting a year but hopefully we can engage with more members to become involved with sub committees and start supporting our clubs wherever we can.

Cornwall Region is still totally behind the new Patrolling project and have agreed to help fund wherever possible to help our clubs to get up and running. Our club have also embraced this and now we have more clubs looking to put on out of hour patrols on their own and working with the RNLI. The Patrol Captain award has also been taken up by so many clubs which is needed and encourage club to get back to their core values without having to change what they have been doing for years.

The Flood Rescue Team is now being recognised by the other emergency agencies and hopefully will be more used in the County. As part of this team I would like to thank the Region for all their support and John (Jock) Paton as the Unit Manager (along with his role as Cornwall's RLSO) and all the time he puts in. The Flood Rescue is not going to replace our core value but will work alongside. We will be able to access the funding and add another string to our bow which will make our Region even more community based. If there is anyone interested in joining the team, please let me know.

2019 was such a good session for SLS Cornwall and I hope that you all keep safe and well in 2020.
