# **Objectives and activities**

Summary of the objects of the charity set out in its governing document

- To work towards eliminating gender inequality, through education, and awareness-raising, for the benefit of the general public and particularly for women and girls involved in music creation and performance
- To promote the art of music through providing music education activities for women and girls in London, and to use these to increase the numbers of women and girls making music and build their confidence and self-esteem

Girls Rock London advanced its objective of providing music education activities for women and girls in London in the following ways:

**Final term of our Post-Camp Programme 2019 –** 13 young people participated in 3 full-day workshops in music-making, technology and performance, Q&As with recording artists, 1-1 support with song-writing, and open mic practice, supported with funding from Youth Music. An average of five volunteers supported each session alongsidepaid facilitators. 4 recording artists performed lunchtime gigs for the young people.

Girls Rock London Summer Camp 2019 - 24 young people participated in our six-day summer camp, facilitated by 37 freelancers and volunteers. 16 participants attended the programme for free, referred by organisations within the community including Akwaaba, Berger Primary School, Mandeville Primary School and Child and Adolescent Mental Health Services. Young people learned the basics of a new instrument, formed a band and wrote a song which they performed at the showcase concert at the end of the week in front of family, friends and supporters. Participants also had the opportunity to participate in workshops focusing on musical skills and other subjects with the aim of supporting participants' awareness and maintenance of good mental health and well-being. 7 female and trans artists performed 'lunchtime gigs' introducing participants to a wide range of new music and role models. This project was supported with funding from The National Lottery.

**Promoting women and trans people in live music –** we supported three alumni acts to access performing opportunities at external events including She-Fest 6 and She-17 Festival and at Rough Trade at a concert hosted by Dream Wife and Blood Records.

Women Rock London Summer Showcase – we hosted a showcase event where 13 women and trans people who had previously participated or facilitated in our camps performed new music live to an audience, with the aim of providing a supportive and nurturing space for developing musicians to share ongoing work.

Girls Rock Camp Alliance - volunteers and beneficiaries of the charity actively participated in various events run by the Girls Rock Camp Alliance, an international membership organisation for girls rock camps. These included an international rock camp in Iceland, in which 5 Girls Rock London people took part as participants and volunteers, and supported by helping to develop content; a European conference of girls rock organisers in Oslo, in which seven of our volunteers, staff and trustees participated, and an international educational conference of girls rock organisers in the United States of America, in which one of our cofounders participated.

**BBC Introducing** – 14 volunteers ran a daily music-making session over three engaging 300 members of the public at this industry event in November, and also presented a documentary about our work with a Q&A to a live industry audience, highlighting gender inequality music-making and performance.

## Section D

## Achievements and performance

Summary of the main achievements of the charity during the year

- Our co-founder Jessie Maryon Davies was recognised by Time Out London in their end-of-year honours list for her work with Girls Rock London.
- An alumni band Concrete Bones reached the finals of the Isle
   Of Wight Festival 2019 New Blood Competition, from a pool of
   5000 entrants.
- We worked intensively with 35 young people. Between them they created approximately 10 musical compositions and performed at four concerts.
- After the summer camp 71% of participants reported positive change in at least one of five indicators measuring confidence and self-esteem, and half of parents and carers surveyed reported improvements in their child's confidence after working with Girls Rock London.
- A total of 72 volunteers delivered our activities and back-office functions in 2018/19, contributing thousands of hours of work for Girls Rock London. Funding was once again secured to pay people from low income backgrounds the London Living Wage to facilitate our activities, enabling us to diversify our delivery team.
- 11 visiting artists performed at our events for young people.
- Two 18-25 -year-olds had the opportunity to participate in a paid, structured work placement where they learned skills in community music leadership, and received mentoring and advice from experienced musicians.
- Sponsorship partnerships were agreed with high-profile partners in the music industry including Marshall, Roland and Bell Music, and Girls Rock London participated in BBC Introducing Live, in partnership with Marshall.
- Approximately 150 people attended our events in person as audience members, and a further 400 watched performances of GRL alumni at concerts where we directly supported acts to perform. We also reached up to 1,675 people with a series of videos of Girls Rock Camp events online.

In 2018/19, Girls Rock London had a turnover of £51,197. Our principal sources of funds came from:

- Programme fees (money paid by participants to take part in our activities)
- Grant funding from Youth Music, Arts Council England and National Lottery Awards for All
- Donations from individuals, organisations and bands including Chyrches via Plus One and Dream Wife
- Fundraising events
- Sale of merchandise

Our expenditure totalled £64,837, and with this we were able to pay for the costs of:

- Two participatory music programmes for young people
- A participatory music programme for adults (that finished just at the end of the previous financial year) and one showcase performance for adults
- Our Young Music Leader programme, where two young people were trained and supported in a paid work placement
- Participation in a number of music industry events, drawing attention to gender inequality and the experiences of women and trans people in music

Expenditure allowed us to support the key objectives of the charity by enabling us to deliver programmes and events that raised awareness of gender inequality and how it affects women and girls in music-making and performance. These events also enabled us to promote the art of music with a wide range of beneficiaries, and to build beneficiaries' confidence and self-esteem through participatory programmes. Our events reached a wide range of people including industry experts, young and adult women from diverse backgrounds, musicians, music journalists and families. At our post-camp programme and summer camp for young people, our expenditure enabled us to provide completely free places for 19 young people from low-income backgrounds to participate in experiences that developed their musical, social and personal skills, and our sliding scale payment structure meant that access to our events were accessible to families from all income levels.
