First Annual Chairman's Report

For the year covering 1st June 2019 to 30th May 2020

This year we have managed to increase our number of clients to Eight hundred and thirtyseven.

The number of trips for the car service this year was six thousand, six hundred and thirty.

We also had a bus service, which transported two thousand, four hundred and ten on regular shopping trips.

This number would have been higher but nine weeks of the lockdown was in this year, which much reduced the call on our services. We still carried out two hundred and sixty-one trips in the first weeks of lockdown.

All this would not have been possible without our loyal Staff, Drivers and Office volunteers. Five Drivers continued to work throughout the lockdown.

This year we have installed new job booking system and additional Computers in the office, which has transformed the booking process for us, giving us the capacity to handle more clients efficiently and reliably. All office staff have trained in using the new system.

A new accounting system has also been commissioned, which has simplified our invoicing process.
