#### **Parish Profile & Mission Action Plan**

#### **SOME PARISH DETAILS**

**Population**: 10,000 approx. (This figure gives some idea of the 'pastoral area' for our church, rather than exact count of the population).


**Location**: North East area of Luton, at the boundary with Herts. The parish includes the wards of Stopsley and Putteridge. The busy A505 from Luton to Hitchin runs through the parish and separates the church geographically from much of the rest of the parish.

**Type[s] of housing**: Mainly owner occupied, with some rented accommodation, and pockets of housing association or council property.

**Community facilities**: Two high schools, two primary schools, one special needs school, and a large sports complex with Olympic swimming and diving facilities.

**History of the community**: In 1862, when the church was built, Stopsley was a village. Over the years since then Luton has gradually swallowed it up and it is now a suburb of the town. Some of the major employers of people in the community over the past 100 years have closed or declined in size, but employment remains fairly high. The airport and the car industry are major employers.

**Parish boundaries:** No longer quite the same natural cohesive community that it once was but boundaries mainly make sense except confusing boundary on Ramridge Estate with St. Francis.



#### PARTNERSHIP IN WORSHIP, MISSION & MINISTRY

We are active participants in the Luton Deanery in working together in mission to our town of Luton.

20 years ago we planted Christchurch, Bushmead, a thriving church largely within what was the much larger former parish of Stopsley.

Other Christian Churches: we have a good friendly relationship with Stopsley Baptist Church and Ramridge Baptist Church with whom we have co-operated on various events and projects. SBC has a much bigger congregation, and with its better facilities and style of worship it attracts younger people and people from a wider area. We have different styles of worship but complement one another in our evangelistic task. We have friendly relations with Sacred Heart (RC). Ministers are involved in local and town wide fraternals, and we also participate in a local evangelical hub for prayer and mission, and a similar but larger grouping for the whole town.

#### **Committees**

#### **Standing Committee**

The Standing Committee is the only committee required by law, and is our only official committee. It has power to transact the business of the P.C.C between its meetings, subject to any directions given by the council. We also have a number of 'Action Church Teams' (ACTs) that organise activities, or discuss matters, as directed by the P.C.C. and Vicar.

#### **Electoral Roll**

There are 140 parishioners now on the Church Electoral Roll. This represents a change of -9 from the previous year's AGM Electoral Roll. These changes are due to parishioners moving, changing church, death or people who live outside the parish and no longer regularly attend St Thomas's.

#### **Review of the Year**

During the last year we continued enthusiastically with God's help our task, as summarised in our Church Mission Statement, of **seeking to share God's love with all**.

We continued our 'Rolling Worship' Sunday service pattern which aims to provide a wide range of service styles, and enables different congregations meeting together as one Church. It is encouraging to see each element of the pattern developing new life. We also value the midweek service, which continues to be well supported. We sought to hold accessible services appropriate to different groups, blending the best of traditional and more informal styles. Much time and effort went into trying to prepare inspirational biblically based preaching.

We presently have two regular 'homegroups', one for women, and also a weekly Bible Study. These are developing well in nurturing fellowship and spiritual growth. We consider this to be a significant part of our church life and very important for future growth, and we wish to grow other groups in coming years. The Tent Project continues to meet with high numbers of attendees appreciating their weekly gathering.

It has been another encouraging year amongst children and young people. The Sunday Club has continued to grow in numbers and the children eagerly show off their work at the 10am service. A team led by Sara Sammons, Karen Ritchie, Ruth Marshall, and now In Marshall, leads the Sunday Club programme which is enjoyable and helpful for members. We continue to appreciate our strong links with Uniformed Youth organisations. However, the Scouts and Cubs have now decided not to regularly attend the Parade Services. However, the Guides continue to do so, although numbers are not what they used to be. We started in 2018 to hold 'After Parade Parties' for the young people (not just from the uniformed organisations) which includes games, activities, food and some appropriate Christian input. The children chose the name of STUFF - St Thomas' Unbelievably Fabulous Fun! These have flourished this year and have been well attended. They included a bonfire event at Haverings, pony rides, a film event, and a Christingle service.

We continue to seek to give a warm welcome to visitors to the Church. Much effort and preparation is given to provide services that develop further an atmosphere of welcome. We

particularly organised special events to welcome people over Christmas, Easter, Remembrance and throughout the year.

Our Lunch Club continues to be well attended, with fish and chip and other lunches. During lent we held successful Lent lunches. We have enjoyed social activities that enhance our welcome to people, including quiz events, meals, and a barn dance. We also held successful monthly Coffee Mornings.

A course on Christian basics is periodically held for people within and without the Church family. Sometimes we use Alpha, other times Christianity Explored, and more recently the START Course. We have a Confirmation planned for 2020.

Baptism policy for children offers a choice between a 'Thanksgiving Service' to families who want to have a celebration service in Church but who do not intend coming to Church regularly, and Baptism for those families willing to undertake preparation to make the commitment involved in that service. Thanksgivings are generally held after the Informal Service and Baptisms are held during the main Sunday Services. We also provide detailed preparation for weddings. The weddings themselves appeared to be thoroughly enjoyed by the couples and their guests. We believe that these continue to be an important opportunity to provide a good witness for the Church, although along with a national trend the number of weddings in church have greatly decreased in recent years.

The choir continues to help lead the worship at the weekly 10am Family Communion and other services. Thanks are due to John Alexander, our Director of Music, who leads the Choir and plays our church organ. Our Music Group continues to creatively lead our Informal Service, and this is much appreciated by those who attend that service. Thanks are due to David Newbound who leads the meditation group, which is much valued by those who attend, and which enhances our spiritual life. We are grateful to all who have helped with the maintenance of Church and Churchyard, especially Ian Clitheroe, and those who clean our Church, and to the flower arrangers. Their hard work enhances our worship.

The Pastoral Care Team continued to meet regularly to oversee some of the pastoral needs in the Church, and have done marvellous work, which has included visiting, delivering cards and arranging lifts. Parishioners are asked to inform the Parish Office if visits or help is needed. We are very fortunate that David Newbound is 'released' (not least by the sacrificial support of his wife Debbie) into his ministry as Pastoral Worker. This has enabled the Church to greatly enhance the pastoral ministry and support that the Church offers. During 2019 Debbie began her ministry as Parish Nurse and this has been very successful and highly valued by church members and also those outside the church family. Early in 2020 Debbie's submitted portfolio passed the examiners with flying colours, and full accreditation will be achieved.

The witness of individuals in their community, work and leisure environments remain vital for our evangelistic mission. The Vicar is involved in ministry to the workplace with chaplaincy work at Vauxhall Motors. David Newbound has been chaplain at NOAH centre of the homeless and at the coffee shop in the village. Steve Dolby is also involved in chaplaincy at Asda. Many of our members help serve at the NOAH 'Soup Kitchen' for the homeless. We have also been keen to support the World-wide Church, particularly focussed through our links with 'Hands of Mercy' in the Philippines. Our Church has been open for prayer and visitors during weekday mornings. We served the community in caring for bereaved people

at the time of funerals and welcome them to an annual Commemoration service, as well as other services.

The Parish Office continues to handle much of the administrative work of the Church. We are grateful for the service of Linda Clitheroe, who during the year stepped down as our Administrator after 18 years! Deborah Bachini has efficiently stepped into her shoes and is now our Church Administrator. We are very grateful for the hard work she does in the Office.

Communications within the Church are good through a new website, advertising our events, and a weekly newsheet, the details of which are also projected onto the Church screen. Communications with the wider parish through our magazine is greatly appreciated by large numbers inside and outside of the Church family. Our thanks to the editorial team and to Tony Clitheroe for all their hard work in producing our magazine. We also contact interested people through emails and WhatsApp messages advertising services and events, and have a social network presence on Twitter and Facebook.

We have continued to run our Stewardship Scheme. We are grateful to everyone who responded to stewardship initiatives, and all the Finance Team, our Treasurer, Neil Rolls, and our Stewardship Secretary, Les Sims, and the skilled help of Sarah Vyvyan. Full details of the finances are provided in the relevant reports and the presentation at the AGM.

We wish to thank many, both Church members and others, who have contributed to the ongoing work of the Church in the last year. Gratitude is due to all involved in leading and preaching at services, especially Ruth Barr, whom was our Curate until July 2019, for this and all her much appreciated ministry in the church and wider parish. She has now taken on a parish near Hatfield and a large contingent of StTs people went to her Licensing Service on 23rd September 2019.

Many thanks are also due to Rosemary Stipta and John Pinnock for all their work with the audio and visual enhancement at our services. We are also very appreciative of the sacrificial work of our

Churchwarden Ian. The PCC wishes to thank all those who contributed to the services: as sanctuary assistants, sidesmen/women, readers and intercessors, not forgetting all who provided welcome refreshments after the morning service and on other important occasions, and also to those who have helped provide such excellent food at Lunch Club and at other events. We are also grateful for the group of volunteers who have helped at Coffee Mornings and in many other ways as well.

We look forward to the future with confident hope in God as we share His love together.

#### Warden's Report

After serving St Thomas' as a Warden for 8 years, Steve, reluctantly, decided to step down as a church warden, to allow more time for his growing commitments in other areas of his home and church ministry. I owe Steve (and his lovely wife Ann) a huge debt of gratitude for all the support and encouragement he gave me while I was getting my feet under the desk

and I shall miss him greatly. He still gives me a lot of support and encouragement on working groups and elsewhere.

Partly due to the above, 2019 has been another challenging year at St Thomas' given the range of problems and issues that we are facing as a church but I am very glad to say that my workload has been lightened considerably thanks to the unstinting work that Deborah Bachini puts in week after week, largely making sure I don't make a complete idiot of myself. This has been a blessing especially given that we have had a 'quinquennial' survey to cope with.

That has raised a host of costly issues that need to be dealt with, some immediately, some within 12 months and the rest over the next five years. Given our parlous financial state, as income reduces while expenses go up, and the fact that we are heading towards a possible deficit in the coming year of approximately £25,000, finding the extra money needed to cover essential repairs to the fabric will prove exceedingly challenging.

As ever, our financial situation is a continuing source of concern as we struggle to balance our books. We are simply not generating enough income on a regular basis to cover our monthly costs which we have pared down almost to the bone. This has brought into question whether or not we can continue to share our God given wealth with those who are much less fortunate than we are. At the moment we are committed to give 10% of our income to a small number of very worthy charities but inevitably we may have to reconsider this if things don't get better. It is our firm belief that, within the body of St Thomas', God has provided us sufficient resources financially and in human skills and talents to not only make ends meet but to create an abundance of material and spiritual wealth.

Part of Discipleship is accepting that, as all things come from God and that we are only returning to Him that which He has given us in the first place, we must seek His will for every part of our lives and trust and obey Him, even if it 'hurts'. If we embrace this, then He will shower us with innumerable blessings, riches and good gifts. If we don't, then we shall be facing yet another year of agonising decisions in connection with our finances and having to cope with the consequences of our actions.

On a more positive note, the alarming cracks in the sanctuary walls look much worse than they are and the architects say there is no risk of collapse or immediate danger.

Notwithstanding that, this situation will need to be addressed at some point. Also, our heating system is now up and running and we are all reaping the benefits of a cosy church building.

Following a conference last March run by Revd. Canon Robin Gamble on church growth we have adopted, and are adapting and applying the recommendations put forward by Robin and his team. It is early days yet as this campaign is designed to bear fruit over a long term and should provide a strong foundation for building up a church of discipleship in service and giving: however, there is still the more immediate need to make ends meet financially.

'START' is a course on fundamental issues and concerns which all Christians, both new and established, can benefit from, so I would suggest that everyone gets booked onto the next 'START' course and gets 'stuck in'.

Our Sides men and women, now referred to as the 'Welcome Team', continue to do a magnificent job every Sunday and we have received several encouraging comments from regulars and visitors to the church about the warm and genuine welcome that they receive. First impressions mean a great deal and, for most people, the first person they see on a Sunday is a member of the Welcome team. So, well done to all.

Hopefully, 2020 is not going to be a year of more stumbling blocks where we lurch from one problem to another: rather that we all commit to trust and obey Him with our God given time, skills, experience and money and embark on a journey of 'stepping stones' allowing God to honour His promise to shower us with countless blessings, gifts and riches? Only God knows the answer to that question.

#### Safeguarding

Judi and Linda meet up monthly with the Vicar to review our safeguarding at St Thomas's. This important role has become more demanding since the end of 2019, due to new Church of England recommendations.

There is now a safer recruitment procedure that we have to follow whenever a person, volunteer or paid, would like to take on a new role within Church life.

Judi and Linda have spent a lot of time this year attending courses and trying to make this practical for our church. There is now a full application, interview and acceptance process to be followed for helpers in all areas.

Using this new process, we have completed seeing one person through for Sunday Club and are in the process of getting others through too. This is all in addition to DBS clearance and relevant training for those with roles involving children and vulnerable adults.

Although this all sounds a lot of hoops to jump through, we are happy to do so if we can keep St Thomas's a safe place. It is known that certain people with problems are attracted to Churches, where they are welcomed into the Church family. This has long been recognised and even more so in the light of some of the more serious historical abuse cases which have come to the forefront of the news in recent years. It is the task of all of us to be observant and know that the correct procedure for reporting any concerns, **however small**, is to contact either the Vicar or Safeguarding Officers as soon as possible, and all concerns will be treated with confidentiality.

We are very grateful to the Safeguarding Officers at St Albans for their help and guidance in any problem we have raised.

#### **Home Groups**

living in dwellings that were ramshackle. Some of the homes were awful - tiny, claustrophobic, no natural daylight, barely enough space for one person let alone all the people living there. The streets were often cramped, with stray dogs, stray cats, cockerels (and rats) abiding, open drains and electricity cables (many of them illegal) running through. The living conditions are **really tough** out there.

I really thank God that I also saw incredible love out there - love from the staff who themselves are so reliant on programmes like the Family Support Programme so that they can feed their own families. Love within families for one another - without which there would be great cause for despair. Love from God expressed through the practical help and support that **Hands of Mercy** provides."

If you are a supporter of the compassion ministry of Hands of Mercy International, you are making a MASSIVE difference in the Philippines. The staff asked Sam again and again to thank you for providing support – whether it's food each month, education for a child or medication that literally keeps people alive, every single pound and prayer makes a difference.

#### **Stewardship Report**

Thank you to everyone who has faithfully committed to supporting the Church this financial year (2019). The "Gift Day" appeal at the end of November raised £3607.00 and resulted in a final figure of £4169.50 after taking gift aid into consideration. As you can appreciate, with increased running costs year on year, regular stewardship giving and "Gift Day" donations are more important than ever. However, stewardship is not only about money, it is also about giving time and practical help to St. Thomas's Church.

At 31<sup>st</sup> December, 2019 there were 78 members (couples counted as one) in the Scheme. This is a net reduction of 11 members from the previous year. This is a mix of people leaving and the deaths of some of our long- standing members. Therefore, as we press on into 2020 there is a continuous challenge to meet the Church's running costs and the Parish Share.

As you will be aware from last year's report (2018) a card payment scheme was introduced in December, 2018. It is aimed at those who do not carry cash and enable them to contribute to St. Thomas's work within the church and the parish. It has become a regular item at our services, and I am informed that £1889.00 was donated by this method in 2019. A splendid achievement considering this is money that would not necessarily have been collected through the plate offerings.

In terms of giving your time and practical help to St. Thomas's Church there is a need for Sunday Club helpers, cleaners, litter pickers and people to carry out odd jobs, etc. The list is endless. If you are in a position to help please talk to the Churchwarden or the Parish Administrator at the Parish Office.

## St Thomas' P.C.C. Stopsley, Luton Notes to the Financial Statements for the Year ended 31 December 2019

#### 1. Accounting Policies

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 together with applicable accounting standards and the Charities SORP.

The financial statements have been prepared under the historical cost convention except for the valuation of investment assets, which are shown at market value.

#### **Funds**
