TRUSTEES' ANNUAL REPORT

REFERENCE AND ADMINISTRATION DETAILS

The principal address of the charity is:-Brading Youth and Community Centre High Street, Brading Isle of Wight, PO36 0DH

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is registered as a Charitable Incorporated Organisation (CIO) under charity number 1172210, and was registered with the Charity Commission on 22 March 2017.

Trustees are selected on the basis of their skills, and willingness to volunteer to serve the residents of Brading. Training for the Trustees is provided. Our board of Trustees has been strengthened this year by the appointment of two new Trustees both of whom have considerable experience of working with young people.

OBJECTIVES

The charitable objectives of the charity as set out in the constitution are: "To further or benefit the residents of Brading and the surrounding area, without distinction of sex, sexual orientation, disability, race or political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the objective of improving the conditions of life for the residents".

ACTIVITIES AND ACHIEVEMENTS

During this financial period the first phase of the building refurbishment programme was completed, providing us with a new kitchen and new windows throughout the building.

This refurbishment has given us a much improved venue enabling new activities to be introduced into the Youth and Community Centre. We have also acquired access to an allotment in Brading on which our young people will be encouraged to grow vegetables for their own use and for distribution throughout the town.

The popularity of our Community café has also increased as a result of these improvements attracting not only members of the community, but also local clubs and visitors.

Youth Work

- Continued delivery of a Youth club which is open four nights per week.
- Introduced new activities The Cook and eat project for young people, delivering the life skills of cooking and eating healthily, including hosting and cooking events for our volunteers.
- Liaised with our local primary school in the provision of lunches and activities/entertainment during holiday periods
- Started a new after school club the Grub Club, which will build on the success of our cook and eat project to include growing vegetables on the allotment, and the opening on a regular basis of a 'restaurant' for all members of our community.

Community Initiatives

- Extended the opening hours of our 'Community Café' to accommodate the demand and significantly increased the number of volunteers willing to help in running the café.
- Maintained links with other Brading based organisations (e.g. BCAG, BRAG, Primary school) to maximise the
 opportunities available to these local organisations.
- In addition to providing a venue for weekly clubs and societies, the Centre has been booked by several local organisations (e.g. Brading Community Archive Group) for their weekend events/exhibitions.

Fund Raising

- A team of BCP Trustees, volunteers and members continues to apply for grant funding in line with a fund raising strategy document approved by the Trustees.
- Received financial support from HIWCF for the initial cook and eat project, which was subsequently extended to the Grub Club project, thanks to significant funding being received from the Henry Smith Foundation for one year and the Tudor Trust for two years.
- Raised a net surplus of £4,500 through our Community Café and donations from clubs and societies using the Centre

Building

- With support from Men in Sheds we started a programme of internal decoration and general maintenance work. This is
 ongoing.
- Lined out the car park to make parking easier for our visitors and club members
- Completed preparatory work for our next two major projects i) replacement heating system, ii) improved toilet facilities

FINANCIAL REVIEW

The accounts for the period show a net surplus of £17,053 (2019 £4,025). This surplus is almost entirely due to funding of £15,000 received in February 2020 to cover the running costs, support our new Grub Club project, and of other projects currently in planning. A further £1000 was received for decorating the outside of our building which is yet to be completed.

Grant funding received to cover the fixed costs associated with running the Youth Club are shown as unrestricted donations (£27,669).

Café sales of £5,520 (2019 £2,170) reflect the increasing appeal of the café and the Centre as a social venue and have slightly exceeded our budget forecast of £5,000.

Staff costs in 2020 reduced significantly £16,337 (2019 £21,977) as a consequence of one of our Youth Club Leaders leaving us to take up a new post as a teacher. His vacated position was covered in part by the appointment of a part time administrator and an increased reliance on volunteers to help run the Youth Club. These staff costs are likely to rise again with the appointment of a project leader to take responsibility for running the Grub Club.

The significant reduction in gas charges £524 (2019 £785) which has been realized in spite of the additional usage of gas by our café operation, can be attributed at least in part to our new windows reducing our heating requirements. The even more significant reduction in our water bill £345 (2019 £791) is down to some excellent maintenance work by our Men in Sheds team. The increase in our electricity charges is believed to be a consequence of the success of our café.

BCP consider that it will maintain a level of unrestricted funding required to meet the monthly fixed costs applicable at that time for a period of 4 months. Should our unrestricted funding fall below this level then the Trustees will meet and agree on operational changes that will reduce our running costs to a level that could be supported by our available unrestricted funds for a further 6 months.

On 17 March 2020 the Trustees agreed unanimously that all BCP activities involving the use of the Brading Youth and Community Centre should cease with immediate effect in line with Government advice. Our Youth Leader was furloughed pending a re-start of Youth Activities while our Admin Assistant continued to work from home until her resignation in June 2020. Our plans for the Grub Club were also put on hold, including the appointment of a part time employee to lead this initiative.

These actions have reduced our fixed costs to a minimum and with the aid of a £10,000 grant from the IW Council, we expect to be in a position to re-start our planned activities as the government restrictions allow.
