- 1 The financial statements have been prepared on the receipts and payments basis in accordance with section 133 of the Charities Act 2011.
- 2 The Charity operates an unrestricted General Fund that can be used in accordance with the charitable objects at the discretion of the trustees.
- 3 None of the trustees were remunerated in their capacity as trustees.

Four trustees received honoraria to cover their out of pocket expenses as follows:-

### INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF BORDER TERRIER WELFARE [Registered Charity No. 1116853]

I report on the accounts of Border Terrier Welfare for the year ended 30th June 2020 which are set out on pages 10 and 11.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

Having satisfied myself that the charity is eligible for independent examination, it is my responsibility to :-

- examine the accounts under section 145 of the 2011 Act;
- to follow the procedures laid down in the general Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act; and

#### Basis of independent examiner's statement
