ANNUAL MEETING OF PARISHIONERS

- 1. Welcome and Apologies for absence.
- 2. Resolution that Section 3 of the Churchwardens Measure 2001 shall not apply (disqualification where a person nominated for the office of Churchwarden has served for six successive periods of office)

NB. Thom Simons was elected as Churchwarden on 26 April 2015, when Tony Aldridge stood down. He will have completed six successive years as Churchwarden in 2021 and would not be eligible to stand as Churchwarden without a 2-year break. Should Thom be prepared to continue as Churchwarden after 2021 and should the Annual Meeting of Parishioners wish him to do so, it will be necessary for a Resolution to be in place to the effect that Section 3 of the Churchwardens Measure shall not apply. Because that Resolution has to be in place before the start of the 2021 APM (Thom could not otherwise be nominated for Office and could not sign the Nomination Form and pass it to Fr Michael before the meeting, as legally required) best practice indicated that the Resolution needs to be passed in the preceding year, i.e. 2020. Hence this item on the Agenda.

The Resolution can be revoked by the APM at a subsequent APM, so if Thom chose not to stand for a further term, then it could be revoked if the Parish so wished. For the avoidance of doubt, and having discussed the legal position with Nathan Whitehead at the Diocese, the interpretation of the legal provisions by learned authors suggests that the Removal of Section 3 applies to the Parish and not to the person. Accordingly, if the Resolution is passed, it would cover not only Thom but also Derek if he had served his 6 yrs and wanted to continue. Both would be eligible to do so. Of course, subsequent APM's could revoke the Resolution and return to the normal position. The normal position would then apply to any person seeking election as a Churchwarden – i.e if they had done 6 successive years, they would not be able to stand again without a 2 yr break.

PARISH OF GREAT BURSTEAD with RAMSDEN CRAYS MINUTES OF THE ANNUAL MEETING OF PARISHIONERS AND THE ANNUAL PAROCHIAL CHURCH MEETING (Held on Sunday 28th April 2019)

<u>At 11.30am</u> Fr. Michael Hall (MH) welcomed everyone present and opened the meetings in prayer. He then explained the eligibility to vote and how those entitled to vote at the AMP included residents in the Parish as well as those on the Electoral Roll of our Church. Those entitled to vote at the APCM were only those on our Electoral Roll.

THE ANNUAL MEETING OF PARISHIONERS

Present: Revd. Michael Hall (MH) [Chair] and 30 parishioners.

Apologies: Norman and Gill Maxwell, Jo Hall, Sheena Cope

Appointment of Secretary: Derek Oakley was appointed Secretary

Election of Churchwardens: Only two nominations had been received, namely Thom Simons (TS) and Derek Oakley (DO). There were no other nominations and, accordingly, their appointments were confirmed for the forthcoming year.

The AMP was closed at 11.35 and the APCM proceeded

THE ANNUAL PAROCHIAL CHURCH MEETING

Notification of AOB: None received

Approval of Minutes: Approval of the minutes of last year's meeting held on 28 April 2018 was proposed by Margaret Flack and seconded by Grahame Rudkins and agreed without amendment. 2 abstentions

Matters Arising: None notified that were not dealt with in Reports

Appointment of Tellers: Mary Edwards and Graham Bruce kindly volunteered and they were accepted by the meeting.

Churchwarden's Report: A written report prepared by Thom Simons on behalf of the Churchwardens had been circulated with the Papers prior to the meeting. There were no questions and the Churchwardens were thanked for their report and for all the work that they had carried out during the year. Derek thanked all those who had participated in the life of the Church in any way and asked Parishioners to offer help whenever and whereever they could in order to share the load.

Annual Report: Circulated with the Papers prior to the meeting. There were no comments or questions.

Electoral Roll Officer's Report: Peter Bowyer (PB), the Electoral Roll Officer, gave his Report. There was a new Electoral Roll this year and there were now a total of 69 names, of whom 41 (59%) were resident within the parish and 28 (41%) were non-resident. PB was thanked for his report. DO reminded the meeting that the production of a new Roll tended to remove (for various reasons) a number of names that had previously been on the Roll. These figures were now the ones that we would refer to in various returns to the National and Diocesan Church.

Election of Assistant Churchwardens: MH reminded the Meeting that in our Church, the role of Assistant Churchwarden was an honorary role and DO explained that at our last APCM it had been agreed that this election would only continue whilst our current Asst. Churchwardens, Mary Edwards and Andrew Lingard-Kay were willing or able to stand. After that, the matter would be referred to the PCC for consideration. ALK was not present to make his views known. It was therefore agreed that ME would serve as Asst. Churchwarden and ALK would be asked and would only serve if he was willing.

Election for one casual vacancy as Deanery Synod Representatives: The Meeting was reminded that, because Deanery Reps served for specific three-year periods, there was now only one year to serve for any newly elected Deanery Rep. If someone felt called to try it out, it would therefore only be for a one year period at this stage. There were no additional nominations, however, and Peter Furness and Micki Lake continue as our Representatives.

Election of PCC Members: DO reported that a number of people had been nominated at last year's APCM. PCC Members usually serve for 3yrs, but in order to avoid a large number of people retiring at the same time, the Church allowed for retirement by Rota. Lots are cast and some retire after 1 yr, some after 2yrs and some serve the full term. Folo Olukoya had retired this year under the Rota provisions but was standing for re-election this year. Carol Simons had come to the end of her 3yr term but was standing for re-election. Unfortunately, Alison Ingleby was found to be ineligible last year, but was eligible this year and was now standing for election. MH reported that there were a total of 5 vacancies and 3 nominations had been received as previously indicated. As there were no further nominations, Alison Ingleby, Carol Simons and Fola Olukoya were accepted as PCC Members by the meeting.

Churches Together in Billericay (CTB): We are entitled to have three lay representatives. Margaret Flack explained the nature of the role and offered to continue as a representative. Bev Price also volunteered to serve in this capacity. Proposed by Carole Heywood and Seconded by Carol Simons. This was agreed with thanks.

Billericay Schools' Ministry: We are entitled to one representative. Margaret Flack had volunteered last year and was waiting to hear more. Margaret was content to continue to be our representative and this was agreed with thanks.

Treasurer's Report and Accounts: Mary Edwards (ME) had provided copies of her Financial Report and Accounts and a Summary thereof. She explained that it was only because of our investment income that we were still able to meet our Parish Share. Our investments had performed poorly last year but had recovered somewhat recently. There were no questions. ME expressed her grateful thanks to Bev Price for her help with the weekly freewill offerings and also to lan Rudkins, our Examiner. It was agreed that a letter of thanks should be sent to lan.

Appointment of Independent Examiner: Ian Rudkins had kindly offered to act as Independent Examiner again this year (assuming that ME would be Treasurer) and this was unanimously agreed.

Appointment of Sidespeople: A list of those who acted in this capacity at the various services was circulated with the papers prior to the meeting. More assistance would be appreciated to help with these duties, but DO reported that, strangely, it appeared that Sidespeople could not be appointed other than at this meeting. This problem had come to light because we had wanted to add Andrew Lingard-Kay as a Sidesperson, but were unable to do so. ALK helped out at 8am Services and fortunately, he had been able to do this as a Server. However, it would be good to have him on the list. Unfortunately, Andrew was not present to make his views known. Peter Bowyer pointed out that David Poulter was not on the new Electoral Roll and it was not clear whether he could be elected as a Sidesperson. DO proposed therefore, that those on the List should continue to serve. In the case of ALK, he should be added as a Sidesperson if he was willing to do so. In the case of David Poulter, he should be included, subject to confirmation that he still qualified. Seconded by ME and agreed.

Appointment of Person to oversee Safeguarding Issues: Tamsyn Taft is our existing Safeguarding Officer and had kindly agreed to continue in this role. There were no other volunteers and her appointment was therefore approved by the meeting.

Basildon Deanery Synod Report: A written report by Mary Edwards had been circulated with the papers prior to the meeting. There were no questions and the report was accepted by the meeting.

Reports of Church Organisations and Clubs: Various written reports were circulated with the papers prior to the meeting. There were no questions. All concerned were thanked for their contributions and there was a plea for more volunteers. DO commented that these Reports showed how much was going on in the life of our Church and how many people played a part. On behalf of Norman Maxwell he also reminded the Meeting that the Fete this year was on Saturday 29th June 2019.

AOB: None notified

Vicar's Report: Fr Michael began by reflecting on how he had enjoyed our fete, the baptisms and all the weddings he had officiated over. On each of these occasions he felt that we came together as church, we were joined by new people, and it was wonderful to see how some of the new people were continuing to keep in touch. He expressed his thanks to various members of our Church: Fr Graham and Fr Peter for all their support to him and our church; to our churchwardens for their service this last year and their continued offer to serve this year; to all the members of the PCC for their hard work; to Emma and the choir for their much valued and much appreciated contribution to our worship; to Norman Maxwell and all the other members of our church who worked so hard in getting our fete right and ready for us. He also wanted to thank all the people of our church who worked behind the scenes and who never receive much recognition, but without whose faithful service things at our church would not be the same. He hoped that they would long continue doing what they did for us.

Last year he had suggested that his focus needed to be on teaching and administration. Perhaps it was prophetic because this last year, with the Church of England's focus on GDPR and upon Safeguarding and other legislation, we had been busy in terms of administration. Fortunately, Thom and Tamsyn had helped do much of the work in ensuring that we were compliant in all areas and we should be grateful to them. With regards to teaching, he could safely say that we had done as much as we could with what we had. In a dream world it would be lovely to think that all of us had infinite time to join groups and to lead groups, but we live in the real world and we had tried to do as much as we could. Quite an amount of his own time had been taken up with pastoral work including working alongside Christians Against Poverty in bringing much needed support to an individual in our parish. He knew that other people in our parish had also been similarly occupied. We had tried some new things. Some of them ,such as the PCC away day had gone and he wanted to repeat the experience soon. Other things such as the YEW Fellowship hadn't quite gone to plan, but rather than give up on them, he wanted to carefully pursue them with patience, prayer and hope that over time God would come through.

This last year we had to be patient and wait for all sorts of things to start, to begin and to arrive, such as the tables and chairs at the back of church. He knew that this waiting for some had been frustrating, but the fact that we had persisted even when things had been slow, said a lot about us and we should be proud of this. In the church things do sometimes take a long time to sort out, and sometimes the delay is caused by things outside of our control. Last year he mentioned we had been joined by some new people. New people to Messy Church; new people to the Yew Fellowship; new people had come to our Celtic Service and he was hopeful that when we do such things as relaunch the Yew Fellowship this year, perhaps under another name, we would see some other new people joining us. Growth can be slow and while statistically it may look like there is nothing happening, seed is nevertheless being sown and over time he believed that, by God's grace, this seed will fruit. Overall, he had been pleased with how we had

acted and operated as a church. We had striven, we had worked hard and though we have had the occasional stumble on the road, we had picked ourselves up, dusted ourselves off and then continued strong.

He wanted to conclude by thanking everyone for all their support to him and his family. His family's welfare was important to him and it meant a lot to him to know that their welfare was important to the Church too.

His personal aim this year continued to be to serve as the best priest he could be. His focus would be upon prayer and spirituality and how we can better serve our parish pastorally. His hope was that, with the prayers and support of the Church, this next year would be another good year for St Mary Magdalene Church - faithfully serving the people of Great Burstead and Ramsden Crays.

After Fr Michael had given his report, DO reminded the Meeting that, in the PCC Report, we had pointed out that over 4,000 people had attended our Church for Weddings, Baptisms or Funerals. For some, this was the only opportunity to experience Christian worship or teaching. Fr Michael and Fr Graham had ministered at most of those services. This was an important part of our Ministry – planting seeds - and he wanted to thank Fr Michael and Fr Graham for all that they did in this respect.

Fr Michael thanked all those who had attended and the meeting ended at 12.15pm with a prayer (MH). The new PCC was asked to stay on for a very short first meeting immediately after the APCM

- Pewsheet in the new format continues to work well
- Gutters cleared without the use of a third party.
- Full compliance with our responsibilities with GDPR

We would like to extend our grateful thanks to all readers, prayer leaders, sidespersons, all on the cleaning and flower rotas, the choir, all those who help with the production and delivery of our revised Events leaflets and anyone who has helped in any way with the running and maintenance of our beautiful church and the delivery of excellent Services to our parish and beyond. A special thank you goes to Father Michael, Father Graham and Father Peter for all that they do.

Item 7 Annual Report of the PCC for the year ending 31.12.19

Alison Ingleby PCC secretary

The PCC has the responsibility of co-operating with the incumbent Priest in Charge, Fr Michael Hall, in providing in the above ecclesiastical parish, the whole mission of the Church; pastoral, evangelistic, social and ecumenical. In this respect, we very much value the continuing and regular assistance of Fr Graham Laut, a retired priest, in working with Fr Michael in many aspects of parish life. We also continue to value and enjoy the assistance of Fr Peter Clark, a retired priest who also regularly worships with us.

The PCC also has maintenance responsibilities for the Church and Church Hall at Great Burstead and the Burial Ground at Ramsden Crays.

The PCC also wishes to thank everyone who has volunteered to support the work and life of our church in any way. Hundreds of hours are given by our volunteers and the PCC is very aware that the whole mission of the church could not continue without such sacrificial giving.

In discharging its functions, the PCC has due regard to the Charity Commission's public benefit guidance where relevant and to compliance with relevant legislation, including health and safety, disability discrimination and safeguarding. The PCC receives regular updates on relevant matters and the Diocese provides training in various areas which many of our members have benefited from. The PCC is particularly grateful to our Data Protection and Compliance Officer (Thom Simons) and Safeguarding Officers (Tamsyn Taft and Derek Oakley) for their input and assistance.

We have two Churchwardens, Thomas Simons and Derek Oakley and we are grateful to both for their energy and contribution to the life and work of the Church.

The experimental change in our Service times has continued and is kept under review. The BCP Evensong remains on the 1st Sunday of each month, with our Celtic styled service continuing on the fourth Sunday, led by Fr Graham and members of the congregation. No regular pattern is emerging for the 2nd 3rd and 5th Sundays and this is being kept under review. Previously introduced initiatives continue. Please also see the Reports from Fr Graham and others with these papers, concerning various areas of Ministry, including The Celtic Service; Ministry to the Sick and Housebound; Messy Church and Lectio Divina.

Weekly Pew sheets keep members informed and we are grateful to Fola Olukoya for making this possible. This year, as part of the 10 areas of PCC focus, we have experimented with a change of format and have been able to incorporate the prescribed readings and Psalms into the Pew Sheet with the aid of Redemptorist publications. The change has proved to be generally popular and helpful to the congregation. Newsburst, our Parish Magazine, continued to reach out to the Parish in June and was replaced by a new Event leaflet with similar information for the Christmas period and coming months. We are grateful to Clare and Susan Morley for their skills in producing Newsburst and to Mary Edwards for producing the Event leaflet. As ever, Kathy and Martyn Heald and the dedicated team of deliverers did wonders in ensuring that Newsburst was distributed to over 5000 houses in our Parish. The Team also assisted the Village Council with the distribution of Village Voice.

We have developed a stronger presence on social media and thanks are given to Claire Morley, Thom Simons and Tamsyn Taft. We regularly promote church activities on Facebook and our website. Nevertheless, the PCC are conscious of the increasing relevance of Social Media and will be looking at the whole question of how we address this. Our website grows in attractiveness and the number of "hits", thanks to the efforts of Thom Simons and Clare Morley.

The Diocesan Proposal to "Re-Imagine Ministry" and the Deanery Plan to link up in Mission and Ministry Units (MMU's) remains incomplete but continues to receive consideration.

We continue to pay our Parish Share in full and we thank our Treasurer, Mary Edwards, for her skill and hard work on our behalf. Of course, we could not achieve this without the generosity of our congregation and the donations received. In addition, we thank God for the generosity of those who have remembered our Church in their Wills and the families who have so kindly made donations in memory of their loved ones. These gifts enable us to do so much more in furthering our Mission and in looking after our beautiful Church and grounds. We have been able to complete the project to open up the seating area at the back of the Church and to provide comfortable and attractive chairs and tables. This has been successful and practical.

At the end of October 2019 there were 69 names on the Electoral Roll, a reduction of 19 (88*) names from 2018. The average net weekly attendance at all services on a usual Sunday (as calculated for the purposes of the October survey) was 45 (50* and 55**), we had 97 at Easter (130*) and Christmas 201 (523*). 10 children were baptized this year, the same as in 2018. 7 couples married in our church (8*). Sadly, there were 41 funerals conducted by our clergy (50*)

During the year over 4000 people attended our church in 2019 for weddings (or marriage blessings), baptisms or funerals.

For some of those attending, this may have been a rare, or perhaps the first, opportunity of experiencing Christian worship or of hearing the Word of God and the Christian message proclaimed. For some, the Service would have been preceded by a time of preparation and Christian teaching. We consider that this is an important (and perhaps underappreciated) part of our Ministry. Whatever happens on the spiritual journey of these individuals (and whether they choose to worship with us or not), we will continue to hold them in our prayers and believe that we have been part of the planting and nurturing of God's seed in their lives. We certainly pray that all those who have come to us will have found something of the presence of God in this place.

The PCC

Members of the PCC are either ex officio, co-opted or elected by the APCM in accordance with the Church Representation Rules. All church members are encouraged to register on the Electoral Roll and stand for PCC Election. A list of PCC members who served during the last year is listed below. The PCC usually meets bi-monthly on Tuesday evenings in the Church hall.

The role of PCC Secretary was undertaken by a new member to the PCC, Alison Ingleby, who took over the role from Derek Oakley.

Committees

The PCC also operates through a number of sub-committees, which meet between full meetings of the PCC.

Standing Committee

This is the only committee required by law. It has power to transact business on behalf of the PCC and is subject to any specific directions given by the council. It is composed of the incumbent, the Churchwardens, the Treasurer and appointed members of the PCC.

Church Hall

The Committee attends to all matters relating to the church hall, including lettings, maintenance and repair and financial records. Thom Simons has been our excellent church hall manager again this year and has worked very hard to ensure that the hall is well run and fit for purpose.

Social

Organises parish socials – it aims to break even financially and operates within its own budgetary discipline

Church Fete

Plans and organises this traditional annual fete held in the grounds of the church, including liaison with exhibitors, entertainers and stall holders. The fete was successful and we thank all those involved.

Garden Maintenance Team

The team is small in number (and further volunteers would be greatly appreciated) but they help to ensure that our beautiful church grounds are kept and maintained. They also take on the mammoth task of keeping the grounds clear of leaves during and following the Autumn fall. This is no easy task and they are to be congratulated.

Finance Group

Meets annually to discuss the fees/honoraria for the following year and to provide recommendations to the PCC. The Group also recommends potential donations from Church funds to charities which the PCC might wish to consider and approve. The PCC try to choose recipients from local, national and church based charities and try to take into account what is topical at the time. Arranged and chaired by the Treasurer, it includes the Vicar and Churchwardens and appointed members of the PCC, but may co-opt non-PCC members if they are relevant to its role.

The overall result -The temperature reached 34c on June 29th and some of us found it a little difficult, especially in the car park! About the same number of visitors as usual turned up but stayed for a shorter time on average because of the heat. It was an extremely happy occasion enjoyed by most people, thanks to the efforts of church members and their families and friends. Profits were 25% down on 2018 (which was a record for recent years) but a very worthwhile contribution was made to church funds in 2019.

Food & drink - Both the barbecue and marquee functioned extremely well and we really appreciated last minute helpers for the ice cream stall.

Stalls - collectables and bottle raffle had an excellent year. Other stalls varied in success, depending on their positioning in the heat. Plants, for so long the major stall at our fete, was deliberately reduced in scope but still made a very worthwhile contribution in 2019. It remains one of the main attractions.

Arena performances - Fusion Dancers, Tilbury Band and Mayflower Morris Men gave their usual polished performances. Dance Trix gave an enchanting performance with young children.

Christian outreach - Messy Church was successfully present as usual. Jesus Deck was a good innovation. However footfall in the church itself was quite low.

Publicity and preparations - Publicity (Newsburst, banners, posters etc.) worked well. The contribution from the Payback Team was good, as were the efforts of members of our congregation for the set up and dismantling.

Grand Draw - and involving our local community - Although a little less successful financially than the previous year, our Grand Draw made a very good contribution. Also it has proven to be a great way to involve the local community, including kind donations from local traders. Many Billericay folk seem to recognise our church by our fete - or FAB as it is still called.

Looking forward to 2020 - Both the PCC and fete organisers were involved in careful discussion as to whether our church community has sufficient energy to plan future fetes. The outcome was that there is great enthusiasm for continuing in 2020, albeit with some church members needing to change their contributions. Alison Ingleby has kindly agreed to lead our fete for 2020. The theme of the fete will support the Billericay Mayflower 400th year anniversary celebrations. We shall also do our best to make our fete more appealing to younger generations. We estimate over 1,000 people attend our fete each year – neighbours, friends and well-wishers for our church.

We continue to see Dizzy Ducks thrive and grow and Dance Trix continue their bookings, these are our main bookings. It was decided by the PCC that we would not have any adhoc bookings including parties. This was decided as we had quite a bit of damage after one party, the repairs for which took me well into the night / early morning so that the hall was usable by Dizzy Ducks for the next day.

Lights within the kitchen, hallways, entrance, and both toilets have been upgraded to LED lights, this was mainly because the old ones were starting to burn holes in the plastic tops and, one very nearly caught fire! It will also save us some money annually which is a bonus. The men's toilets have been upgraded and painted a nice blue colour. The sink has been upgraded which is now sitting on the same type of worktop to the kitchen, making it tie in nicely together. A nice new hand dryer has also been added. The main hall has been painted inside temporarily to sprue it up but the entire building is in dire need of a full make over, except as above, the men's toilets. I will attempt to get contractor prices for 2020 in a view to complete late 2020 early 2021.

The CCTV system continues to work brilliantly and is a great addition to the hall's security. The hall accounts are looking healthy - during the period of 01.01.2019 and 31.12.2019 our income was £27,204.12 which is another yearly growth, for this year it was a growth of £2,715.84 (+11%) compared to the same period in 2018. Our expenditures were lower this year at £8,709.54, meaning for 2019 we had a net income of £18,422.58, an increase of £6,972.94 (+60.9%) compared to the same period in 2018.

Our contact details are available in church, and people can also make contact through Fr Michael.

If we hear that the person/situation needs continued prayer, then we will carry on. The person who makes contact can give as much or as little information as they feel comfortable.

1 ACCOUNTING POLICIES

a) Basis of accounting

The financial statements have been prepared in accordance with the Church Accounting Regulations as amended by the Church Accounting (Amendment) Regulations 2006 together with applicable accounting standards and the Statement of Recommended Practice: Accounting for charities.

b) Funds

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted.

The accounts include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body of those that are informal gatherings of church members.

c) Incoming resources

Collections are recognised when received by or on behalf of the PCC

Planned giving receivable under gift aid is recognised only when received

Income tax recoverable on gift aid donations is recognised when the income is recognised

d) Fixed assets

Consecrated and beneficed property of any kind is excluded from the accounts by s.96(2) of the Charities Act 1993.

For other fixed assets acquired prior to 1st January 1990 there is insufficient cost information available and therefore such assets are not valued in the accounts.

Other fixed assets acquired after 1 January 1990 have been capitalised and depreciated in the accounts on a straight line basis over their currently anticipated economic life of between five and ten years.

Investments are carried at their market value at 31 December.
