#### Main Object

#### **Main Activities**

This is a small general grant making charitable trust. The Trustees have paid due regard to the guidance in Public Benefit, given by the Charity Commission. They have used their best endeavours to ensure that they have made grants for the public benefit.

#### **Investment Policy**

The Trustees are advised by investment managers who are instructed to maintain a fair balance between income and growth, avoiding high risk stocks and certain other stocks.

### **Reserves Policy**

The Trustees do not maintain reserves, except to the extent that at the end of the financial year they may anticipate a requirement for a particular grant early in the following year.

#### **Grants Policy**

The Trustees exercise a wide discretion. They normally make grants to registered charities only.

# Independent Examiner's Report to the Trustees
